10 Wine Liquor License for Little Vine, located at 1541 Grant Avenue; and,

11 WHEREAS, The Planning Department has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 20
18 Off-Sale Beer and Wine Liquor License, to Jay Esopenko for Little Vine, located at 1541
19 Grant Avenue, will serve the public convenience or necessity of the people of the City
20 and County of San Francisco.

21 Conditions: (1) Sales of alcoholic beverages shall be permitted only between the
22 hours of 9:00 a.m. to 9:00 p.m. daily. (2) No more than 5% of the square footage of the
23 premises will be used for the display of alcoholic beverages. (3) The monthly gross
24 sales of alcoholic beverages shall not exceed 25% of the total gross sales.
