

Academic and Teaching Experience Related to Humanities, Women Health, and Spirituality

Painting from the Heart Art classes using acrylic paint, shells, beads, glitter, dirt, and cloth that the students used on a canvas. I used guided meditation, music and a relaxing safe atmosphere to allow the students to get into there artwork. Each student as well as staff stated they enjoyed the class and will return for more classes. The students were of various ages 18-50 and diverse backgrounds. Catholic Charities, Treasure Island, CA. 2009.

Adjunct Faculty *Philosophy of Religion* one of the classes that I taught at Napa Valley College. In the Philosophy of Religion classes I included various philosophers from around the world, as well as various religions. These diverse philosophers include people of color, women, and diverse sexual orientations 2006-2007.

Adjunct Faculty *Comparative Religion* consists of various religions from around the world. In both classes students were given a test on their knowledge of various religions and then were assigned to do two projects. The first project consisted of the students

interviewing someone of a different philosophy and/or religion and comparing it to the readings of another philosophy and/or religion, presenting their results and turning in a three page paper. The second project was a group project, which consisted of the students creating a philosophy or religion that incorporated diversity, compassion, and empowerment. In both class I was amazed by the creativity the students showed during their presentations. Several students produced DVD's for their presentations, while others created collages. I started teaching at Napa Valley College in Spring 2006-fall 2007.

Adjunct Faculty *Women's Ethnic Heritage* consists of diverse women and their heritages. In my *Women's Ethnic Heritage* class women, as well as men were taught about various women from around the world. Each student is required to do a mother line, so that they can have a deeper and richer value and respect of the matrilineal side of their family. In addition, by doing this research it also helped the students to learn more about their ancestors. Moreover, in this class students learned to understand and honor other peoples' heritage. Lastly, the students' final is a group project, which consist of the students creating a women's organization, club, or business that incorporates empowerment, compassion, and diversity 2007.

Women and Health Seminar I taught a one hour seminar on women and health, focusing on women of color and the high risks diseases: heart disease, diabetes, and hypertension at Napa Valley College. In the class I had the students validate that women are powerful and very creative. I taught them how to prevent from acquiring the diseases. In addition, I had the women to do a brief meditation on their reproductive system, as well as saying hello to the rest of their body. Lastly, space was allowed for questions 2007.

Women's Workshop Instructor Women's Empowerment Workshops "Discovering the Goddess Within" were taught at my business, *Daughter of Isis*, Chico, CA and also at California State University Chico, through the Women's Student Union. These workshops consisted of the history and stories of various goddesses. It also consisted of a group of women participating in drawing of themselves, answering questions about themselves, and a short ritual at the end, 2000-2001.

Women and Poetry An *Art History* class student presentation on women poets from around the world. In this class I taught students about women poets both famous and unknown. I also had the students to create a poem and lastly read out loud a poem about women and their struggles. Each student stated that the stanza they read was significant to them. This class was taught through my business *Daughter of Isis* and at *California State University Chico*, 2000-2001.

Holistic Health Provider- Through my business, *Daughter of Isis* I performed hands on healing techniques on clients, as well as taught them how they could also heal them selves with this technique. I taught classes on tapping into your consciousness, unconsciousness and the awareness of the energy that surrounds everybody's physical body at *California State University Chico, Chico, CA*, at my business *Daughter of Isis, Chico, CA*, 2000-2001, and at *Napa Valley College* in my Humanities classes, 2006- present.

Registered Nurse I have been a registered nurse for over 21 years working as a staff nurse, as well as a team-leader, charge nurse, preceptor, nurse facilitator, and diabetic educator on Medical/Surgical, I.C.U., Burn, Psychiatric, Oncology, Spine, Plastics, Post-partum, and Gynecology. I have done patient care, I.V.'s to include chemotherapy, blood products, and T.P.N. , charting, blood draws, and transcribed doctors verbal orders. I have worked in places such as Stanford, Colusa, Alta Bates, Summit, Enloe, and I am currently working at California Pacific Medical Center.

Nursing Instructor. Women's History Month "Women's Health Day," STI reduction, stress reduction, heart disease, diabetes, and cancer prevention in African American women taught through the Black Student Union at Napa Valley College.

Diabetic Instructor: "The Risks of Diabetes," and "The Signs and Symptoms of Diabetes," taught to certified nurse assistants, licensed vocational nurses, and registered nurses in 2000-2001 at Colusa Hospital, Colusa, CA, and Stanford Hospital 1997- 2001. I have taught all of my diabetic patients the signs and symptoms of hyperglycemia, hypoglycemia, how to use their insulin, how to use their needles and glucometers since 1993.

Nursing Preceptor I have been a nursing preceptor for new graduates and nursing students at various hospitals on Medical Surgical and Psychiatric units. I taught, observed, and evaluated the new graduate nurses and nursing students' performance, skills, communication, and charting. Furthermore, I assisted nursing students with medication administration, patient care, interventions, patient education, signs and symptoms and complications of various diseases as well as infection, since 1994-2008 at various hospitals

throughout the Bay Area and Butte County.

Nursing Council Facilitator I was the nursing facilitator for one year at Stanford Hospital. I created with a team of nurses on a Medical Surgical unit, goals, innovative ways to increase moral and team-work, educational in-services, and brainstorming to address ways to problem-solve issues that may arise on the unit.

Academic Student Teaching and Presentations

Art Aesthetics I did my Aesthetics class focusing on Suzi Gablik's book *The Re-Enchantment of Art*. Gablik writes about how artists can once again become creative, open, embrace the feminine, and honor their art work. She also talks about connecting with the environment and using objects that compliment the environment instead destroying the environment. Taught in the fall 2006.

Surrealism Student Teaching The surrealism class consisted of the history, the war that many surrealist artists protested through their medium. In addition, in this class we explored the psychological connection each artist expressed through various mediums, which included the paintings, photography, poetry, and film. I also included Sigmund Freud's impact on surrealism. Lastly, we discussed who the women in surrealism and why so many were not included. My intention is to teach a 15 week college level surrealism class. Taught in the spring 2007.

Sacred Geometry Student Teaching Sacred Geometry is all around us. Sacred Geometry exists and thrives in our bodies, in the ocean, trees, flowers and plants, buildings, and in the galaxy. In the Sacred Geometry class I started with the history, followed by various pictures of plants, trees, parts of the human body, buildings, and the galaxy using power point. In the second half of the class I demonstrated to the class how to create the vesica piscis and then had them create the vesica piscis. After creating the vesica piscis, I had them use colored pencils to finish their creation. Moreover I had them finish their creation and do a brief meditation on where this symbol they created was located in their body. Furthermore, I had the class re-create the symbol they drew while they were meditating and to see, when was the first time they ever saw it. It was amazing how some people including men saw the birth canal. Lastly, I had them to allow that energy to go into that symbol and destroy it. I am interested in teaching a 15 week college level class through the arts and/or math to show how in sacred geometry math, science, and art all are connected.

I am a native San Franciscan and attorney who left private practice in 2004 to serve on active duty in the United States Marine Corps. Throughout my service in the Marine Corps, I spent a considerable amount of time advising individual service members on a wide variety of civil and criminal legal matters. After successfully completing Officer Candidates School ("OCS") and six months of infantry platoon commander's training at the Marine Corps Basic School, I was assigned to a litigation billet as a judge advocate in Twentynine Palms, California. Between 2005 and the spring of 2007, I handled a wide variety of criminal cases including narcotics (both use and distribution) and sexual misconduct offenses.

I also gained valuable experience working in non-traditional legal roles in the high-pressure and often ambiguous environment of combat operations. In 2007 I was assigned to an infantry battalion and deployed to Ramadi, Iraq. In Ramadi, the criminal courts had previously ground to a halt amid widespread lawlessness and violence against police officers and judges. In support of the battalion's counterinsurgency operations, I worked with Iraqi Police investigators and judges to build their cases and help reestablish a functioning criminal justice system in the city. At the same time, I prepared cases with our own intelligence assets for eventual prosecution at the Central Criminal Court of Iraq ("CCCI") in Baghdad. By the time our battalion returned home, the first criminal trials in Ramadi were just beginning again, and we left behind a strong reputation for successfully prosecuting members of Al Qaeda and related groups at CCCI. After returning from deployment, I was honorably discharged in February 2008 and returned to private practice with Cooley LLP in March 2008.

I believe this experience, combined with my professional background and long-standing ties to San Francisco, have provided me with the qualifications necessary to be of service to the Veterans' Affairs Commission.

The Veterans Affairs Commission consists of a total of seventeen (17) members, twelve (12) of whom are appointed by the Board of Supervisors and five (5) of whom are appointed by the Mayor as follows:

- At least three (3) must be women veterans (at least two (2) members shall be appointed by the Board);
- Two (2) members who served in the Armed Forces of the United States and who have a physical disability arising from that service (the Mayor and Board of Supervisors shall each appoint at least one (1) member), in accordance with the definitions applied in such cases by the Veterans' Administration; and
- All members shall reside in the City and County of San Francisco. The Board of Supervisors may only waive this requirement by Ordinance.

The term of each member of the Commission shall be four (4) years; provided, however, that the members first appointed shall, by lot, classify their terms so that three (3) members shall serve a one-year term, four (4) members shall serve a two-year term, four (4) members shall serve a three-year term and four (4) members shall serve a four-year term. On the expiration of these and all successive terms, their successors shall be appointed for a four-year term in a manner similar to that described for the initial members. In the event a vacancy occurs during the term of office of any member, a successor shall be appointed for the unexpired portion of the term of the office vacated in a manner similar to that described for the initial members.
