17 Station for the City and County of San Francisco before becoming the Medical Director for the  
18 City's third service Paramedic Division in 1994; and

19 WHEREAS, Dr. Marshal Isaacs also was named Emergency Medical Services Director  
20 for the San Francisco Fire Department in 1994 directing its Early Defibrillation and Basic  
21 EMT/First Responder programs; and

22 WHEREAS, Dr. Marshal Isaacs has made significant contributions to the San  
23 Francisco Fire Department and the City and County of San Francisco during his tenure as the  
24 EMS Medical Director the past 12 years; therefore be it
