

1 [Eureka Valley Recreation Center Funding]  
2 URGING GOVERNOR GRAY DAVIS TO ALLOCATE \$400,000 IN STATE FUNDING FOR  
3 MUCH NEEDED IMPROVEMENTS TO EUREKA VALLEY RECREATION CENTER IN SAN  
4 FRANCISCO.

5 WHEREAS, Eureka Valley Recreation Center in the heart of San Francisco's Castro  
6 neighborhood is one of the city's most beloved and well-utilized parks; and,

7 WHEREAS, EVRC's programs serve seniors, children, sports enthusiasts, and lesbian,  
8 gay, bisexual and transgender individuals, among other groups, with a wide array of  
9 recreational and social programs; and,

10 WHEREAS The facility's physical plant is in serious disrepair and in need of upgrades  
11 put off in less prosperous times; and,

12 WHEREAS, In recognizing and affirming these needs, the City of San Francisco is  
13 moving forward with a \$2.3 million renovation of EVRC from its Open Space Fund; and,

14 WHEREAS, Several important improvements will not be covered by this allocation and  
15 could be appropriately supplemented by state funds; and,

16 WHEREAS, One improvement is a new children's play area, which would make the  
17 facility more inviting and safe for children, costing \$340,000; and,

18 WHEREAS, Another improvement is decorative sound fencing so the EVRC plaza  
19 area could be closed off at night, discouraging individuals from loitering and creating  
20 disturbances in the neighborhood; costing \$60,000; and,

21 WHEREAS, For every dollar the City is requesting from the state, it would be putting  
22 forth \$6, which constitutes an excellent local match and demonstrates the City's commitment  
23 to the project; and,

24 WHEREAS, These much needed improvements will make the park a safer, more  
25 enjoyable space for residents and visitors alike; now, therefore be it,




