3 **Resolution repealing Resolution Nos. 89-71, 286-71, 359-71, 360-71, 608-71, 14-72, 578-**  
4 **72, 510-73, 934-74, 126-77, 26-78, 704-78, 412-82, 349-89, and 414-89 to dissolve the**  
5 **“Mayor's Criminal Justice Council.”**

7 WHEREAS, Resolution No. 89-71 created a "Mayor's Criminal Justice Council"; and  
8 Resolution Nos. 286-71, 359-71, 360-71, 608-71, 14-72, 578-72, 510-73, 934-74, 126-77, 26-  
9 78, 704-78, 412-82, 349-89, and 414-89, extended the term of the Council; and

10 WHEREAS, Rule 2.27 of the Board of Supervisors' Rules of Order requires the Clerk of  
11 the Board to determine and identify each year every subordinate body that has not met for at  
12 least four months and to request the City Attorney to prepare legislation repealing the  
13 resolution or ordinance that created the body; and,

14 WHEREAS, The Clerk of the Board polled this subordinate body and found that the  
15 Council has not met in more than four months; now, therefore, be it

16 RESOLVED, That Resolution Nos. 89-71, 286-71, 359-71, 360-71, 608-71, 14-72, 578-  
17 72, 510-73, 934-74, 126-77, 26-78, 704-78, 412-82, 349-89, and 414-89 are hereby repealed  
18 in their entirety and the Mayor's Criminal Justice Council is dissolved.
