

1 [Accept and Expend Grant - Retroactive - California Office of Emergency Services - Probation
2 Specialized Unit Program - \$300,000]

3 **Resolution retroactively authorizing the Department of Adult Probation to accept and**
4 **expend a grant in the amount of \$100,000 for the period of October 1, 2023, through**
5 **September 30, 2024; \$100,000 for the period of October 1, 2024, through September 30,**
6 **2025; \$100,000 for period of October 1, 2025, through September 30, 2026; for a total**
7 **not to exceed amount of \$300,000 from the California Office of Emergency Services for**
8 **Probation Specialized Units Program federally funded through the Violence Against**
9 **Women Act, for the total grant period of October 1, 2023, through September 30, 2026,**
10 **to continue the Probation Specialized Unit Program federally funded through the**
11 **Violence Against Women Act should the parties agree to an amendment as allowed**
12 **under the provisions of the grant agreement.**

14 WHEREAS, On October 3, 2023, the Board of Supervisors passed Resolution
15 No. 461-23 authorizing the Adult Probation Department to accept and expend a grant from
16 California Office of Emergency Services (Cal OES) in the amount of \$100,000 for a one year
17 grant period from October 1, 2023, through September 30, 2024; and

18 WHEREAS, The Cal OES notified the Adult Probation Department of required Resolution
19 edits; and

20 WHEREAS, The purpose of the Probation Specialized Unit Program (PSUP) is to
21 enhance or create specialized units within probation departments in California to intensively
22 supervise small caseloads of probationers of crimes involving domestic violence, sexual
23 assault, dating violence and stalking; and

24 WHEREAS, Cal OES grant funding for the PSUP would enhance the Adult Probation
25 Department's existing Domestic Violence (DV) Program in several ways; and

1 WHEREAS, The current DV Program protocols and supervision strategies will be
2 revised to increase field supervision and enhance the outreach services to DV victims; and

3 WHEREAS, The PSUP would reduce violence of DV probationers in that it will:
4 exercise principles of Evidence-Based Practices; apply the principles of effective reentry
5 practices; adopt a victim-centered approach; revise the certification process for the 52 weeks
6 Batterers Intervention Programs (BIP); and implement performance measures; and

7 WHEREAS, The grant does not require an amendment to the Annual Salary
8 Ordinance; and

9 WHEREAS, The Adult Probation Department will provide \$99,999, in matching funds to
10 meet the matching requirement; and

11 WHEREAS, The Adult Probation Department proposes to maximize use of available
12 grant funds on program expenditures by not including indirect costs in the grant budget; now,
13 therefore, be it

14 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
15 the grant budget; and, be it

16 FURTHER RESOLVED, The Board of Supervisors designates the Chief Adult
17 Probation Officer as the authorized signatory of Adult Probation to enter into Grant Subaward
18 Agreement for Cal OES Probation Specialized Units Program and extensions, this
19 authorization applies to all applicable Grant Subaward Amendments and extensions for the
20 Cal OES PU Probation Specialized Units Program.




