6 WHEREAS, The Director of Administrative Services has entered into an agreement
7 dated May 16, 1997 with Gensler/Michael Willis/Kwan Henmi Joint Venture for the design of
8 the new Moscone Center Expansion; and

9 WHEREAS, the Agreement is currently authorized by the Board of Supervisors to a
10 limit of \$14,026,326.68 on file with the Clerk of the Board of Supervisors in File No. 991712,
11 which is hereby declared to be a part of this resolution as if set forth fully herein; and,

12 WHEREAS, the Director intends to increase the scope of services under said
13 Agreement and to increase the sum under said agreement by ~~\$1,000,000.00~~ \$670,000.00;
14 and,

15 WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of
16 ten million dollars or amendments to said agreement in excess of \$500,000.00 be approved
17 by the Board of Supervisors; now, therefore, be it

18 RESOLVED, That the Director of Administrative Services is authorized to enter into
19 amendments to the May 16, 1997 agreement with Gensler/Michael Willis/Kwan Henmi Joint
20 Venture in an amount not to exceed ~~\$1,000,000.00~~ \$670,000.00; and, be it

21 FURTHER RESOLVED, That any monies for design of the Howard Street Hotel that
22 would be expended by the City be secured by an adequate instrument to insure that the City
23 is fully compensated for any such expenditures.




