3 **Ordinance authorizing settlement of the lawsuit filed by Jane Doe against the City and**  
4 **County of San Francisco for \$200,000; the lawsuit was filed on September 12, 2022, in**  
5 **United States District Court, Northern District of California, Case No. 22-cv-05179;**  
6 **entitled Jane Doe v. City and County of San Francisco, et al.; the lawsuit involves an**  
7 **alleged civil rights violation.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Jane Doe v. City and County of San  
12 Francisco, et al., United States District Court, Northern District of California, Case No. Case  
13 No. 22-cv-05179 by the payment of \$200,000. The lawsuit involves an alleged civil rights  
14 violation.

15 Section 2. The above-named action was filed in United States District Court Northern  
16 District of California on September 12, 2022, and the following parties were named in the  
17 lawsuit: plaintiff: Jane Doe; defendants: City and County of San Francisco, William Scott #26,  
18 Mark Powell, Kelley Fracchia, and Sylvia Lange.
