

1 [Motorcycle Sidewalk Parking Policy]

3 **Resolution urging the Department of Parking and Traffic to prioritize the**
4 **accommodation of scooters and motorcycles in the Department's planning and**
5 **enforcement polices, to devote its sidewalk enforcement resources consistently to the**
6 **task of keeping the sidewalks clear of vehicles that impede the right of way of**
7 **pedestrians or disabled persons, and to create adequate motorcycle parking.**

9 WHEREAS, Motorcyclists contribute to reducing traffic congestion and to reducing the
10 amount of space dedicated to storage of private vehicles; and

11 WHEREAS, The Board of Supervisors asked to Office of the Legislative Analyst to
12 conduct on assessment of motorcycle parking in San Francisco; and,

13 WHEREAS, The Office of the Legislative Analyst found that there were only 1696
14 designated motorcycle parking spaces for the 15,959 registered motorcycles in San
15 Francisco; and,

16 WHEREAS, The inadequate number of motorcycle parking spaces is exacerbated by
17 the location of these spaces; and,

18 WHEREAS, The Office of the Legislative Analyst found that motorcycles are
19 concentrated in Districts Two, Five, and Seven yet the parking spaces are concentrated in
20 Districts Three and Six; and,

21 WHEREAS, The increase in sidewalk parking fines to \$100 passed by the Board of
22 Supervisors was intended to address the serious problem of cars blocking the sidewalks; and

23 WHEREAS, Federal Law requires City Governments to keep sidewalks clear of
24 obstructions, including but not limited to parked vehicles, such that disabled persons are not
25 impeded by such obstructions; and,

WHEREAS, State law prohibits the parking of vehicles on any portion of the sidewalk;
and,

WHEREAS, A solution is needed to account for the lack of motorcycle parking; now,
therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco
urges the Department Parking and Traffic to prioritize the accommodation of scooter and
motorcycles in its parking planning policies; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges the Department of
Parking and Traffic to devote its sidewalk enforcement resources consistently to the task of
keeping the sidewalks clear of vehicles (a vehicle is a device by which any person or property
may be propelled, moved exclusively by human power or used exclusively upon stationary
rails or track) that impede the right-of-way of pedestrians or disabled persons; and, be it

FURTHER RESOLVED, That the Board of Supervisors urges the Department of
Parking and Traffic to make aggressive efforts to create adequate amounts of safe on-street
parking in residential and commercial districts proportionate to the distribution of motorcycles
and to report back to the Board regarding its plans in a timely manner.


