14 WHEREAS, At the City Operations and Neighborhood Services Committee
15 meeting of June 6, 2005, residents of the area testified against the transfer of a liquor
16 license at this location; and,

17 WHEREAS, The Police Department recommends that the liquor license
18 application be denied; now, therefore, be it

19 RESOLVED, That in accordance with Section 23958.4 of the California Business
20 and Professions Code, the Board of Supervisors of the City and County of San
21 Francisco hereby determines that the transfer of a Type 21 off-sale general alcoholic
22 beverage control license for Brotherhood Market & Deli at 301 Randolph Street from
23 308 Randolph Street requested by Jacqueline Badenhausen and Abdo Alkasmy be




