3 **Ordinance authorizing payment of reward to Jane Doe for supplying information**
4 **leading to the arrest and conviction of the perpetrator who murdered Shayne**
5 **Worcester on May 26, 1999.**

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. On June 1, 1999, Mayor Brown and the Mayor's Office of Criminal Justice
9 established the Shayne Worcester Reward Fund to be paid to any individual supplying
10 information that led to the arrest and conviction of the person or persons responsible for the
11 death of Shayne Worcester on May 26, 1999. The Reward Fund provided that moneys be
12 paid only if a suspect is convicted or pleads guilty. A Jane Doe came forward and supplied
13 information leading to the arrest and conviction of the persons responsible for the death of
14 Shayne Worcester. Three suspects have now been convicted or pled guilty.

15 Section 2. The Controller of the City and County of San Francisco is hereby authorized
16 to draft a warrant upon the Treasury of the City and County of San Francisco in the amount of
17 Twelve Thousand Five Hundred Dollars (\$12, 500) payable to Jane Doe for supplying
18 information leading to the arrest and conviction of the perpetrator who murdered Shayne
19 Worcester.






