

1 [Apply For-State/Regional Grant]

3 **Resolution authorizing the City Administrator to apply for a grant in the amount of**  
4 **\$864,000 from the Bay Area Air Quality Management District for the purpose of**  
5 **implementing programs to improve air quality.**

7 WHEREAS, Assembly Bill 434 created the Transportation Fund for Clean Air in the Bay  
8 Area and provided authority to the Bay Area Air Quality Management District (the District) to  
9 impose up to a \$4.00 surcharge on motor vehicle registration fees within its jurisdiction, to be  
10 used to implement specified transportation control measures included in the District's 1991  
11 Bay Area Clean Air Plan; and

12 WHEREAS, the District has approved a surcharge on motor vehicles and is seeking  
13 applications from Bay Area cities, counties, school districts and other agencies to cover the  
14 cost of transportation programs and projects that achieve emission reductions from motor  
15 vehicles; and

16 WHEREAS, the City and County of San Francisco supports the Bay Area Clean Air  
17 Plan; and

18 WHEREAS, the following city departments have developed programs and projects  
19 eligible for AB 434 program funding; the Department of the Environment in the amount of  
20 \$500,000 to subsidize the conversion of curbside refuse trucks engines from diesel to  
21 Liquefied Natural Gas, for Norcal Waste Systems, Inc. and the Department of Parking and  
22 Traffic in the amounts of \$99,000 to purchase and install bike racks at various locations  
23 throughout the City, \$175,000 to build bike lanes on Alemany Boulevard between San Jose  
24 Avenue and Lyell Street, \$15,000 to build bike lanes on Folsom Street between 11<sup>th</sup> and 14<sup>th</sup>  
25 Streets, and \$75,000 to build bike lanes on Illinois Street between 16<sup>th</sup> and Islais Creek; and

1           WHEREAS, the District requires all applications to be authorized by the applicant's  
2 governing board, or in this case, the Board of Supervisors; and

3           WHEREAS, an accept and expend resolution and any additional necessary  
4 documentation will be provided, as required, in the event any of these projects are designated  
5 for District funding awards; now, therefore, be it

6           RESOLVED, that the City Administrator, on behalf of the above named departments, is  
7 authorized to apply for funding from the Transportation Fund for Clean Air for the programs to  
8 reduce air pollution from motor vehicles.


