Mark Rennie on behalf of Sirhed Enterprises LLC has filed an application with the California Department of Alcoholic Beverage Control (ABC) seeking a Person to Person/Premises to Premises- Type 48 (On-Sale General for Public Premises)-bar license for 222 Powell Street (located on the east side of Powell St. between Geary St. and O'Farrell St.).

This location is currently licensed as a Type 21 (Off-Sale General) and a Type 42 (On-Sale Beer and Wine). The applicant has agreed to surrender the Type 21 and Type 42 upon issuance of the Type 48 license by the ABC.

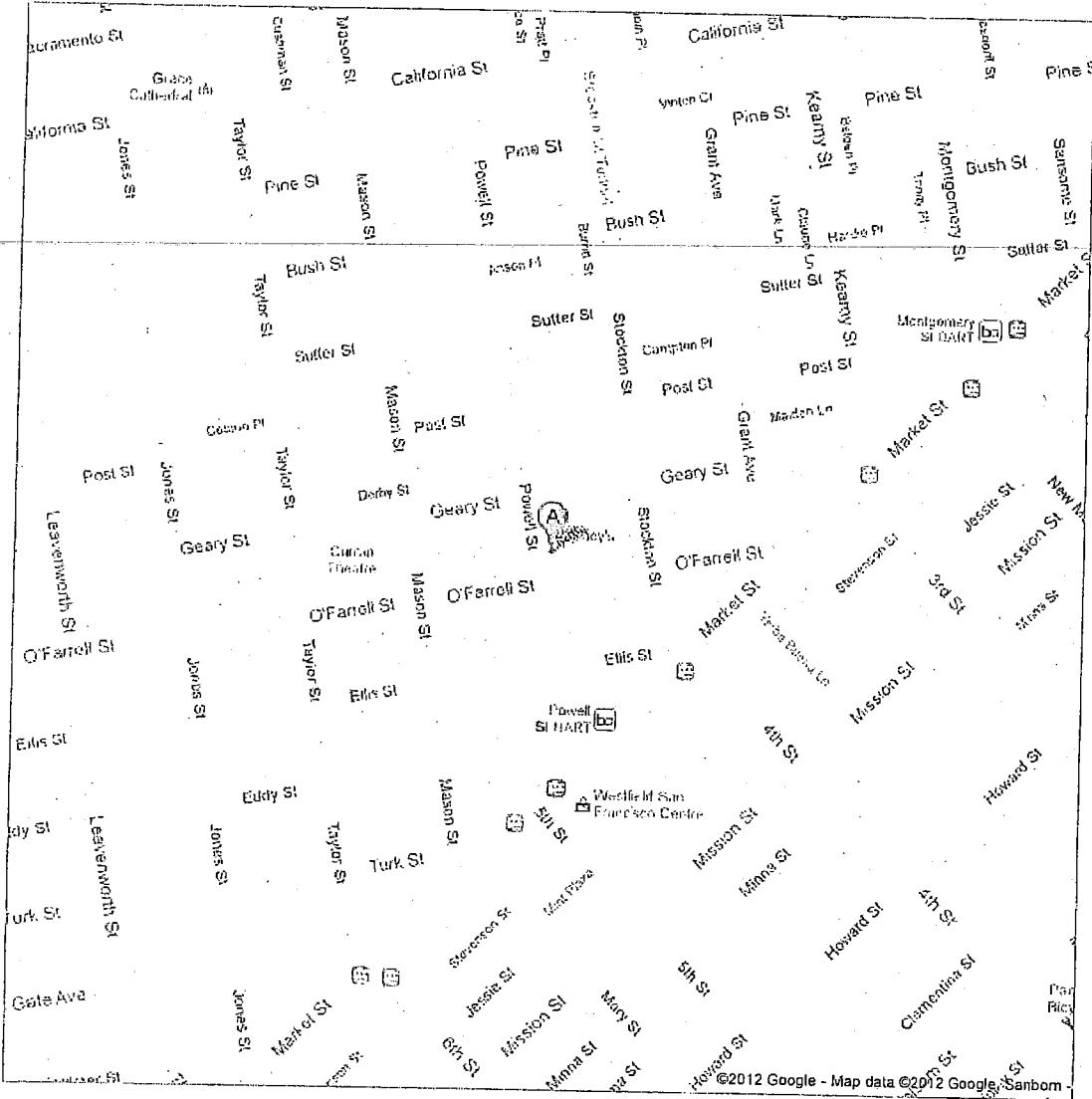

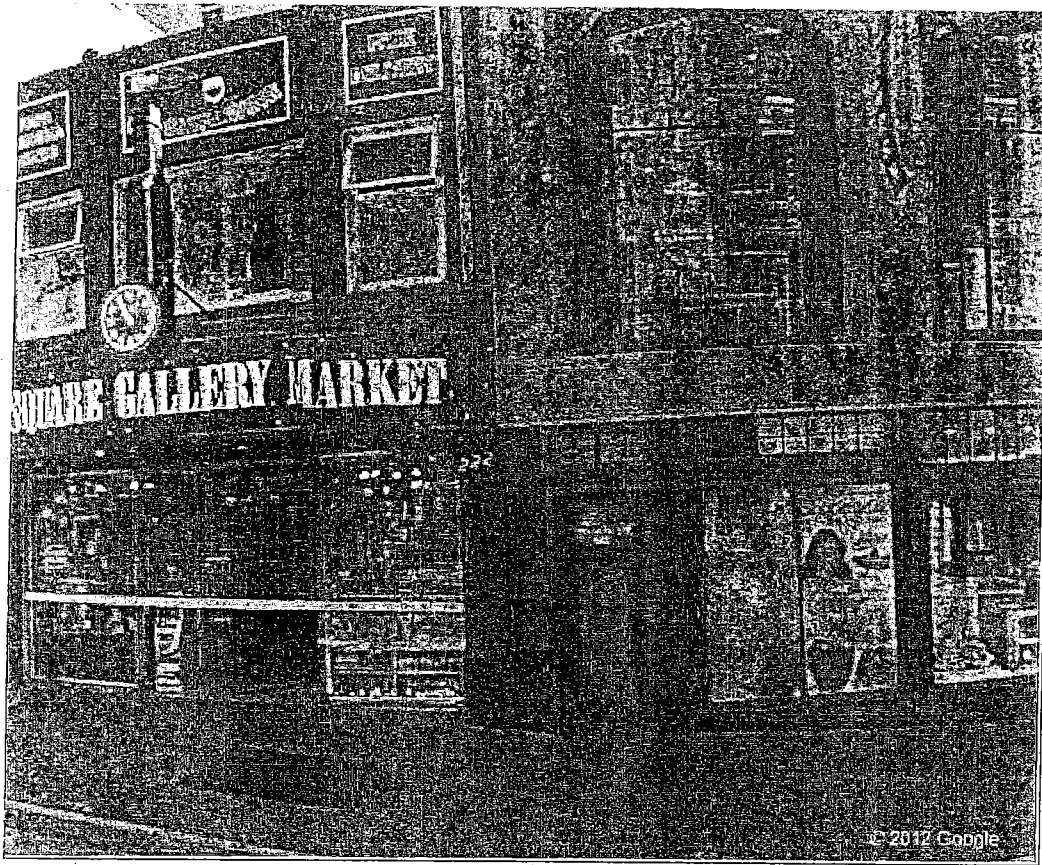

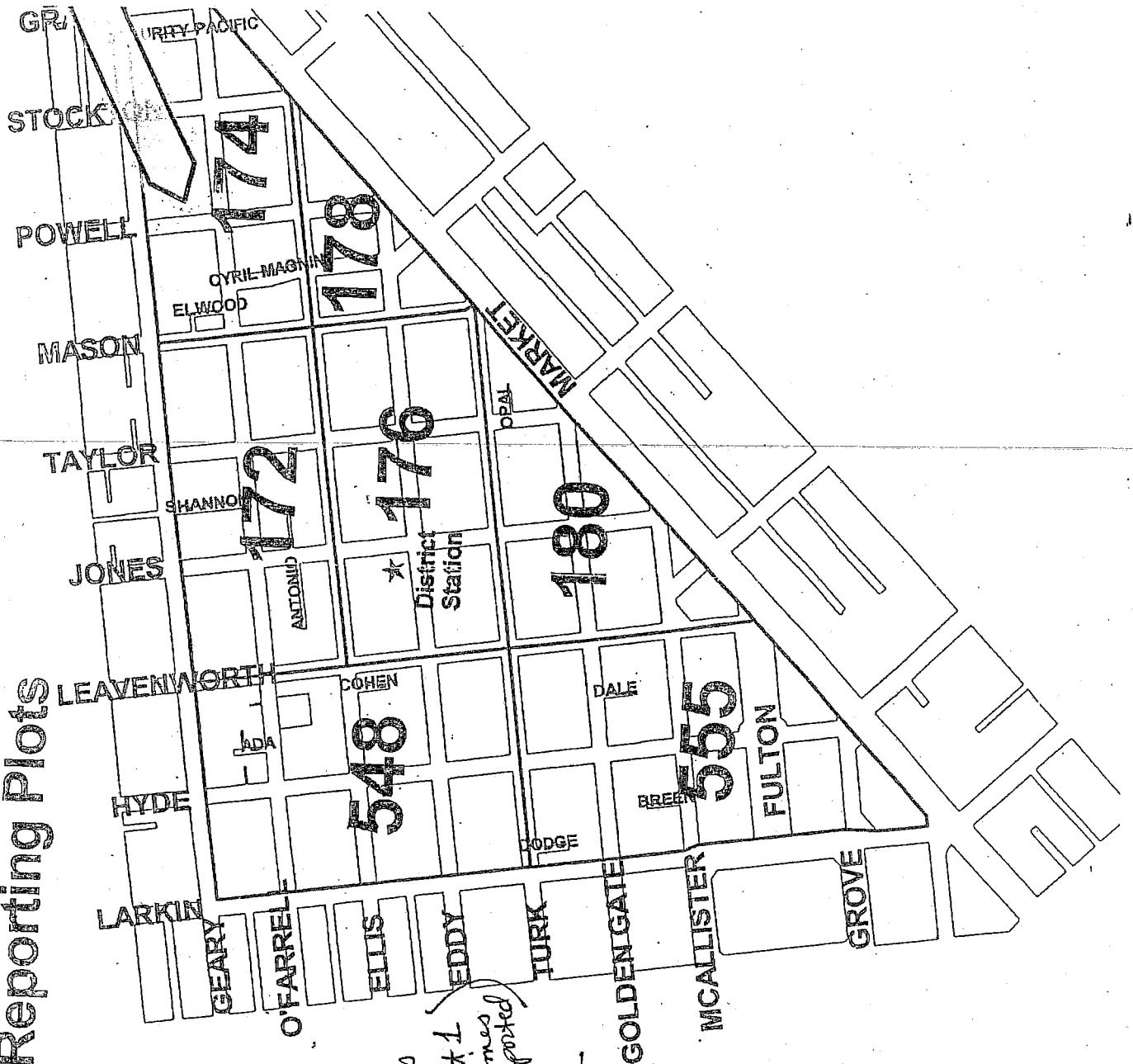

## Major Streets & Reporting Plots



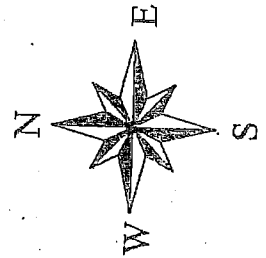

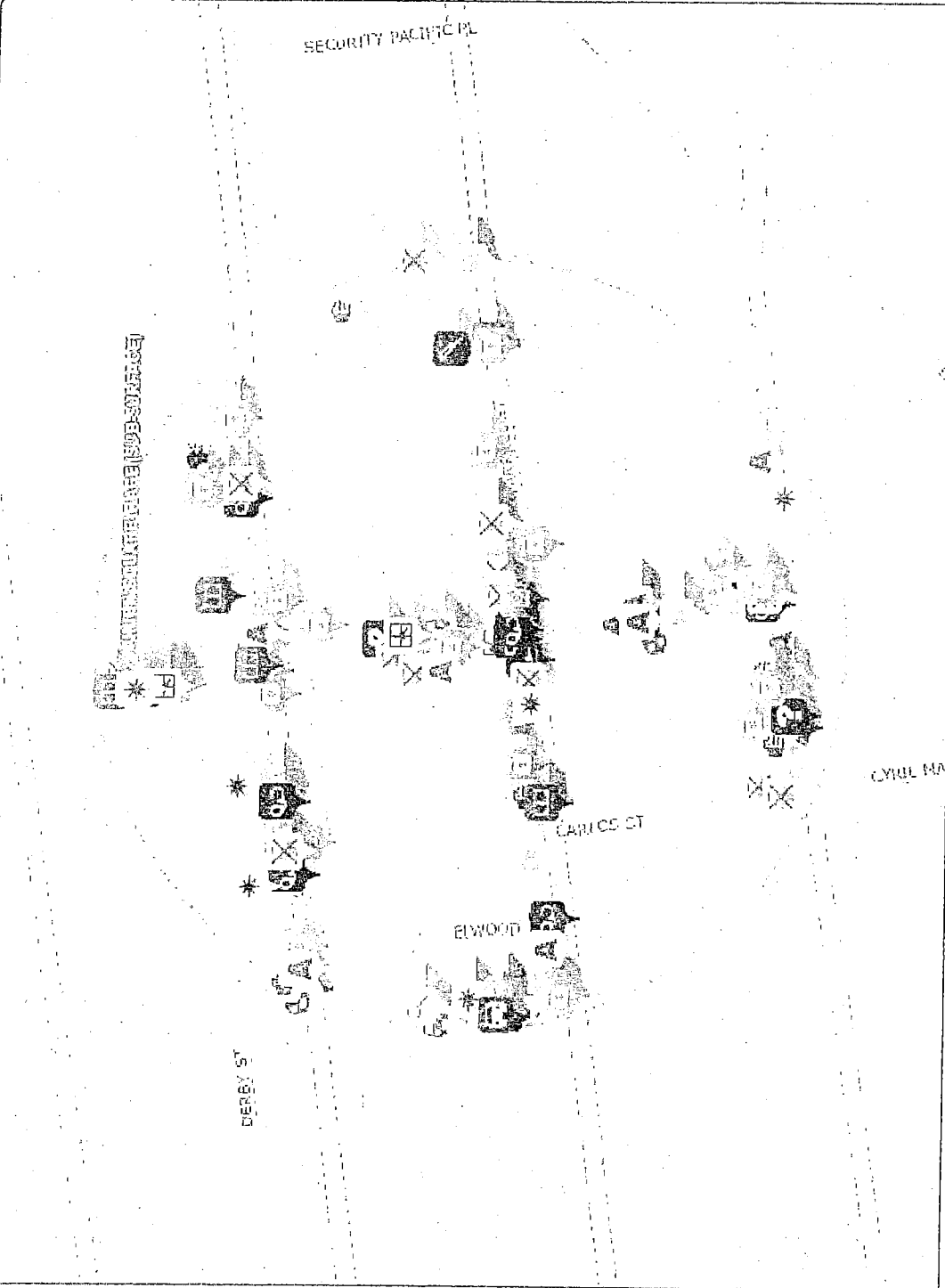

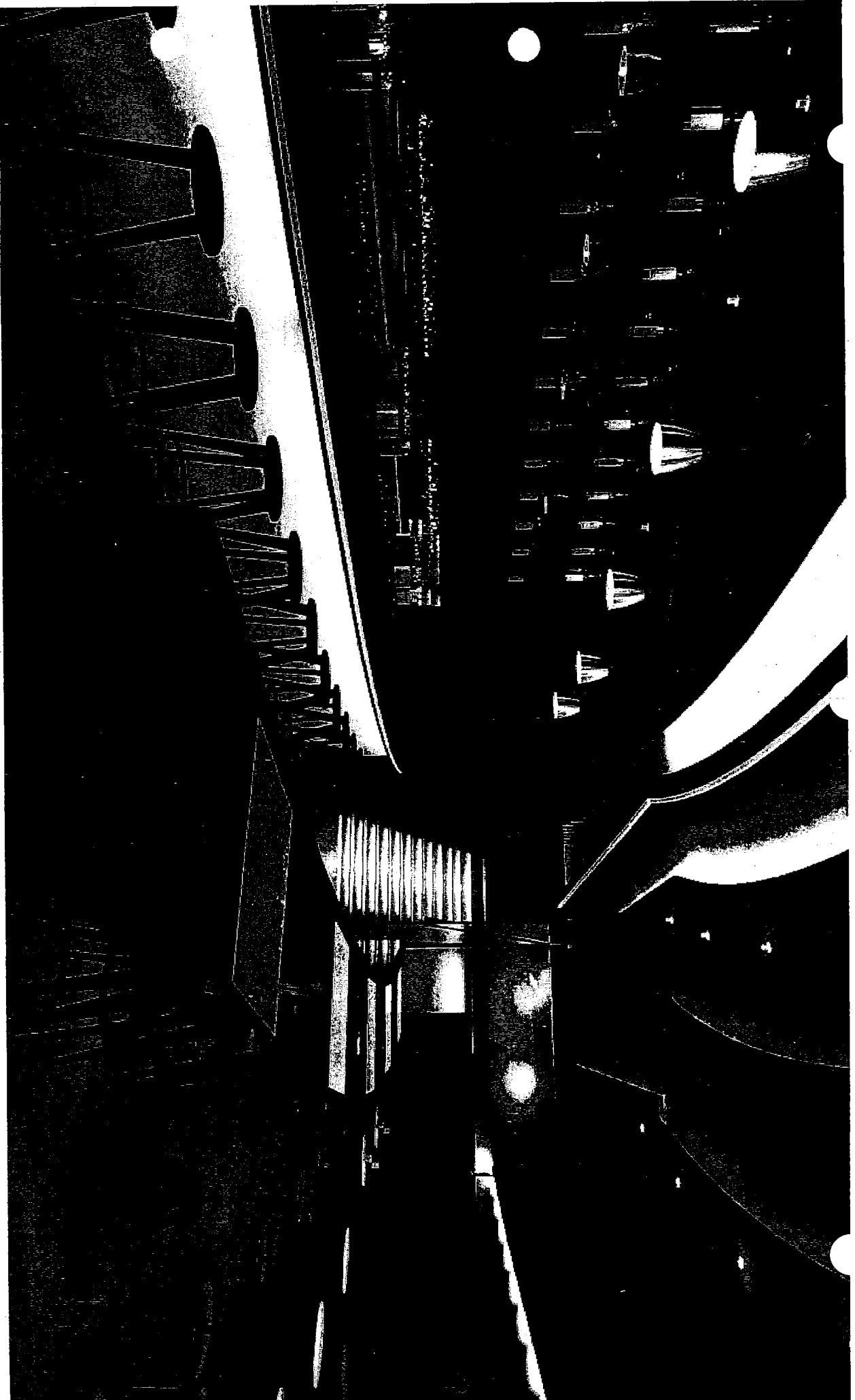

**FACT SHEET**  
**July 10, 2012**

**Background:**

Sam Sirhed is the owner of the business and also the property at 222 Powell Street. Since \_\_\_\_\_, Mr. Sirhed has operated the space first as an art gallery and, for the past few years, the space has operated as a souvenir shop and a wine tasting venue and has been called Gallery Market. Please note that this is a free standing building and there are no residences above.

**Plan:**

Mr. Sirhed's plan is to establish a cocktail lounge on the ground floor at 222 Powell. He hopes to fill the void created by the departure of the Gold Dust Lounge, which was located in the 300 block of Powell. Sam's Cable Car Lounge would provide locals and visitors alike a similar venue with similar price points and similar music. There will be a trio house band of acoustic instruments with very low-level amplification. T-shirts and souvenirs will be available for out of town visitors.
