

[Planning, Administrative, Building Codes - Inclusionary Housing Program Updates and Reductions; Development Impact Fee Reductions]

Ordinance amending the Planning Code to: 1) reduce Inclusionary Affordable Housing Program requirements for projects of 25 units or more; 2) delete Inclusionary Affordable Housing Program requirements for projects under 25 units; 3) allow all projects to dedicate land to the City as an alternative to payment of the Inclusionary Affordable Housing Program fee; 4) adopt a process for projects to request a modification to conditions of approval related to Inclusionary Affordable Housing Program requirements; 5) delete certain Article 4 affordable housing and development impact fees; and 6) adopt conforming amendments to various sections of the Planning Code; amending the Building Code to reduce Planning Code Article 4 development impact fees and allow deferral of payment of such fees; and amending the Administrative Code to adopt conforming amendments to the requirements of the Citywide Affordable Housing Fund; affirming the Planning Department's determination under the California Environmental Quality Act; making public necessity, convenience, and welfare findings under Planning Code, Section 302; and making findings of consistency with the General Plan, and the eight priority policies of Planning Code, Section 101.1.

Be it ordained by the People of the City and County of San Francisco:

1 Section 1. Land Use and Environmental Findings.

2 (a) The Planning Department has determined that the actions contemplated in this
3 ordinance comply with the California Environmental Quality Act (California Public Resources
4 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
5 Supervisors in File No. 260538 and is incorporated herein by reference. The Board affirms
6 this determination.

7 (b) On June 18, 2026, the Planning Commission, in Resolution No.21923, adopted
8 findings that the actions contemplated in this ordinance are consistent, on balance, with the
9 City's General Plan and eight priority policies of Planning Code Section 101.1. The Board
10 adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
11 Board of Supervisors in File No.260538, and is incorporated herein by reference.

12 (c) Pursuant to Planning Code Section 302, this Board finds that these Planning Code
13 amendments will serve the public necessity, convenience, and welfare for the reasons set
14 forth in Planning Commission Resolution No. 21923, and the Board adopts such reasons as
15 its own. A copy of said resolution is on file with the Clerk of the Board of Supervisors in File
16 No. 260538 and is incorporated herein by reference.

18 Section 2. Additional Findings.

19 (a) San Francisco's Inclusionary Affordable Housing Program is intended to help
20 address the demonstrated need for affordable housing in San Francisco. As rents and sales
21 prices for housing outpace what is affordable to the typical San Francisco family, the City
22 faces a continuing shortage of affordable housing for all but households with the highest
23 incomes. The California Association of Realtor's "California Housing Affordability Update," for
24 the fourth quarter of 2025, reported that the median home price in San Francisco was
25 \$1,800,000, requiring a minimum qualifying income of \$441,200 to purchase such a home.

1 San Francisco's median home prices are over twice the State of California's median of
2 \$650,000, and over four times the national median home price of \$414,900. The majority of
3 market-rate homes for sale in San Francisco are priced out of the reach of low- and moderate-
4 income households.

5 (b) San Francisco is facing a shortage of all types of housing. To meet San
6 Francisco's share of the regional need for housing between 2023-2031, the City must
7 accommodate over 82,000 units, including 46,598 units for extremely low-, very low-, low- and
8 moderate-income households. The Inclusionary Housing Program is an important part of the
9 City's overall strategy for providing affordable housing to very low-, low-, moderate-, and
10 middle-income households, and as of 2025, has created more than 3,600 units since its
11 inception. But the success of the Inclusionary Housing Program is contingent on the overall
12 feasibility of residential development. For that reason, Planning Code Section 415.10 requires
13 periodic review of the program's requirements.

14 (c) From December 2025 through April 2026, consistent with Planning Code Section
15 415.10, the Controller and the Affordable Housing Technical Advisory Committee (TAC) met
16 to conduct and review the feasibility of the City's inclusionary affordable housing obligations.
17 The Controller and the TAC studied five condominium prototypes and five rental apartment
18 prototypes, and considered key economic parameters, such as: interest rates, capitalization
19 rates, land prices, construction costs, use of the State Density Bonus law, rents, and sale
20 prices.

21 (d) The Controller and TAC found that none of the development prototypes studied
22 were financially feasible at the current inclusionary housing rates in the Planning Code. Most
23 prototypes studied had significant negative land value, indicating that the prototype would not
24 be financially feasible, even setting aside the cost of land. The prototypes, which were studied
25 because they represent the types of residential development that are common in San

1 Francisco, account for a majority of the housing production in San Francisco. The finding that
2 these 10 prototypes are not feasible suggests that residential development is, broadly
3 speaking, not financially feasible under current economic conditions at current inclusionary
4 housing rates.

5 (e) Economic conditions that render residential development infeasible threaten
6 several important policy priorities of the City, including the expansion of the City's housing
7 supply, the production of inclusionary affordable housing units, as well as the creation of jobs
8 and growth in tax revenue.

9 (f) On April 30, 2026 the Controller submitted a report to the Board of Supervisors that
10 summarizes the residential development feasibility analysis and the recommendations
11 developed by the Controller, with TAC agreement, between December 2025 and April 2026.
12 The report recommended that the City's inclusionary housing on-site rates be reduced from
13 the current interim rates of 12% - 15% to 5%, and for the fee and off-site rate be reduced from
14 the current interim rates of 20% - 20.5% to 10%, provided that the City concurrently
15 establishes a long-term source of stable funding for the production of affordable housing.

16 (g) The City's inclusionary housing requirements are an important policy lever, that, if
17 optimized, can facilitate robust and ongoing production of both market rate housing and
18 inclusionary housing. The Controller and the TAC found that the current interim citywide rates
19 directly contribute to the economic infeasibility of residential development. By reducing the
20 rates in line with the Controller and TAC's recommendation, the City will stimulate residential
21 development, increase production of inclusionary affordable housing, create jobs, and grow
22 tax revenue.

23 (h) By reducing the inclusionary housing obligation and development impact fee costs
24 of new projects, as well as projects with complete development applications, the City will
25 incentivize projects to advance into the construction phase, and swiftly provide much needed

1 market rate and below market rate housing.

2 (i) To further the financial feasibility of residential development, this ordinance deletes
3 certain Planning Code requirements for area-specific inclusionary housing fees: Market and
4 Octavia Area Plan and Upper Market Neighborhood Commercial District Affordable Housing
5 Fee (Planning Code Section 416 et seq.); Eastern Neighborhoods Area Plan Affordable
6 Housing Requirement (Section 417 et seq.); Housing Requirements for Residential
7 Development Projects in the UMU Zoning Districts of the Eastern Neighborhoods (Section
8 419 et seq.); Van Ness & Market Affordable Housing Fee (Section 424 et seq.); and
9 Divisadero Street NCT Affordable Housing Fee and Requirements (Section 428 et seq.), while
10 maintaining a higher inclusionary percentage in some locations. However, as the need for
11 affordable housing generated by new development is still unmet, the City finds there is a
12 continued need to expend area-specific inclusionary housing fees that the City previously
13 collected, as further described in the City's FY 2026-35 Capital Expenditure Plan, a copy of
14 which is on file with the Clerk of the Board of Supervisors in File No. 250233. Though the
15 Inclusionary Affordable Housing Program is not subject to the requirements of the Mitigation
16 Fee Act, California Government Code Sections 66000 et seq., nothing in this ordinance alters
17 the Board's previous findings regarding the purpose, need, and reasonable relationship
18 between the use of the fee and need for affordable housing, and the construction of new
19 market rate housing, including but not limited to the findings in Ordinance Nos. 76-16 (File No.
20 160255), 298-08 (File No. 081153); and 72-08 (File No. 071157). No funds were collected
21 under the Divisadero Street NCT Affordable Housing Fee and Requirements (Section 428 et
22 seq.).

23 (j) To further the financial feasibility of residential development, this ordinance also
24 deletes some area-specific fees for the provision of infrastructure and community facilities:
25 Van Ness & Market Neighborhood Infrastructure Fee (Section 424.5.) and the Van Ness &

1 Market Community Facilities Fee and Fund (Section 425 et seq.). However, the City finds that
2 the need for neighborhood infrastructure and community facilities generated by new
3 development in these areas is still unmet. Because the City has not collected sufficient funds
4 to develop these facilities and infrastructure, as further described in the City's FY 2026-35
5 Capital Expenditure Plan, a copy of which is on file with the Clerk of the Board of Supervisors
6 in File No. 250233, there is a continued need to expend funds previously collected for these
7 purposes. Nothing in this ordinance alters the Board's previous findings regarding the
8 purpose, need, and reasonable relationship between the use of these fees for infrastructure
9 and facilities and new development, including but not limited to the findings in Ordinance Nos.
10 50-15 (File No. 150149), and 193-23 (File No. 230764).

11 (k) This ordinance does not establish, increase, or impose a fee within the meaning on
12 Government Code Section 66001(a).

13 (l) On June 17, 2026, the Building Inspection Commission considered this ordinance at
14 a duly noticed public hearing pursuant to Charter Section 4.121 and Building Code Section
15 104A.2.11.2. A copy of a letter from the Secretary of the Building Inspection Commission
16 regarding the Commission's recommendation is on file with the Clerk of the Board of
17 Supervisors in File No. 260538.

18 (m) No local findings are required under California Health and Safety Code Section
19 17958.7 for the amendments to the Building Code found in Section 8 because those
20 amendments do not regulate materials or manner of construction or repair, and instead relate
21 in their entirety to administrative procedures for implementing the code, which are expressly
22 excluded from the definition of a "building standard" by California Health and Safety Code
23 Section 18909(c).

25 Section 3. Articles 1 and 4 of the Planning Code are hereby amended by revising

Sections 102 and 401 to read as follows:

SEC. 102. DEFINITIONS.

Development Application. Any application for a land use authorization or entitlement, *whether discretionary or ministerial*, including but not limited to a Project Authorization, Conditional Use, Variance, Large Project Authorization, HOME-SF Project Authorization, authorization pursuant to Article 3 of the Planning Code, or for any other authorization of a development project required to be approved by the Planning Department, Zoning Administrator, Historic Preservation Commission, or Planning Commission, that has been deemed complete by the Planning Department and includes any information necessary to conduct environmental review, determine Planning Code compliance, and conformity with the General Plan. Unless otherwise set forth in a valid development agreement, for projects approved pursuant to Administrative Code Chapter 56, Development Application shall mean an individual building's design review application, or if no design review application is required, then the first site or building permit application for an individual building.

Family. Family shall mean Household, as defined in this Section 102.

Final Approval. Final Approval or Finally Approved shall mean (1) approval by the Department's issuance of a Planning Approval Letter; (2) approval of a project's first Development Application by the Commission, unless such approval is appealed; (3) if a project only requires a

building permit, Planning approval of the first site or building permit, unless such permit is appealed; or (4) if the Commission approval or first site or building permit is appealed, then the final decision upholding the Development Application, or first site or building permit, on the appeal by the relevant City Board or Commission. For development projects with multiple buildings, including projects approved pursuant to Administrative Code Chapter 56, Final Approval shall mean the Department's approval of a first site or building permit application for each building. Final Approval, or Finally Approved, shall not include any modification of an approval pursuant to Section 415.10(e).

"First Certificate of Occupancy." Either a temporary Certificate of Occupancy or a Certificate of Final Completion and Occupancy under Building Code Section 109A, whichever is issued first.

Fleet Charging. Automotive Use, Non-Retail that provides electricity to electric motor vehicles through one or more Electric Vehicle Charging Stations that are dedicated or reserved for private parties pursuant to contract or other agreement and are not available to the general public. Fleet Charging is not allowed as an accessory use to any other principal use. Parcel Delivery Service activity, including unloading, sorting, and/or reloading merchandise for deliveries, is prohibited as part of a Fleet Charging use.

Plan Dimensions. The linear horizontal dimensions of a building or structure, at a given level, between the outside surfaces of its exterior walls. The "length" of a building or structure is the greatest plan dimension parallel to an exterior wall or walls and is equivalent to the horizontal dimension of the corresponding elevation of the building or structure at that level. The "diagonal dimension" of a building or structure is the plan dimension between the two most separated points on the exterior walls.

Planning Approval Letter. Written documentation from the Planning Department verifying the

Department's determination that a project with a complete Development Application may apply for a site or building permit.

Planning Commission (Commission). The San Francisco Planning Commission.

SEC. 401. DEFINITIONS.

In addition to the specific definitions set forth in Section 102 and elsewhere in this Article 4, the following definitions shall govern interpretation of this Article:

"Affordable to a household." ~~shall mean a~~ A purchase price that a household can afford to pay based on an annual payment for all housing costs, as defined in the Procedures Manual ~~in California Code of Regulations ("CCR") Title 25, Section 6920~~, as amended from time to time, of 33% percent of the combined household annual gross income, assuming a down payment recommended by ~~the Mayor's Office of Housing~~ MOHCD in the Procedures Manual, and available financing, or a rent that does not exceed 30% percent of a household's combined annual gross income. Where applicable, the purchase price or rent may be adjusted to reflect the absence or existence of a parking space(s), subject to the Department's policy on ~~unbundled~~ parking for affordable housing units as specified in the Procedures Manual and amended from time to time.

"Affordable to Qualifying Households."

(A) With respect to Owned Units, the ~~average~~ purchase price on the initial sale of all Owned Units in a housing project shall not exceed the allowable ~~average~~ purchase price. Each unit shall be sold:

(i) Only to first-time homebuyer households, as defined in this Section;

(ii) Only to households with an annual gross income equal to or less than the qualifying income limits ~~for a household of moderate income~~, adjusted for household size, except for the exceptions set forth in Section 415.8(a)(4)(C), (D), and (E);

(iii) Only to households that meet the household size requirements, as defined in the Procedures Manual;

(iv) On the initial sale, at or below the maximum purchase price, as defined in this Section;

(v) On subsequent sales at or below the prices to be determined according to the formula specified in the Procedures Manual in place at the time of the purchase of the Owned Unit, as amended from time to time, such that the units remain affordable for the life of the project. The formula in the Procedures Manual shall permit the seller to include certain allowable capital improvements in the new maximum purchase price. ~~The formula shall include a per unit cap on capital improvements of 10% of the resale price in order to maintain affordability. Special Assessments shall be added to the resale price at an uncapped rate.~~ Capital improvement requests shall be evaluated by ~~the Mayor's Office of Housing~~ MOHCD according to the ~~formula~~ policies specified in the Procedures Manual.

(B) With respect to Rental Units, the ~~average~~ annual rent shall not exceed the allowable ~~average~~ annual rent. Each unit shall be rented:

(i) Only to households with an annual gross income equal to or less than qualifying limits ~~for a household of lower income~~ adjusted for household size, as defined in this Section, except for the exceptions set forth in Section 415.8(a)(4)(A) and (B);

(ii) Only to households that meet the household size requirements, as defined in the Procedures Manual;

(iii) At or less than the maximum annual rent according to policies specified in the Procedures Manual.

“Allowable ~~average~~ purchase price.” A price for all Owned Units ~~of the size indicated below~~ that ~~are~~ is affordable to a household of median income as defined in this Section, adjusted for the household size indicated below as of the date of the close of escrow, except for Single Room Occupancy units and Group Housing units that are less than 350 square feet (both as defined in Section 102), which shall be 75% of the maximum purchase price level for studio units, and, where applicable, adjusted to reflect the Department’s policy on ~~unbundled~~ parking for affordable housing units as specified in the Procedures Manual and amended from time to time.;

9 the percentage change in Maximum Monthly Rent levels as published by MOHCD from the
10 previous calendar year to the current calendar year.

11 “Alternative.” A method of compliance with Section 415.1 et seq., which shall include payment
12 of the Affordable Housing fee, the provision of Affordable Units On-site, the dedication of land to the
13 City, or the provision of Affordable Units Off-site.

14 “Area Median Income” or “AMI.” The unadjusted median income levels published by
15 MOHCD derived in part from the Department of Housing and Urban Development (“HUD”) on
16 an annual basis for the San Francisco area, adjusted solely for household size, but not high
17 housing cost area.

18 “Annual gross income.” Gross income as defined in ~~CCR~~ Title 25 of the California Code
19 of Regulations, Section 6914, as amended from time to time; provided however that MOHCD may
20 develop and apply a different definition to promote consistency with other regulatory requirements ,
21 ~~except that MOHCD may, in order to promote consistency with the procedures of the San Francisco~~
22 ~~Redevelopment Agency, develop an asset test that differs from the State definition~~ if it publishes that
23 test in the Procedures Manual.

24 “Annual net income.” Net income as defined in Title 25 of the California Code of
25 Regulations, Section 6916.

1 “Area Plan Impact Fee.” ~~shall mean a~~ A development impact fee collected by the City to
2 mitigate impacts of new development in the Area Plans of the San Francisco General Plan,
3 under Article 4 of the Planning Code.

4 ~~“Average annual rent.” The total annual rent for the calendar year charged by a housing~~
5 ~~project for all Rental Units in the project of an equal number of bedrooms divided by the total number~~

13 ~~percent~~ 65% of AMI for a Rental Unit and 100% of AMI for an Owned Unit.

14 ~~"Household of median income." For purposes of Section 415 et seq., a household whose~~
15 ~~combined annual gross income for all members does not exceed 90 percent of AMI.~~

16 "Household of moderate income:" or "moderate-income household." For purposes of
17 Section 415 et seq., a household whose combined annual gross income for all members does
18 not exceed ~~110 percent~~ 90% of AMI for a Rental Unit and 120% of AMI for an Owned Unit.

19 "Housing developer." Any business entity building housing units which receives a
20 payment from a sponsor for use in the construction of the housing units. A housing developer
21 may be

- 22 (a) the same business entity as the sponsor,
23 (b) an entity in which the sponsor is a partner, joint ~~venturer~~ venture, or
24 stockholder, or
25 (c) an entity in which the sponsor has no control or ownership.

1 “Housing ~~Project~~project.” Any development which includes a Residential Use as defined
2 in Section 102 of this Code, including but not limited to Dwellings, Group Housing, Single
3 Room Occupancy Units, independent living units, and other forms of development which are
4 intended to provide long-term housing to individuals and households. “Housing ~~P~~project” shall
5 not include that portion of a development that qualifies as an Institutional Use under the
6 Planning Code. “Housing ~~P~~project” for purposes of the Inclusionary Housing Program shall
7 also include the development of Live/Work ~~u~~Units as defined by Section 102. “Housing
8 ~~P~~project” for purposes of the Inclusionary Housing Program shall mean all phases or
9 elements of a multi-phase or multiple lot residential development.

10 “Housing unit” or “unit.” A residential use in a Housing project. For the purposes of the
11 Inclusionary Affordable Housing Program, Planning Code Section 415 et seq., and
12 corresponding definitions in this Section 401, the use of the word “unit” will also mean

6 the Procedures Manual in effect at the time of initial purchase or initial rental and some in
7 effect in the then-current Procedures Manual. If the owner or tenant chooses to be governed
8 by the then-current Procedures Manual, the owner or tenant ~~he or she~~ shall sign an agreement
9 with the City to that effect, and the Department and MOHCD shall apply all of the rules and

13 **Affordable Housing.** The findings in former Planning Code Section 315.2 of the

15 (a) Affordable housing is a paramount statewide concern. ~~In 1980, t~~The California
16 Legislature declared in Government Code Section 65580:

17 (1) The availability of housing is of vital statewide importance, and the early
18 attainment of decent housing and a suitable living environment for every California family is a
19 priority of the highest order.

20 (2) The early attainment of this goal requires the cooperative participation of
21 government and the private sector in an effort to expand housing opportunities and
22 accommodate the housing needs of Californians of all economic levels.

23 (3) The provision of housing affordable to low-and moderate-income
24 households requires the cooperation of all levels of government.

25 (4) Local and state governments have a responsibility to use the powers vested

1 in them to facilitate the improvement and development of housing to make adequate provision
2 for the housing needs of all economic segments of the community.

3 (b) The Legislature further stated in Government Code Section 65581 that:

4 It is the intent of the Legislature in enacting this article:

5 (1) To assure that counties and cities recognize their responsibilities in
6 contributing to the attainment of the state housing goal.

7 (2) To assure that counties and cities will prepare and implement housing
8 elements which will move toward attainment of the state housing goal.

9 (3) To recognize that each locality is best capable of determining what efforts
10 are required to contribute to the attainment of the state housing goal.

11 (c) The California Legislature requires each local government agency to develop a
12 comprehensive long-term general plan establishing policies for future development. As
13 specified in the Government Code (at Sections 65300, 65302(c), and 65583(c)), the plan must
14 (1) “encourage the development of a variety of types of housing for all income levels, including
15 multifamily rental housing”; (2) “[a]ssist in the development of adequate housing to meet the
16 needs of low- and moderate-income households”; and (3) “conserve and improve the
17 condition of the existing affordable housing stock, which may include addressing ways to
18 mitigate the loss of dwelling units demolished by public or private action.”

19 (d) The Board of Supervisors adopted San Francisco’s General Plan 2022 Housing
20 Element Update in January 2023~~March 2015~~, and the California Housing and Community
21 Development Department certified it on February 1, 2023~~May 29, 2015~~. The Housing Element
22 states that San Francisco’s share of the regional housing need for years ~~2015~~ 2023 through
23 2030 ~~2022~~ includes ~~10,873~~ 32,881 housing units for extremely low, very-low and low-income
24 households and ~~5,460~~ 49,188 units for moderate and above-moderate ~~middle~~-income
25 households, and a total production of ~~28,870~~ 82,069 net new units, with almost 60% to be

2 *A project sponsor may elect to satisfy the requirements of Section 415.1 et seq. by dedicating*
3 *land for affordable housing to the City, or by providing Affordable Off-site Units as set forth below.*

4 **(a) Land Dedication Alternative.** *A project sponsor may dedicate a parcel of land to the City*
5 *and County of San Francisco for the purpose of constructing units Affordable to Qualifying*
6 *Households. To meet the requirements of this Alternative, the developer must convey title to land in fee*
7 *simple absolute to the City according to the Procedures Manual, provided the dedicated site is deemed*
8 *of equivalent or greater value to the Principal Site per those procedures, and is in line with the*
9 *following requirements:*

10 *(1) The dedicated site will result in a total amount of Affordable Units of not less than*
11 *70 units, as determined by MOHCD. MOHCD may approve and accept dedicated sites which result in*
12 *fewer units, but no less than the number of units set forth in subsection (a)(3), at its sole discretion.*

13 *(2) The dedicated site is located within one mile of the Principal Project, except that for*
14 *Principal Projects located in one of the areas listed in Section 415.7(a)(3), or in a Well-Resourced*
15 *Neighborhood as defined in Section 436, the dedicated site may be located within one mile of the*
16 *Principal Project or anywhere within that area.*

17 *(3) The dedicated site will result in a total number of Affordable Units as follows:*

18 *(A) Except as otherwise specified in subsection (a)(3)(B), equivalent to or*
19 *greater than 10% of the units that will be provided on the Principal Site;*

20 *(B) Equivalent to or greater than 15% of the units that will be provided on the*
21 *Principal Site if the Principal Site is in the following areas or districts:*

22 *(i) Mission Area Plan (See San Francisco General Plan, Eastern*
23 *Neighborhoods Area Plan, Map 1);*

24 *(ii) SoMa Neighborhood Commercial Transit District (Section 753);*

25 *(iii) North of Market Residential Special Use District (Section 249.5);*

1 (iv) South of Market Youth and Family Special Use District (Section
2 249.38);

3 (v) Urban Mixed Use (UMU) District (See Section 838);

4 (vi) Western SoMa Special Use District (Section 249.39) and

5 (vii) Central South of Market (Central SOMA) Special Use District
6 (Section 249.78).

7 (4) The dedicated site is deemed suitable by MOHCD based on size, configuration,
8 physical characteristics, physical and environmental constraints, access, location, adjacent use, and
9 other relevant planning criteria.

10 (5) The dedicated site includes infrastructure necessary to serve the Affordable Units,
11 including sewer, utilities, water, light, street access, and sidewalks.

12 (6) The developer must submit full environmental clearance, including any required
13 remediation, for the dedicated site before the land can be considered for conveyance, and before a first
14 site or building permit may be conferred upon the Principal Project.

15 (7) The City may accept dedicated sites that vary from the minimum threshold, provided
16 such a dedication is deemed generally equivalent to the original requirement by MOHCD.

17 (8) The City may accept dedicated sites that meet the above requirements in accordance
18 with the Procedures Manual, in combination with fees or On-site Units, provided such a combination is
19 deemed generally equivalent by MOHCD to the original requirement.

20 (9) The project applicant has a letter from MOHCD verifying acceptance of the

(e) **Marketing the Units.** The Project Sponsor shall submit a proposed marketing plan to MOHCD to begin marketing the Affordable Units at least six months prior to the beginning of marketing for any unit in the Principal Project. MOHCD shall approve the marketing plan for the Affordable Units prior to the Project Sponsor marketing any unit in the

Principal Project. Failure to comply shall be deemed a violation of the Planning Code subject to enforcement and penalties as set forth in Section 415.9. MOHCD shall be responsible for overseeing and monitoring the marketing of Affordable Units under this Section 415.7. In general, the marketing requirements and procedures shall be contained in the Procedures Manual as amended from time to time and shall apply to the Affordable Units in the project. SEC. 415.8. DURATION AND MONITORING OF AFFORDABILITY.

(a) For any units permitted under the Program:

(1) All units constructed pursuant to Sections 415.6 (On-site Affordable Housing Alternative) and 415.7 (Off-site Affordable Housing Alternative) must be owner-occupied, as defined in the Procedures Manual, in the case of Owned Units, or occupied by qualified households in the case of Rental Units.

(2) Units shall not remain vacant for a period exceeding 60 days without the written consent of MOHCD in accordance with the Procedures Manual.

(3) All units constructed pursuant to Sections 415.6 and 415.7 must remain Affordable to Qualifying Households for the life of the project.

(4) The income levels specified in the Notice of Special Restrictions and/or conditions of approval for the project shall be the required income percentages for the life of the project. Notwithstanding the foregoing sentence, if approved by MOHCD and as provided in the Procedures Manual, an exception to the required income percentage may be made in the following cases:

(A) a rental unit that converts to an Owned Unit with Qualifying Income up to a maximum of 150% of AMI and a sales price established pursuant to Section

1 415.8(b)(5);

2 (B) where there is an existing tenant who has undergone re-certification
3 as defined in the Procedures Manual, the existing tenant's household income may increase
4 up to a maximum of 200% of AMI;

5 (C) new Owned Units where the project sponsor has used good faith
6 efforts to secure a contract with a qualified buyer but is unable to secure such a contract in a
7 timely manner from the initiation of marketing;

8 (D) resale Owned Units where the owner has used good faith efforts to
9 secure a contract with a qualified buyer but is unable to secure a buyer contract at a
10 maximum resale price specified by MOHCD in a timely manner;

11 (E) the Qualifying Income level for new or resale Owned Units may be
12 set at 20% above the income level stated in the Notice of Special Restrictions or conditions of

14 (F) resale Owned Units where the owner has requested an adjustment to
15 the maximum income limit stated in the existing Notice of Special Restrictions or other
16 document establishing affordability requirements for the unit and/or has requested an increase

18 (5) The Commission or the Department shall require all housing projects subject
19 to Section 415.1 et seq. to record a Notice of Special Restrictions in the official records of the
20 City and County of San Francisco. The Notice of Special Restrictions must incorporate the
21 affordability restrictions, including the requirements of Section 415.8. All projects described in
22 ~~Section 415.3(a) must incorporate all of the requirements of this Section 415.8 into the Notice for~~
23 ~~Special Restrictions, including any provisions required to be in the conditions of approval for housing~~
24 ~~projects described in Section 415.3(a). These Section 415.3(a) projects which are housing projects that~~
25 ~~go through the conditional use or planned unit development process shall have conditions of approval.~~

1 The conditions of approval shall specify that project applicants shall adhere to the marketing,
2 monitoring, and enforcement procedures outlined in the Procedures Manual, as amended
3 from time to time, in effect at the time of project approval. ~~The Commission shall file the~~
4 ~~Procedures Manual in the case file for each project requiring inclusionary housing pursuant to this~~
5 ~~Program.~~ The Procedures Manual will be referenced in the Notice of Special Restrictions for
6 each project.

7 (b) For any units permitted to be Owned Units under the Program, ~~the~~ MOHCD shall:

8 (1) Establish and implement a process for reselling an affordable unit in the
9 Procedures Manual.

10 (2) Provide that owners may not change title on the unit without review and
11 approval by MOHCD and according to guidelines published in the Procedures Manual, as
12 amended from time to time.

13 (3) Provide that owners must comply with refinancing procedures and
14 limitations as published in the Procedures Manual, as amended from time to time.

15 (4) Provide that, in order to retain all units restricted as affordable under this
16 Program within the City's affordable housing stock, the specific procedures for passing an
17 affordable unit through inheritance are contained in the Procedures Manual. All transfers
18 through inheritance must be reviewed and approved by MOHCD and, in all cases, the heir
19 must acknowledge and agree to the provisions of the Program. The following households may
20 inherit the ability to occupy a unit restricted under this Program: (i) a spouse or registered
21 domestic partner, regardless of income; or (ii) a child of the owner if the child is a qualifying
22 household for the unit. If the heir qualifies under one of these categories, the heir must occupy
23 the unit or the heir must market and sell the unit at the restricted price through a public lottery
24 process and retain the proceeds from the sale. If the heir does not qualify to occupy the unit,

1 public lottery process. The heir would retain the proceeds of such sale.

2 (5) Require that affordable Rental Units permitted by the Commission to be
3 converted to Owned Units satisfy the requirements of the Procedures Manual, as amended
4 from time to time, including that the units shall be sold at restricted sales prices to households
5 meeting the income qualifications specified in the Notice of Special Restrictions or conditions
6 of approval, with a right of first refusal for the occupant(s) of such units at the time of
7 conversion. If the current tenant qualifies for and purchases the unit, the unit shall be sold at a
8 sales price corresponding to the affordability level required for the unit as a Rental Unit as
9 specified in the Notice of Special Restrictions or conditions of approval, with a maximum
10 allowable Qualifying Income level up to 150% of AMI. If the unit is sold to a buyer who is not a
11 current tenant, the sales price shall correspond to the affordability level required for the unit as
12 an Owned Unit as specified in the Notice of Special Restrictions or conditions of approval.
13 Upon conversion to ownership, the units are subject to the resale and other restrictions of this
14 Program for the life of the project, as defined in the Notice of Special Restrictions or
15 conditions of approval for the Project.

16 (6) For Owned Units approved pursuant to Sections 415.6 ~~or 415.7~~, the Notice of
17 Special Restrictions or conditions of approval will include provisions restricting resale prices
18 and purchaser income levels according to the formula specified in the Procedures Manual, as
19 amended from time to time. All amenities and parking spaces that were purchased with the
20 initial sale of the Owned Unit must be sold with the Owned Unit upon resale and shall be
21 included in the resale price. In the event subordination of the Affordability Conditions
22 contained in a recorded Notice of Special Restrictions may be necessary to ensure the project
23 applicant's receipt of adequate construction and/or permanent financing for the project, or to
24 enable first-time home buyers to qualify for mortgages, the project applicant may follow the
25 procedures for subordination of affordability restrictions as described in the Principal Project's

1 conditions of approval or in the Procedures Manual. A release following foreclosure or other
2 transfer in lieu of foreclosure may be authorized if required as a condition to financing
3 pursuant to the procedures set forth in the Procedures Manual.

4 (7) Purchasers of Affordable Units shall secure the obligations contained in the
5 Notice of Special Restrictions or conditions of approval by executing and delivering to the City
6 a promissory note secured by a deed of trust encumbering the applicable affordable unit as
7 described in the Procedures Manual or by an alternative means if so provided for in the
8 Procedures Manual, as amended from time to time.

9 (8) **Procedures for Units Unable to Resell.** The Board of Supervisors finds
10 that certain requirements of this Program and the Procedures Manual may create hardship for
11 owners of Affordable Units restricted under this Program. However, the Board also recognizes
12 that the requirements of this Program are important to preserve the long-term affordability of
13 units restricted under the Program. In order to allow some relief for owners of Affordable Units
14 during a time of economic downturn, but to provide the maximum protection for the long-term
15 affordability of the units, the Board directs MOHCD to analyze the following issues and, if it
16 deems appropriate, to propose amendments to the Procedures Manual to address the issues:

17 (A) **Waiver of Resale Requirements and Maximum Qualifying**
18 **Income Level for New Buyers of Resale BMR Units.** The Board recognizes that the risk to
19 low- and moderate-income homeowners during times of economic downturn can increase the
20 risk of default and foreclosure of units restricted under this Program. The Board directs
21 MOHCD to study ways to reduce such risks in the below market rate unit context and, if it
22 deems appropriate, to make recommendations to the *Planning* Commission to amend the
23 Procedures Manual to allow MOHCD discretion, in certain limited circumstances, to waive
24 requirements for owners of Affordable Units who have used good faith efforts to secure a
25 contract with a qualified buyer but are unable to resell their unit in a timely manner. Such

1 amendments to the Procedures Manual may include, but are not limited to, authorizing
2 MOHCD to make one or more allowances for owners of Affordable Units unable to resell,
3 such as: (i) a one-time waiver of the first-time homebuyer rule for the purchasing household;
4 (ii) a one-time waiver of qualifying household size requirements for the purchasing household;
5 (iii) a one-time waiver of owner occupancy rules to allow a temporary rental; (iv) a one-time
6 modification of the asset test for the new buyer household; and (v) allowing MOHCD
7 discretion to increase the Qualifying Income level for the unit by up to 20% above the
8 maximum income limit currently allowed by the Use Restrictions for the unit but at no time
9 higher than 150% of AMI. MOHCD and the Commission shall set forth criteria for granting
10 such allowances such as establishing a minimum time that the units must have been
11 advertised by MOHCD without selling; establishing criteria related to unusual economic or
12 personal circumstances of the owner; providing a maximum percentage for the increase
13 above the maximum income limit currently allowed; providing that the increase may only be
14 granted on a one-time basis; and requiring the owner to clearly establish that the BMR unit is
15 being resold at the maximum resale price specified in the Procedures Manual, as amended
16 from time to time.

17 **(B) Waiver of Maximum Qualifying Income Level for New Buyers of**
18 **Initial Sale BMR Units.** The Board of Supervisors recognizes that the current Program
19 provides that the income of a new buyer of a below market rate household cannot exceed the
20 maximum income stated in the Planning Approval or Notice of Special Restrictions for the
21 BMR Unit. Due to less desirable developments or geographic areas, a project sponsor is
22 sometimes unable to find a buyer for a BMR Unit within the maximum income stated in the
23 Planning Approval or Notice of Special Restrictions for the unit. This situation makes it
24 difficult, if not impossible, for certain current owners of below market rate units to resell their
25 units. In order to minimize this situation, the Board of Supervisors directs MOHCD to study

ways to address this issue and, if it deems appropriate, to make recommendations to the *Planning* Commission to amend the Procedures Manual to allow MOHCD to assist project sponsors who have used good faith efforts as determined by MOHCD to secure a contract with a qualified buyer but who are unable to secure such a contract in a timely manner from the initiation of marketing. Such amendments may include allowing MOHCD discretion to increase the Qualifying Income level for the unit by up to 20% above the maximum income limit currently allowed by the Use Restrictions for the unit but at no time higher than 150% of AMI. MOHCD and the *Planning* Commission shall establish limits to this or a similar proposal such as: providing a maximum percentage for the increase above the maximum income limit currently allowed; requiring that a certain period without securing a buyer would pass before such an allowance would be made; and providing that the increase may only be granted on a one-time basis.

(9) Adjustment of Pricing and Income Limits for Owned Units Purchased at a Price Above the Affordable Price Determined at the Time of Resale.

(A) Findings and Purposes. The Board of Supervisors finds that the requirements of this Program and the Procedures Manual may create financial hardship for certain Owners of Affordable Units who could suffer a financial loss if said Owners sold their units at a price in compliance with the existing Notice of Special Restrictions or other affordability restrictions for the unit. However, the Board also recognizes that the requirements of this Program are important to preserve the long-term affordability of units restricted under the Program. To provide flexibility while protecting the long-term affordability of the Affordable Units and viability of the Program, this subsection (b)(9) provides options to allow some relief for Owners of Affordable Units that are re-selling at a time when the Affordable Price would be lower than the price at which they originally purchased their Affordable Unit.

(B) Authorization to Reset Pricing and Income Limits. The Board

1 authorizes MOHCD to adjust the Affordable Price at the time of resale and to establish the
2 corresponding maximum income limit or income range for eligible Owned Units, as further
3 specified and limited in this subsection (b)(9). This authorization and adjustment procedure
4 shall be available only once per eligible Owned Unit and shall result in an Affordable Price that
5 is based on a permanent increase to the restrictions on Affordable Price and maximum
6 income limit for the Owned Unit. For the resale and any subsequent resale of the Owned Unit,
7 the Maximum Purchase Price shall be determined by MOHCD based on the new, increased
8 maximum percentage of AMI established pursuant to this subsection (b)(9).

9 (C) **Eligibility.** An Owned Unit is eligible for an increase in the Affordable
10 Price and corresponding maximum income limit or income range for the Owned Unit if: 1) the
11 Owner purchased the unit at a price above the Affordable Price at the time of resale, which
12 Affordable Price shall be determined by MOHCD based on the existing Notice of Special
13 Restrictions or other document establishing affordability requirements for the unit at the time
14 MOHCD processes the Owner's resale request; and 2) the Owner submits a resale request
15 for the unit to MOHCD ~~within three years from~~ by December 14, 2027, the effective date of the
16 ~~ordinance in Board File No. 240802, enacting this subsection (b)(9).~~ The Owner is not required to
17 attempt to sell the unit prior to the adjustment described in this subsection (b)(9) to qualify for
18 said adjustment.

19 (D) **Maximum Allowable Adjustment.** For the resale of an Owned Unit
20 eligible for an adjustment under this subsection (b)(9), MOHCD may establish an adjusted
21 Affordable Price up to the original purchase price paid by the current Owner. MOHCD may
22 increase the maximum income limit or income range for the unit to reflect the adjusted
23 Affordable Price, up to a maximum of 130% AMI. In addition, once per eligible Owned Unit,
24 MOHCD may increase the maximum Qualifying Income level for the unit by up to 20% above
25 the maximum income limit or income range in the new Notice of Special Restrictions or other

1 document establishing affordability requirements for the unit, provided that the increased
2 maximum Qualifying Income level does not exceed 150% of AMI. The ultimate resale price
3 may be lower or higher than the adjusted Affordable Price. Nothing in this subsection (b)(9)
4 ensures or entitles an Owner to a resale price equal to the adjusted Affordable Price when
5 reselling their Owned Unit.

6 (E) **Procedures.**

7 (i) MOHCD shall propose policies and procedures for
8 implementing price and AMI level adjustments consistent with this subsection (b)(9) to the
9 *Planning* Commission for inclusion in the Procedures Manual.

10 (ii) MOHCD may establish an adjusted Affordable Price and
11 increase the maximum AMI level consistent with this subsection (b)(9) for the purposes of
12 processing the resale, including marketing the Affordable Unit. If approved pursuant to
13 subsections (b)(9)(E)(iii) through (vi), the increased maximum AMI level shall be established
14 for all other purposes by the recording of a new Notice of Special Restrictions upon closing
15 the resale of the Owned Unit that reflects the increased AMI level. As a condition of MOHCD's
16 approval of the adjustments under this subsection (b)(9), the Owner shall execute and
17 authorize the recordation of the new Notice of Special Restrictions in senior lien priority upon
18 closing the resale of the Owned Unit.

19 (iii) For units in principal projects that required *Planning*
20 Commission approval, the *Planning* Commission, in consultation with MOHCD, may modify
21 any original conditions of approval for the principal project related to the maximum price or
22 income levels consistent with this subsection (b)(9), including, but not limited to, modification
23 to the required terms of a Notice of Special Restrictions recorded or to be recorded against
24 the project or the Owned Unit. If the *Planning* Commission has delegated its authority to the
25 Planning Department to review and approve requests for pricing and AMI level adjustments,

1 such adjustments shall be reviewed and considered for approval by the Director of the
2 Planning Department, and the *Planning* Commission shall not hold a public hearing for
3 discretionary review.

4 (iv) For units in principal projects that required *Planning*
5 Department approval but not *Planning* Commission approval, the *Planning* Department, in
6 consultation with MOHCD, may modify any original conditions of approval for the principal
7 project related to the maximum price or income levels including but not limited to modification
8 to the required terms of a Notice of Special Restrictions recorded or to be recorded against
9 the project or the Owned Unit.

10 (v) For units in principal projects that did not require *Planning*
11 Commission or *Planning* Department approval, the *Planning* Department, in consultation with
12 MOHCD, may modify the required terms of a Notice of Special Restrictions recorded or to be
13 recorded against the project or the Owned Unit.

14 (vi) Any other City approval required prior to modifying the terms
15 of a Notice of Special Restrictions, such as amending a development agreement, shall be
16 obtained.

17 (vii) Modifications under this subsection (b)(9) shall not be subject
18 to review under any other Planning Code provision applicable to a change of use or change of
19 condition including but not limited to Sections 303(e), 309(f), or 329(f)(7).

20 (F) **Reporting.** MOHCD shall provide a report to the Inclusionary
21 Housing Technical Advisory Committee, Planning Commission, and Board of Supervisors or a
22 committee thereof after 10 adjustments are approved under this subsection (b)(9), and after
23 every tenth adjustment approved thereafter. In addition, MOHCD shall provide a report to the
24 Inclusionary Housing Technical Advisory Committee, Planning Commission, and Board of
25 Supervisors or a committee thereof ~~within twelve months from~~ by December 14, 2025 ~~the effective~~

1 ~~date of the ordinance in Board File No. 240802 enacting this subsection (b)(9),~~ and every ~~twelve~~ 12
2 months thereafter. The Board of Supervisors or a committee thereof shall hold a public
3 hearing on the first annual report; accordingly, that report must be accompanied by a draft
4 resolution for the Board to accept the report. Each report provided pursuant to this subsection
5 (F) shall include at least the following information for each approved adjustment:

6 (i) The location of the Affordable Unit;
7 (ii) The date the adjustment was approved; and
8 (iii) Pricing and AMI level information before and after the
9 adjustment.

10 (G) **Expiration of this Subsection and Related Subsection.** This
11 subsection (b)(9), and the related subsection (a)(4)(F), shall expire by operation of law on
12 December 14, 2028. ~~four years from the effective date of the ordinance in Board File No. 240802~~
13 ~~enacting those two subsections.~~ Upon expiration of those subsections, the City Attorney is
14 authorized to cause their removal from the Planning Code, which removal may include as
15 appropriate nonsubstantive modifications in subsection lettering, numbering, punctuation, and
16 language.

17 (c) For any units permitted to be Rental Units under the Program, MOHCD shall
18 establish, and set forth in the Procedures Manual, the following:

19 **BOARD OF SUPERVISORS.**

20 **(a) Findings.**

21 San Francisco continues to experience a housing crisis that requires a broad spectrum
22 of land use and financing tools to address. The 2022 Housing Element Update of the City's
23 General Plan calls for 40% of all new housing production to be affordable for lower income
24 households below 80% of area median income and 17% of new housing affordable to be built
25 for moderate/middle income households up to 120% of area median income. San Francisco's

1 inclusionary housing program, which requires housing developers to provide affordable units
2 as part of their projects, is a critical component of the City's programs to expand affordable
3 housing options. The Inclusionary Housing program is one of the City's tools for increasing
4 affordable housing dedicated to lower income San Franciscans without using public subsidies,
5 and in particular it is a useful tool for creating any affordable housing to meet the growing
6 need of moderate/~~middle~~ income households.

7 The City adopted an Inclusionary Housing ordinance in 2002 that set requirements on
8 market rate development to include affordable units at 12% of the total for the first time. As of
9 2025, the ~~The~~ inclusionary program has successfully resulted in more than ~~3,330~~ 3,600 units of
10 below-market, permanently affordable housing since its adoption. The City prepared a Nexus
11 Study in 2007 in support of the program, which was updated in 2016. The reports
12 demonstrated the necessary affordable housing in order to mitigate the impacts of market rate
13 housing. The City's inclusionary housing requirements, which have been set at various levels
14 since 2002 in response to changing economic conditions, are codified in Section 415 et seq. of
15 the Planning Code.

16 The purpose of this Section 415.10 is to provide for the ongoing study of how to set
17 inclusionary housing obligations in San Francisco at the maximum economically feasible
18 amount in market rate housing development to create housing for low and moderate/~~middle~~
19 income households, at the income levels set forth in Section 415.10(d), and with guidance
20 from the City's Nexus Study, which shall be periodically updated.

21 (b) **Triennial Economic Feasibility Analysis.** With the support of independent
22 consultants as deemed appropriate by the Controller and with advice on setting qualifications
23 and criteria for consultant selection from the Inclusionary Housing Technical Advisory
24 Committee established in Administrative Code Chapter 5, Article XXIX, the Controller, in
25 consultation with relevant City Departments and the Inclusionary Housing Technical Advisory

1 Committee, shall conduct a feasibility study of the City's inclusionary affordable housing
2 obligations set forth in Planning Code Section 415 et seq., including but not limited to the
3 affordable housing fee and On- site and Off-site Alternatives, and shall submit a report to the
4 Board of Supervisors by September 1, 2029. ~~July 31, 2016 and by October 31 for subsequent years.~~
5 Thereafter, the Controller, in consultation with the Department and the Inclusionary Housing
6 Technical Advisory Committee, shall repeat this process at least every 36 months, or more
7 frequently as deemed necessary by the Controller in response to a significant shift in
8 economic or market conditions.

9 (c) **Elements of the Economic Feasibility Analysis.** The economic feasibility
10 analysis required by subsection (b) of this Section 415.10 shall include sensitivity analyses of
11 key economic parameters that can vary significantly over time, such as, but not limited to:
12 interest rates; capitalization rates; equity return rates; land prices; construction costs; project
13 scale, available state and federal housing finance programs including Low Income Housing
14 Tax Credits readily available for market rate housing; tax-exempt bond financing; Federal
15 Housing Administration and U.S. Department of Housing and Urban Development mortgage
16 insurance; available City or local housing finance programs, such as Enhanced Infrastructure
17 District (EIFD) and tax increments; zoning changes that increase or decrease development
18 potential; variable City exactions, including community benefit fees, capacity charges,
19 community facilities districts; the value of state density bonus, concessions and incentives
20 under California Government Code Section 65915 and any other state law that confers value
21 to development and which project sponsors may attempt to avail themselves of and public-
22 private partnership development agreements where applicable and other factors as deemed
23 reasonably relevant.

24 (d) **Report to Board of Supervisors.** The Board of Supervisors may review the
25 feasibility analyses, as well as the periodic updates to the City's Nexus Study evaluating the

1 necessary affordable housing in order to mitigate the impacts of market rate housing. The
2 Board of Supervisors will review the feasibility analyses within three months of completion and
3 may consider legislative amendments to the City's Inclusionary Affordable Housing ~~in-lieu~~ fees,
4 On-site or Land Dedication/Off-site Alternatives, and in so doing will seek consultation from the
5 ~~Planning~~ Commission, adjusting levels of inclusionary or affordable housing obligations and
6 income levels ~~up to maximums as defined in Section 415.2~~, based on the feasibility analyses, with
7 the objective of maximizing affordable Inclusionary Housing in market rate housing
8 production, and with guidance from the City's Nexus Study. Any adjustment in income levels
9 shall be adjusted commensurate with the percentage of units required so that the obligation
10 for inclusionary housing is not reduced by any change in income levels. The Board of
11 Supervisors may also utilize the Nexus Study in considering legislative amendments to the
12 Inclusionary Housing requirements. Updates to the City's Inclusionary Housing requirements
13 shall address affordable housing fees, On-site affordable housing and Land Dedication/Off-site
14 affordable housing, as well as the provision of affordable housing available to low-income
15 households at or below 55% of Area Median Income for Rental Units and up to 80% of Area
16 Median Income for Owned Units, and moderate/middle-income households from 80% to
17 120% of Area Median Income.

18 **(e) Permitted Modifications to Pipeline Projects Following Legislative Amendments to the**
19 **Inclusionary Affordable Housing Program. If any of the requirements of Section 415.1 et seq., are**
20 **amended by the Board of Supervisors following recommendation by the Technical Advisory Committee**
21 **or otherwise, Pipeline Projects may request a modification of conditions of approval, conditions on a**
22 **project permit, Notice of Special Restrictions, or other requirements that have been so amended**
23 **pursuant to requirements of Section 415.1 et seq.. Modifications shall be requested under the process**
24 **set forth in Planning Code section 415.4(e)(4). In addition to the modifications allowed in Section**
25 **415.4(e)(2), a Pipeline Project may seek the following additional modifications:**

1 (1) A reduction in the Affordable Housing Fee, or On-site Unit, Off-site Unit or Land
2 Dedication percentages or other requirements in effect at the time of the modification request.

22 ~~**(a) Need for New Housing and Other Land Uses.** San Francisco is experiencing a severe~~
23 ~~shortage of housing available to people at all income levels. In addition, San Francisco has an ongoing~~
24 ~~affordable housing crisis. Many future San Francisco workers will be earning below 80% of the area's~~
25 ~~median income, and even those earning moderate or middle incomes, above the City's median, are~~

1 likely to need assistance to continue to live in San Francisco. In 2007, the median income for a family
2 of four in the City was about \$86,000. Yet median home prices suggest that nearly twice that income is
3 needed to be able to afford a dwelling suitable for a family that size. Only an estimated 10% of
4 households in the City can afford a median-priced home.

5 The Association of Bay Area Governments' (ABAG) Regional Housing Needs Determination
6 (RHND) forecasts that San Francisco must produce over 31,000 new units in the next five years, or
7 over 6,000 new units of housing annually, to meet projected needs. At least 60%, or over 18,000, of
8 these new units should be available to households of very low, low, and moderate incomes. With land in
9 short supply in the City, it is increasingly clear that the City's formerly industrial areas offer a critical
10 source of land where this great need for housing, particularly affordable housing, can be partially
11 addressed.

12 **(b) Target Area For New Housing.** San Francisco's Housing Element establishes the Eastern
13 Neighborhoods as a target area for development of new housing to meet San Francisco's identified
14 housing targets. The release of some of the area's formerly industrial lands, no longer needed to meet
15 current industrial or PDR needs, offers an opportunity to achieve higher affordability, and meet a
16 greater range of need. The Mission, Showplace Square – Potrero Hill, East SoMa and Central
17 Waterfront Area Plans of the General Plan (Eastern Neighborhoods Plans) thereby call for creation of
18 new zoning intended specifically to meet San Francisco's housing needs, through higher affordability

(1) **Infrastructure.** All monies deposited in the Fund, plus accrued interest, shall be used solely to design, engineer, acquire and develop neighborhood recreation and open space, pedestrian amenities and streetscape improvements, and bicycle infrastructure that result in new publicly-accessible facilities. First priority should be given to projects within the Van Ness & Market Residential Special Use District. Second Priority should be given to projects within the Market and Octavia Plan Area or within 1,250 feet of the Plan Area. 22 Well-Resourced Neighborhoods.

23 (b) ~~Additional Inclusionary Housing Options~~ **Rent Control In Lieu of Inclusionary Housing.**

24 ~~(1) Rent Control.~~ If an eligible Housing Project is a Rental Housing Project and
25 agrees to subject all units in the project to the San Francisco Rent Stabilization and Arbitration

1 Ordinance (Chapter 37 of the Administrative Code) for the Life of the Project, the project shall
2 not be subject to the Inclusionary Housing Ordinance, Planning Code Section 415 et seq.,
3 pursuant to this Section 436.

4 (A1) **Regulatory Agreement.** Project Sponsors of Housing Projects that
5 agree to subject all units in the Housing Project to the San Francisco Rent Stabilization and

7 shall enter into a regulatory agreement with the City, as a condition of approval of the project

12 and agreed to the terms of an agreement with the City in consideration for a direct financial

14 65915 et seq.; (B) a statement that the units will be rented for the Life of the Project because,
15 consistent with Government Code Section 7060.1(a), the property owner has entered into and
16 agreed to the terms of an agreement with the City, in consideration for a direct financial
17 contribution specified in Section 7060.1(a); (C) a statement that all units subject to the
18 Regulatory Agreement shall be held as an undivided ownership and will not be subdivided;
19 (D) a calculation of the direct financial contribution or form of assistance provided to the
20 property owner in the form of the fee waiver; and (E) a description of the remedies for breach
21 of the agreement and other provisions to ensure implementation and compliance with the
22 agreement. The property owner and the Planning Director or the Director’s designee, on
23 behalf of the City, may execute the Regulatory Agreement, which shall be reviewed and
24 approved as to form by the City Attorney’s Office. The Regulatory Agreement shall be
25 executed prior to the City’s issuance of the First Construction Document for the project, as

defined in Section 107A.13.1 of the San Francisco Building Code. ~~(2) **Land Dedication Alternative.** In lieu of Section 415 et seq., the Project Sponsor of any Housing Project outside the Priority Equity Geographies SUD, may comply with the Land Dedication Alternative requirements in Section 419.5(a)(2), except that in lieu of the Land Dedication Alternative requirements of Table 419.5, projects may satisfy the requirements of Section 415.5 by dedicating land for affordable housing if the dedicated land could accommodate a total amount of units that is equal to or greater than 35% of the units that are being provided on the principal development site, as determined by the Planning Department. Any land dedicated pursuant to this Section 436 shall be provided outside the Priority Equity Geographies SUD.~~

7 (a) **Purpose.** This Section 206.3 sets forth the HOME-SF Program. The HOME-SF
8 Program or “HOME-SF” provides benefits to project sponsors of housing projects that either
9 (1) set aside residential units onsite at below market rate rent or sales price in an amount
10 higher than the amount required by the Inclusionary Housing Ordinance, or (2) agree to
11 subject all units in the project, except for units required by the Inclusionary Housing
12 Ordinance, to the San Francisco Rent Stabilization and Arbitration Ordinance (Chapter 37 of
13 the Administrative Code). The purpose of HOME-SF is to expand the number of below market
14 rate units produced in San Francisco and provide housing opportunities to a wider range of
15 incomes than traditional affordable housing programs, such as the City’s Inclusionary
16 Affordable Housing Program, Planning Code Sections 415 et seq., which typically provide
17 housing only for very low, low or moderate income households, and to expand the number of
18 units in San Francisco that are subject to rent control. For projects that elect to provide
19 additional on-site below market rate units, HOME-SF also provides an alternative method of
20 complying with the on-site inclusionary option set forth in Section 415.6. HOME-SF allows
21 market-rate projects to match the City’s Proposition K (November 2014) housing goals that
22 50% of new housing constructed or rehabilitated in the City by 2020 be within the reach of
23 working middle class San Franciscans, and that at least 33% be affordable for low and
24 moderate income households, and the Housing Element of the General Plan’s finding that
25 rent control has been critical to protecting low- and moderate-income residents from being at

1 risk of eviction and displacement.-

3 (ix) For projects that elect to proceed under Section 206.3(c)(1)(B), a statement
4 that the units included in such project, except for any Affordable Units as defined in Planning

6 Code Sections 1954.50 et seq.) because under Section 1954.52(b), the property owner has
7 entered into and agreed to the terms of the agreement with the City in consideration for

15 (f) ~~Temporary provisions~~ HOME-SF Eligibility Tiers. To facilitate the construction of
16 HOME-SF projects that elect to include HOME SF Units under subsection (c)(1)(A) of this
17 Section 206.3, and based on information from the inclusionary housing study prepared for the
18 Divisadero and Fillmore Neighborhood Commercial Transit District, in Board of Supervisors
19 File No. 151258, and the Office of the Controller's Inclusionary Housing Working Group final
20 report (February 2016), the HOME-SF program shall include temporary development
21 incentives as specified in this subsection (f) based on the amount and level of affordability
22 provided in this subsection (f). For any development project that has submitted a complete

(1) **HOME-SF Project Eligibility Requirements.** To receive the development bonuses granted under this Section 206.3, a HOME-SF Project must provide a percentage of units, in the amounts set forth in ~~§~~Section 206.3(f)(2)(A), (B), or (C), as HOME-SF Units, as defined in Section 206.2. The HOME-SF Units shall be restricted for the Life of the Project and shall comply with all of the requirements of the Procedures Manual authorized in Section 415 except as otherwise provided in this Section 206.3. All HOME-SF Units must be marketed at a price that is at least 20% less than the current market rate for that unit size and neighborhood, and MOHCD shall reduce the Area Median Income levels set forth in this Section 206.3 in order to maintain such pricing. As provided for in subsection (e), the Planning Department and MOHCD shall amend the Procedures Manual to provide policies and procedures for the implementation, including monitoring and enforcement, of the HOME-SF Units;

(2) **Development Bonuses.** Any HOME-SF Project shall at the project sponsor's request receive the following:

(A) **Tier One:** ~~A Tier One HOME-SF Project that consists of fewer than 25 units and are Owned Units shall provide 20% of units in the HOME-SF Project as HOME-SF Units at the following levels: ten percent shall have an average affordable purchase price set at 80% of Area Median Income; 5% shall have an average affordable purchase price set at 105% of Area Median Income; and 5% shall have an average affordable purchase price set at 130% of Area Median Income. A Tier One HOME-SF Project that consists of fewer than 25 units and are rental units shall provide 20% of units in the HOME-SF Project as HOME-SF Units at the following levels: ten percent shall have an average affordable rent set at 55% of Area Median Income; 5% shall have an average~~

(e) **Additional Height, Square Footage, and Other Bonuses.** HC-SF Projects that contain certain uses, amenities, or other building features are eligible for additional bonuses and code modifications, as described below.

(7) **Limits on Bonuses.** Except as provided below, an HC-SF Project can combine the heights, square footage, and additional bonuses in subsections (e)(1) through (e)(6).

~~(1A)~~ **Height.** A project may combine the bonuses in subsections (e)(1) through (e)(5) provided that any height bonus is limited to 10 feet above the Housing Choice-SF height limit. A project may combine the bonuses in subsections (e)(1) through (e)(6) provided that any height bonus is limited to 30 feet above the Housing Choice-SF height limit.

~~(2B)~~ **Rear Yard.** A project cannot reduce the required rear yard beyond the lowest of the limits set forth in subsections (e)(3)-(e)(6).

SEC. 243. VAN NESS SPECIAL USE DISTRICT.

(a) **General.** A Special Use District entitled the Van Ness Special Use District, the boundaries of which are shown on Sectional Map No. SU02 of the Zoning Map of the City and County of San Francisco, is hereby established for the purposes set forth below.

6 additions to existing structures that exceed 20% of the gross floor area of the existing
7 structure, nonresidential uses shall be permitted in the addition in excess of 20% only if the
8 ratio between the amount of occupied floor area for residential use, as defined in this
9 paragraph below, to the area of occupied floor area for nonresidential use is 3 to 1 or greater.
10 This residential use ratio shall not apply to (i) development sites in the Van Ness Special Use
11 District that have less than 60 feet of street frontage on Van Ness Avenue and have no street
12 frontage other than the Van Ness Avenue frontage, or (ii) development consisting of new
13 construction proposed for an Institutional Community Use at 1750 Van Ness Avenue,
14 Assessor's Parcel Block 0622, Lot 019. For purposes of this Section, "nonresidential uses"
15 shall mean any use not defined as a Residential Use in Section 102 and principally or
16 conditionally permitted in the Van Ness Special Use District.

17 (B) **Reduction of Ratio of Residential Uses for Affordable Housing.**

18 The ~~Planning~~ Commission may modify the Van Ness Special Use District residential to
19 nonresidential use ratio between Golden Gate Avenue and California Street, or may modify the
20 timing and location requirements of linked projects, as a with eConditional uUse authorization
21 provided that, in one of the following ways: in addition to the findings required by Section 303(c), the
22 Commission finds that:

23 (i) ~~In Lieu Fee. By conditional use, the developer may elect to fulfill the~~
24 ~~obligation to build housing by paying an in-lieu fee to the Affordable Housing Fund as provided in~~
25 ~~Section 413 of this Code. No more than a 50 percent reduction of the required housing for a specific~~

project can be fulfilled by paying an in-lieu fee. Use of these funds shall provide affordable housing within 2,000 feet of the Van Ness Special Use District. The in-lieu fee shall be determined by the following formula:

(ii) **Providing Affordable Housing.** By conditional use, the developer may reduce up to 50 percent of the required amount of on-site housing by maintaining a portion of that housing as permanently affordable for the life of the project. Affordable units shall be managed by a nonprofit housing agency through a duly executed agreement between the project sponsor, the nonprofit agency, and the Planning Department. The mix of affordable units retained in the project shall conform to the overall dwelling unit size mix of the project. The portion of retained residential that shall be affordable will be determined by calculating the number of market rate units that could be subsidized by the amount of "in-lieu fee" calculated in Paragraph (i) above. The number of square feet of affordable housing shall be calculated in the following manner:

$$(1) \text{---} \text{In-Lieu Fee} / \$30/\text{square foot subsidy} = \text{Square Feet of Affordable Housing Retained in the Project}$$

(iii) **Annual Reporting, Evaluation, and Adjustments to Affordability and Fee Calculations.** The Department shall report annually to the Planning Commission on the activity and utilization of Section 243(c)(8)(B). Based on an evaluation of this report, the Planning Commission may initiate a modification or deletion of Section 243(c)(8)(B). The dollar amounts used in the calculation for Paragraphs (i) and (ii) of this Subsection shall be subject to annual adjustments in accord with Section 409 of this Code. (1) **Purpose.** The Central SoMa Plan Area contains a number of large, underutilized development sites. By providing greater flexibility in the development of these sites, the City has an opportunity to achieve key objectives of the Central SoMa Plan and to locate important public assets that would otherwise be difficult to locate in a highly developed neighborhood like SoMa.

* * * *

(3) **Controls.** Pursuant to this Section 329(e) and the Key Site Guidelines adopted as part of the Central SoMa Area Plan, the Planning Commission may grant exceptions to the provisions of this Code as set forth in subsection (d) above and may also grant the exceptions listed below for projects that provide qualified amenities in excess of what is required by the Code.

(A) **Qualified Amenities.** Qualified additional amenities that may be provided by these Key Sites include: affordable housing beyond what is required under Section 415 et seq.; land dedication pursuant to Section 413.6 by non-residential projects for

1 construction of affordable housing in partial or full satisfaction of the Jobs-Housing linkage
2 Fee, or in excess of that required to satisfy the Jobs-Housing linkage Fee, provided that if the
3 land dedication is in partial satisfaction of that Fee, the balance of the Fee shall be paid with
4 the land value calculated as set forth in Section 413.6; land dedication pursuant to Section
5 413.6 by residential projects for construction of affordable housing in partial or full satisfaction
6 of the Alternatives to the Inclusionary Housing Fee, or in excess of that required to satisfy the

8 permitted by state law, provided that if the land dedication is in partial satisfaction of that Fee,
9 the balance of the Fee shall be paid with the land value calculated as set forth in Section
10 413.6; PDR at a greater amount and/or lower rent than is otherwise required under Sections
11 202.8 or 249.78(c)(5); public parks, recreation centers, or plazas; and improved pedestrian

SEC. 759. DIVISADERO STREET NEIGHBORHOOD COMMERCIAL TRANSIT DISTRICT.

The Divisadero Street Neighborhood Commercial Transit District (“Divisadero Street NCT”) extends along Divisadero Street between Haight and O’Farrell Streets. Divisadero Street’s dense mixed-use character consists of buildings with residential units above ground-story commercial use. The District has an active and continuous commercial frontage along Divisadero Street for most of its length. Divisadero Street is an important public transit corridor and throughway street. The commercial district provides convenience goods and services to the surrounding neighborhoods as well as limited comparison shopping goods for a wider market.

~~If the Planning Department determines that any site proposed for residential development and located within the Divisadero Street NCT has received a 50% or greater increase in residential densities over prior zoning through the adoption of Ordinance No. 127-15, any development project that is subject to the Inclusionary Affordable Housing Program on such site shall pay the Affordable Housing Fee, or provide one of the Alternatives to Payment of the Affordable Housing Fee, set forth in Planning Code Sections 415 et seq., except that the amount of the Affordable Housing Fee or Alternatives to Payment of the Affordable Housing Fee shall be modified as set forth in Planning Code Sections 428 et seq.~~

1 dedicated solely to replenishing the Neighborhood Infrastructure Seed Fund for that specific
2 neighborhood infrastructure impact fee account. In no event shall a neighborhood infrastructure
3 impact fee specific to one Area Plan be mixed with neighborhood infrastructure impact fees specific to
4 a different Area Plan. If the 20 percent development fee pre-payment exceeds the total amount owed for
5 the neighborhood infrastructure impact fee account, the remaining pre-paid portion of the 20 percent
6 development fee pre-payment shall be apportioned equally among the remaining applicable
7 development fees.

8 The neighborhood infrastructure development fees subject to the 20 percent pre-payment
9 provision of this Subsection 107A.13.3.1.1 are as follows: (1) the Rincon Hill Community Infrastructure
10 Impact Fee, as set forth in Planning Code Section 418.3(b)(1); (2) the Visitacion Valley Community
11 Facilities and Infrastructure Fee, as set forth in Planning Code Section 420.3(b); (3) the Market and
12 Octavia Community Infrastructure Fee, as set forth in Planning Code Section 421.3(b); (4) the Balboa
13 Park Community Infrastructure Impact Fee, as set forth in Planning Code Section 422.3(b); (5) the
14 Eastern Neighborhoods Infrastructure Impact Fee, as set forth in Planning Code Section 423.3(b); (6)
15 the Van Ness and Market Neighborhood Infrastructure Impact Fee, as set forth in Planning Code
16 Section 424.3(b)(ii); and (7) the Central SoMa Infrastructure Impact Fee, as set forth in Planning Code
17 Section 433.

18 **Sec. 107A.13.3.1.2 Prior deposit of pre-paid portion of deferred development impact fees into**
19 **Neighborhood Infrastructure Seed Funds.** For a project that has been issued a first construction
20 document, but has not been issued a first certificate of occupancy, any portion of a non-neighborhood
21 infrastructure development impact fee that has been paid into a Neighborhood Infrastructure Seed
22 Fund under Section 107A.13.3.1.1 shall be reallocated and deposited into the applicable fee account.

23
24 Section 8. Chapter 5, Article XXIX, and Chapter 10, Article XIII, of the Administrative
25 Code are hereby amended by revising sections 5.29-6, and 10.100-49 respectively, to read as

1 follows:

2 **CHAPTER 5: COMMITTEES**

4 **ARTICLE XXIX. INCLUSIONARY HOUSING TECHNICAL ADVISORY COMMITTEE**

5 * * * *

6 **SEC. 5.29-6. MEETINGS AND PROCEDURES.**

7 The Advisory Committee shall hold a regular meeting not less than once every four
8 months until the sunset date set forth in Section 5.29-7. Notwithstanding any other provision
9 of this Section 5.29 or Planning Code section 415.10, the Advisory Committee shall convene
10 no later than ~~January 1, 2026~~ April 1, 2029, and every 36 months thereafter.

14 **ARTICLE XIII: FUNDS**

15 * * * *

16 **SEC. 10.100-49. CITYWIDE AFFORDABLE HOUSING FUND.**

17 (a) **Establishment of Fund.** The Citywide Affordable Housing Fund is established as
18 a category eight fund to receive fee revenue dedicated to affordable housing and other
19 contributions to the fund. The fund receives, or received, money from, among other sources:

20 (1) The North of Market Residential Special Use District, former Planning Code
21 Section 263.7;

22 (2) The Jobs Housing Linkage Program, Planning Code Sections 413 et seq.;

23 (3) The Inclusionary Affordable Housing Program, Planning Code Sections 415
24 et seq.;

25 (4) The Market and Octavia Affordable Housing Program, former Planning Code

1 Section 416.5;

2 (5) The Eastern Neighborhoods Area Plan Alternate Affordable Housing Fee,
3 former Planning Code Section 417.5;

4 (6) The Eastern Neighborhoods Housing Fund, Planning Code Section 423.5;

5 (7) The Expedited Condominium Conversion Program, Subdivision Code
6 Section 1396.4; and,

7 (8) Repayments of loans and other program income associated with
8 investments initially made with monies from the fund.

9 (b) **Use of Fund.** The fund is to be used exclusively by the Mayor's Office of Housing
10 and Community Development ("MOHCD"), or its successor, for the purpose of supporting
11 affordable housing in San Francisco. Specific eligible uses of the fund are delineated for each
12 fee in the code where the fee is or was established, or as set forth in subsection (e). Within the
13 fund, all fees, repayments, and program income shall be separately accounted for as required
14 by each fee.

15 (c) **Exceptions to Fund Category.** The Director of ~~the Mayor's Office of Housing and~~
16 ~~Community Development~~ MOHCD shall approve all expenditures from the fund.

17 (d) **Administration of Fund.** ~~The Mayor's Office of Housing and Community Development,~~
18 ~~or its successor,~~ MOHCD shall administer the fund and shall report annually to the Board of
19 Supervisors on the current status of the fund, the amounts approved for disbursement, and
20 the number and types of housing units or households assisted. ~~The Mayor's Office of Housing~~
21 ~~and Community Development~~ MOHCD shall have the authority to prescribe rules and regulations
22 governing the Fund.

23 (e) The following fees were deleted in the ordinance in Board File No. 260538. Fees deposited
24 into those funds prior to the effective date of the ordinance in Board File No. 260538 shall continue to
25 be separately accounted for and expended according to the following priorities:

1 (1) Funds from the North of Market Residential Special Use District, former Planning
2 Code Section 263.7, shall be used solely to stabilize, rehabilitate, and retain affordable housing in the
3 North of Market Residential Special Use District. No fees collected under Section 263.7 may be used,
4 by way of loan or otherwise, to pay any administrative, general overhead, or similar expense of any
5 entity except for servicing cost related to participation in the amortized payment program.

6 (2) Funds from the Market and Octavia Affordable Housing program, former Planning
7 Code Section 416 et seq., shall be expended according to the following priorities: (a) to increase the
8 supply of housing Affordable to Qualifying Households in the Market and Octavia Plan Area and the
9 Upper Market Neighborhood Commercial Transit District (NCT); (b) to increase the supply of housing
10 Affordable to Qualifying Households within one mile of the boundaries of the Plan Area and the Upper
11 Market NCT District; and (c) to increase the supply of housing affordable to qualifying households in
12 the City and County of San Francisco.

13 (3) Funds from The Eastern Neighborhoods Area Plan Alternate Affordable Housing
14 Fee, former Planning Code Section 417 et seq., shall be expended according to the following priorities:
15 (a) to increase the supply of housing Affordable to Qualifying Households in the Eastern
16 Neighborhoods Project Areas; (b) to increase the supply of housing Affordable to Qualifying
17 Households within one mile of the boundaries of the Eastern Neighborhoods Project Areas; and (c) to
18 increase the supply of housing Affordable to Qualifying Households in the City and County of San
19 Francisco. No funds were collected within the Central SoMa Special Use District, thus the restrictions
20 on the use of those funds in former Planning Code Section 417.5 do not apply to the existing fund
21 balance.

22 (4) Funds from the Van Ness and Market Downtown Residential Special Use District
23 Affordable Housing Fund, former Planning Code Section 424.4, shall be prioritized as follows: (a) to
24 increase the supply of housing Affordable to Qualifying Households in the Van Ness & Market
25 Residential Special Use District; (b) to increase the supply of housing Affordable to Qualifying

1 Households within one mile of the boundaries of the Market and Octavia Area Plan; and (c) to increase
2 the supply of housing Affordable to Qualifying Households in the City and County of San Francisco.

3 (5) Funds from the Housing Requirements, UMU Zoning Districts of the Eastern
4 Neighborhoods, former Planning Code Section 419, shall be spent to increase the supply of housing
5 Affordable to Qualifying Households in the City and County of San Francisco.
6

7 Section 9: Deletion of “Significant increase in residential development potential.” This
8 ordinance, in Section 3, deletes the definition of “Significant increase in residential
9 development potential” in Planning Code Section 401. That definition was first adopted by the
10 Board of Supervisors in Motion M13-097, pursuant to then Charter Section
11 16.110(h)(1)(B)(iv), enacted by Proposition C, adopted by the voters in November 2012. That
12 Section required the City to “adopt a standard for determining what constitutes ‘a significant
13 increase in residential development potential.’” Charter Section 16.110(h), including the
14 requirement for defining a “significant increase in residential development potential,” was later
15 deleted by Proposition C, adopted by the voters in June 2016. Because Charter Section
16 16.110(h) has been deleted, the Charter requirement for a definition of “significant increase in
17 residential development potential” no longer exists and the definition may be deleted by
18 ordinance, as provided herein.
19

20 Section 10. This ordinance includes amendments to Section 415.3, 415.5, 415.6, and
21 415.7, and deletes Sections 419.3, 419.5, 428, and 428.3 in their entirety. Section 7 of
22 Ordinance 201-23, adopted November 12, 2023, amends those same sections, with an
23 operative date of November 21, 2026. This ordinance supersedes any amendments included
24 in Section 7 of Ordinance 201-23, and the Board hereby rescinds the amendments to those
25 sections made in Ordinance 201-23. Accordingly, the amendments to those sections made in

1 Ordinance 201-23 shall not become effective on November 21, 2026 or any other date, unless
2 re-enacted by the Board in a subsequent ordinance.

3
4 Section 11. Severability. If any section, subsection, sentence, clause, phrase, or word
5 of this ordinance, or any application thereof to any person or circumstance is held to be invalid
6 or unconstitutional by a decision of a court of competent jurisdiction, such decision shall not
7 affect the validity of the remaining portions or application of the ordinance; provided that if the
8 amendments to Planning Code Section 206.10 are held invalid or unconstitutional by decision
9 of a court of competent jurisdiction, all of Section 206.10 shall become inoperative and have
10 no legal effect. Except as stated regarding Section 206.10, the Board of Supervisors hereby
11 declares that it would have passed this ordinance and each and every section, subsection,
12 sentence, clause, phrase, and word not declared invalid or unconstitutional without regard to
13 whether any other portion of this ordinance or application thereof would be subsequently
14 declared invalid or unconstitutional.

15
16 Section 12. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
17 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
18 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
19 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
20 additions, and Board amendment deletions in accordance with the "Note" that appears under
21 the official title of the ordinance.

22
23 Section 13. Effective Date. This ordinance shall become effective on the 31st day
24 after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns
25 the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the

1 Board of Supervisors overrides the Mayor's veto of the ordinance.
