8 WHEREAS, On May 9, 2006, Supervisor Sandoval introduced legislation to initiate the  
9 process to amend the Zoning Map of the City and County of San Francisco to change the use  
10 designation of Lot 11C in Assessor's Block 6954 from RH-1 (One-Family) to NC-3 (Moderate-  
11 Scale Neighborhood Commercial District; and,

12 WHEREAS, On May 17, 2006 the proposed ordinance was referred to the Planning  
13 Commission, which currently is reviewing the proposed ordinance; and,

14 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by  
15 resolution, extend the prescribed time within which the Planning Commission is to render its  
16 decision on proposed amendments to the Planning Code (which includes the Zoning Map)  
17 initiated by the Board of Supervisors; and,

18 WHEREAS, The Planning Department has requested additional time to review the  
19 proposed ordinance; and,

20 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning  
21 Commission additional time to review the proposed ordinance and render its decision; now,  
22 therefore, be it


