I wanted to confirm that the substitute legislation does not include any changes to the Building Code changes already reviewed and recommended for approval by the BIC at the June BIC meeting.

Also, Charter, Section D3.750-5, after Prop B amended the BIC provisions, no longer governs BIC referral. It is now located in Charter Section 4.121.
