2 ADDING SECTION 32.6.22 TO THE SAN FRANCISCO TRAFFIC CODE, REGARDING PARKING
3 REGULATIONS ON PORTIONS OF LECH WALESIA STREET.

4 Note: This entire section is new.

5 Be it ordained by the people of the City and County of San Francisco:

6 Section 1. Article 3 of the San Francisco Traffic Code is hereby amended by adding Section
7 32.6.22 thereto to read as follows:

8 **SEC. 32.6.22. PARKING CONTROL, PORTIONS OF LECH WALESIA STREET; PENALTIES**
9 **FOR VIOLATION.** No person shall stop, park, or leave standing any vehicle, whether attended or
10 unattended, at the following locations:

11 (a) Lech Walesia Street, north side, from 120 feet to 235 feet west of Polk Street (115-foot
12 zone); and

13 (b) Lech Walesia Street, north side, from Polk Street to 89 feet westerly (89-foot zone)

14 except official City-owned vehicles displaying a valid permit issued by the Department of Public Health
15 authorizing parking in such zones. The permit exceptions under this Section shall not apply when
16 parking prohibition regulations for street-cleaning purposes are in effect. Violation of this Section is
17 an obstruction to the free use of property and a nuisance within the meaning of Division 4, Part III of
18 the Civil Code of California relating to nuisance and the abatement thereof.
