APPROVING THE PEDESTAL-MOUNTED NEWSRACK AGREEMENT BY AND BETWEEN THE CITY AND COUNTY OF SAN FRANCISCO AND ADSHEL INC. WHICH ALLOWS FOR THE PROVISION, INSTALLATION AND MAINTENANCE OF PEDESTAL MOUNTED NEWSRACKS ON PUBLIC PROPERTY; APPROVING AN INDEMNIFICATION OF THE CONTRACTOR BY THE CITY FOR ALL CLAIMS INITIATED BY A PUBLISHER HOLDING A PERMIT FOR A NEWSRACK BOX OR OTHER PUBLISHER CONCERNING THE NEWSRACKS, THEIR OPERATION OR THE AGREEMENT WITH ADSHEL, INC., AND AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF PUBLIC WORKS TO MAKE CHANGES TO THE DEPARTMENT OF PUBLIC WORKS DIRECTOR'S ORDERS INCORPORATED BY REFERENCE IN THE AGREEMENT WITH ADSHEL, INC.

Section 1. The Board of Supervisors hereby a.) approves the Pedestal-Mounted Newsrack Agreement By and Between the City and County of San Francisco and Adshel, Inc., which allows for the provision, installation and maintenance of pedestal mounted newsracks on public property in exchange for the Contractor's right to advertise on the back side of four hundred and fifty (450) such newsracks, a copy of which Agreement is contained in Board of Supervisors file number <sup>982047</sup> \_\_\_\_\_; and b.) Approves an indemnification by the City of Adshel Inc., for all claims initiated by a Publisher holding a permit for a newsrack box or other publisher concerning the newsracks, their operation or the City's Agreement with Adshel, Inc; and (c.) Authorizes the Director of the Department of Public Works to enter into any additions, amendments or changes to the Department of Public Works Director's Orders concerning the pedestal mounted newsracks incorporated by reference in the Agreement with Adshel, a draft of which is on file with the Clerk of the Board of Supervisors, as long as such additions, amendments or changes are in the City's best interest, consistent with San Francisco Public


