3 **Resolution approving the settlement of the unlitigated administrative enforcement**
4 **action filed by the Central Valley Regional Water Quality Control Board against**
5 **San Francisco imposing a penalty of \$1,000,000.**

7 WHEREAS, The Central Valley Regional Water Quality Control Board filed an
8 administrative enforcement action against the City and County of San Francisco alleging
9 violations of the federal Clean Water Act, the California Water Code, the Sacramento and San
10 Joaquin River Basins Plan; and the California Fish and Game Code; and

11 WHEREAS, The San Francisco Public Utilities Commission of the City and County of
12 San Francisco has recommended settlement of said administrative enforcement action by
13 payment of \$800,061 to The Central Valley Regional Water Quality Control Board, and
14 \$199,939 to the California Department of Fish and Wildlife for a total of \$1,000,000; now,
15 therefore, be it

16 RESOLVED, That pursuant to Section 10.22 of the San Francisco Administrative Code,
17 settlement and compromise of said complaint by payment of \$1,000,000 is hereby approved.
