25 **for food and beverage service; affirming the Planning Department's determination**

1 under the California Environmental Quality Act; and making findings of consistency
2 with the General Plan, and the eight priority policies of Planning Code, Section 101.1,
3 and public necessity, convenience, and welfare findings pursuant to Planning Code,
4 Section 302.

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Environmental and Land Use Findings.

14 (a) The Planning Department has determined that the actions contemplated in this
15 ordinance comply with the California Environmental Quality Act (California Public Resources
16 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
17 Supervisors in File No. 181211 and is incorporated herein by reference. The Board affirms
18 this determination.

19 (b) On March 7, 2019, the Planning Commission, in Resolution No. 20401, adopted
20 findings that the actions contemplated in this ordinance are consistent, on balance, with the
21 City's General Plan and eight priority policies of Planning Code Section 101.1. The Board
22 adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the
23 Board of Supervisors in File No. 181211, and is incorporated herein by reference.

24 (c) Pursuant to Planning Code Section 302, this Board finds that this Planning Code
25 Amendment will serve the public necessity, convenience, and welfare for the reasons set forth
in Planning Commission Resolution No. 20401, and the Board incorporates such reasons

1 herein by reference. A copy of Planning Commission Resolution No. 20401 is on file with the
2 Clerk of the Board of Supervisors in File No. 181211.

3
4 Section 2. Background, Purpose, and General Findings.

5 (a) In February 2018, the Office of Economic and Workforce Development
6 published “State of the Retail Sector: Challenges and Opportunities for San Francisco’s
7 Neighborhood Commercial Districts” (the “Retail Study”). Prepared by Strategic Economics,
8 the Retail Study included briefs studying: the national restructuring of the retail, restaurant,
9 and personal services industries; the factors required to support successful San Francisco
10 retail districts; and opportunities, costs, and challenges for retail, restaurant, and personal
11 services businesses in San Francisco, and the adaptations that businesses are making in
12 response to changing conditions.

13 (b) The Retail Study identified a national trend in retail stores seeking to experiment
14 with new strategies to capitalize on increasing consumer demand for experiences, as
15 opposed to objects. The Retail Study observed that, to remain competitive with e-commerce
16 businesses, retailers are increasingly seeking to incorporate food and drink sales, events, and
17 classes into their businesses, and noted a number of San Francisco businesses
18 experimenting with diverse offerings.

19 (c) While San Francisco possesses many competitive advantages that benefit local
20 retailers and restaurants, the Retail Study observed that a significant number of neighborhood
21 commercial districts are experiencing an increase in vacancy rates. The Retail Study also
22 found that San Francisco businesses face challenges connected to the City’s land use
23 regulations and permitting requirements, which can add significant cost and time to the
24 process of opening a new business and may limit retailers’ flexibility to adapt to changing
25 economic conditions.

1 (d) San Francisco's nightlife and entertainment sector is an integral part of the City's
2 vibrant commercial corridors. Nightlife and entertainment businesses attract tourists and
3 residents to the City's diverse neighborhoods. The Retail Study found that nightlife and
4 entertainment uses complement neighborhood retail sales and services by providing
5 destinations and gathering spaces for potential retail customers.

6 (e) According to the U.S. Bureau of Labor Statistics, the nightlife and entertainment
7 sector in San Francisco in 2017 was comprised of 3,715 restaurants, bars, live music venues,
8 nightclubs, and other performance spaces with 63,695 employees citywide.

9 (f) A 2016 analysis by the Controller's Office found that nightlife generated \$6
10 billion in consumer spending in 2015. The nightlife sector paid approximately \$80 million in
11 local taxes in 2015, including \$60 million in sales tax and \$20 million in payroll and gross
12 receipts taxes.

13 (g) Despite these significant contributions to the local economy, nightlife and
14 entertainment businesses often face zoning barriers, burdensome permitting requirements,
15 and duplicative inspections. Legislation to address these challenges will reduce storefront
16 vacancies, improve the permitting process for small businesses, enable retailers to engage in
17 creative strategies to attract customers and diversify revenues, and support the health of San
18 Francisco's commercial corridors.

19
20 Section 3. Article 8 of the Health Code is hereby amended by revising Sections 412
21 and 440.5, to read as follows:

22 **SEC. 412. WIRE SCREENS, ETC., IN PLACES WHERE FOOD IS SOLD.**

23 It shall be unlawful for any person, firm, association, or corporation engaged in
24 maintaining, conducting, carrying on, or managing a restaurant place, kitchen, meat market,
25 fruit store, vegetable store, delicatessen store, bakery store, street vendor's store, or any

1 other place in which or where food is prepared, sold, or disposed of for human consumption,
2 to maintain, conduct, carry on, or manage said place or store, except in the manner provided
3 for in this Section 412.

4 It shall be unlawful for any person, firm, association, or corporation to maintain,
5 conduct, carry on, or manage a restaurant place or kitchen where foodstuffs are cooked, or
6 prepared, ~~sold or disposed of~~ for human consumption, unless the doors, windows, apertures, or
7 other openings to the ~~premises or~~ place where ~~said restaurant or kitchen is conducted, maintained,~~
8 ~~carried on or managed~~ food preparation occurs are effectively enclosed with finely woven wire
9 mesh screens. Dining areas and bars are not required to be enclosed, provided that no food
10 preparation occurs there other than adding ingredients to a beverage or dispensing into a serving
11 container when the beverage is prepared for immediate service in response to an individual consumer
12 order.

15 **SEC. 440.5. TOILET AND HANDWASHING FACILITIES TO BE PROVIDED.**

16 (a) Every ~~food establishment~~ permanent food facility, as defined in Section ~~27520113849~~ of
17 the California Health and Safety Code, must provide toilet and handwashing facilities for use
18 by employees. ~~Every such establishment as to which construction or substantial reconstruction or~~
19 ~~rehabilitation is commenced on or after September 1, 1986, selling food for the purpose of immediate~~
20 ~~consumption without the reasonable expectation of further preparation or addition to other foods, shall~~
21 ~~make such toilet and handwashing facilities available for use by patrons without charge and.~~ Every
22 permanent food facility shall provide clean toilet facilities in good repair for consumers, guests, or
23 invitees if there is onsite consumption of food or if the permanent food facility was constructed after
24 July 1, 1984, and has more than 20,000 square feet of floor space. In addition, such toilet facilities
25 shall comply with the Plumbing Code of the City and County of San Francisco.

1 ~~(b) Provisions of this Section shall not apply to roadside stands, food establishments which~~
2 ~~are open to outside air or businesses which primarily sell at retail, meat, poultry and their by products.~~

3 **(b)** For purposes of this Section 440.5, "onsite consumption of food" means the
4 consumption of food, provided by a permanent food facility to patrons or guests, at or within the facility
5 or within an area operated or controlled by the facility. A permanent food facility that does not offer
6 onsite consumption of food may not have on its premises any dining tables, dining chairs, dining
7 counters, or dining standing-tables.

8
9 Section 4. The Planning Code is hereby amended by revising Sections 102, 445.2,
10 145.4, 186, 303.1, 703, 710, ~~744~~, 712, 713, 714, 719, 721, 728, 754, ~~757, 758~~, 759, 760, 764,
11 780.3, and 781.9, to read as follows:

12 **SEC. 102. DEFINITIONS.**

13 * * * *

14 ~~**Amusement Game Arcade.** A Retail Entertainment Arts and Recreation Use that provides eleven or~~
15 ~~more amusement game devices such as video games, pinball machines, or other such similar~~
16 ~~mechanical and electronic amusement devices, in a quantity which exceeds that specified in Section~~
17 ~~1036.23 of the Police Code as an Ancillary Use. Mechanical amusement devices are further regulated~~
18 ~~in Sections 1036 through 1036.24 of the Police Code.~~

20 **Arts Activities.** A retail Entertainment, Arts and Recreation Use that includes performance,
21 exhibition (except exhibition of films), rehearsal, production, post-production and some
22 schools of any of the following: Dance, music, dramatic art, film, video, graphic art, painting,
23 drawing, sculpture, small-scale glassworks, ceramics, textiles, woodworking, photography,
24 custom-made jewelry or apparel, and other visual, performance, and sound arts and craft. It
25 shall exclude accredited Schools and Post-Secondary Educational Institutions. It shall include

1 commercial arts and art-related business service uses including, but not limited to, recording
2 and editing services, small-scale film and video developing and printing; titling; video and film
3 libraries; special effects production; fashion and photo stylists; production, sale, and rental of
4 theatrical wardrobes; and studio property production and rental companies. Arts spaces shall
5 include studios, workshops, archives, and theaters, and other similar spaces customarily used
6 principally for arts activities, exclusive of a Movie Theater, ~~Amusement Game Arcade~~ arcades that
7 provide eleven or more amusement game devices, Adult Business, and any other establishment
8 where liquor is customarily served during performances.

9 * * * *

10 **Bar.** A Retail Sales and Service Use that provides on-site alcoholic beverage sales for
11 drinking on the premises, including bars serving beer, wine, and/or liquor to the customer
12 where no person under 21 years of age is admitted (with Alcoholic Beverage Control [ABC]
13 license types ~~02~~, 23, 42, 48, or 61) ~~and~~, drinking establishments serving beer where minors
14 are present (with ABC license types 40 or 60) in conjunction with other uses such as Movie
15 Theaters and General Entertainment, and bars serving wine operated by licensed
16 winegrowers (with ABC license type 02). Such businesses shall operate with the specified
17 conditions in Section 202.2(a). A non-profit theater that provides on-site alcoholic beverage sales
18 only for consumption by ticket-holding patrons on the premises, with ABC license type 64, shall not be
19 considered a Bar use.

20 * * * *

21 **Bona Fide Eating Place.** A place that is regularly and in a bona fide manner used and kept
22 open for the service of meals to guests for compensation and that has suitable kitchen
23 facilities connected therewith, containing conveniences for cooking of an assortment of foods
24 that may be required for ordinary meals.

1 (a) "Meals" shall mean an assortment of foods commonly ordered at various hours of the
2 day for breakfast, lunch, or dinner. Incidental food service, comprised only of appetizers to
3 accompany drinks, is not considered a meal. Incidental, sporadic, or infrequent sales of meals
4 or a mere offering of meals without actual sales is not compliance.

5 (b) "Guests" shall mean persons who, during the hours when meals are regularly served
6 therein, come to a bona fide public eating place for the purpose of obtaining, and actually
7 order and obtain at such time, in good faith, a meal therein. Nothing in this section, however,
8 shall be construed to require that any food be sold or purchased with any beverage.

9 (c) Actual and substantial sales of meals are required, during the normal days and meal
10 hours that a bona fide public eating place is open, provided that "normal days of operation"
11 shall mean a minimum of five days a week and "normal hours" of operation for meal service
12 shall mean approximately 7:00 a.m. to 11:00 a.m. if open for breakfast; 11:00 a.m. to 2:00
13 p.m. if open for lunch; or 5:00 p.m. to 10:00 p.m. if open for dinner.

14 (d) The premises must be equipped and maintained in good faith. This means the
15 premises must possess working refrigeration and cooking devices, pots, pans, utensils, table
16 service, condiment dispensers, menus, signs, and enough goods to make substantial meals.
17 The premises must comply with all regulations of the Department of Public Health.

18 (e) A minimum of 51 percent of the restaurant's gross receipts shall be from food sales
19 prepared and sold to guests on the premises. Records of the restaurant's gross receipts shall
20 be provided to the Department upon request.

21 (f) A "bona fide eating place" does not include an Adult Business as defined in this Section
22 of the Code.

23 ~~(g) Paragraphs (c) and (e) above do not apply to~~ For a place that has also established a
24 Nighttime Entertainment Use and that only provides on-site alcoholic beverage sales for
25 consumption by ticket-holding patrons on the premises during the normal hours of operation

1 of entertainment activities., paragraphs (c) and (e) do not apply, but actual and
2 substantial sales of meals are required during the normal hours of operation. For
3 purposes of this paragraph, the “normal hours of operation” shall include two hours prior to,
4 and one hour after, entertainment activities, but may not exceed eight total hours in a calendar
5 day. This paragraph (g) does not apply to a place located in the Broadway
6 Neighborhood Commercial District, North Beach Neighborhood Commercial District,
7 Pacific Avenue Neighborhood Commercial District, or Polk Street Neighborhood
8 Commercial District.

9 * * * *

10 **Entertainment, General.** A Retail Entertainment, Arts and Recreation Use that provides
11 entertainment or leisure pursuits to the general public including dramatic and musical
12 performances where alcohol is not served during performances, arcades that provide eleven or
13 more amusement game devices (such as video games, pinball machines, or other such similar
14 mechanical and electronic amusement devices), billiard halls, bowling alleys, skating rinks, and
15 mini-golf, when conducted within a completely enclosed building, and which is adequately
16 soundproofed or insulated so as to confine incidental noise to the premises. Mechanical
17 amusement devices are further regulated in Sections 1036 through 1036.24 of the Police Code.

18 * * * *

19 **Entertainment, Arts and Recreation Use.** A Use Category that includes ~~Amusement Game~~
20 ~~Arcade~~, Arts Activities, General Entertainment, Livery Stables, Movie Theater, Nighttime
21 Entertainment, Open Recreation Area, Outdoor Entertainment, Passive Outdoor Recreation
22 and Sports Stadiums. Adult Business is not included in this definition, except for the purposes
23 of Development Impact Fee Calculation as described in Article 4.

1 **Restaurant.** A Retail Sales and Service use that serves prepared, ready-to-eat cooked foods
 2 to customers for consumption on the premises and which has seating. As a minor and
 3 incidental use, it may serve such foods to customers for off-site consumption. It may provide
 4 on-site beer, wine, and/or liquor sales for drinking on the premises (with ABC license types 02,
 5 23, 41, 47, 49, 59, ~~or~~ 75, or 87); however, if it does so, it shall be required to operate as a
 6 Bona Fide Eating Place. It is distinct and separate from a Limited-Restaurant. Such
 7 businesses shall operate with the specified conditions in Section 202.2(a)(1). It shall not be
 8 required to operate within an enclosed building so long as it is also a Mobile Food Facility. A
 9 business that is both a Restaurant use and a Nighttime Entertainment use shall not be
 10 required to operate as a Bona Fide Eating Place. Any associated outdoor seating and/or
 11 dining area is subject to regulation as an Outdoor Activity Area as set forth elsewhere in this
 12 Code.

1 **SEC. 186. EXEMPTION OF LIMITED COMMERCIAL AND INDUSTRIAL**
2 **NONCONFORMING USES IN RH, RM, RTO, AND RED DISTRICTS.**

3 The purpose of this Section 186 is to provide for the further continuance in RH, RM,
4 RTO, and RED Districts of nonconforming uses of a limited commercial and industrial
5 character, as herein described, which are beneficial to, or can be accommodated within, the
6 residential areas in which they are located. It is hereby found and declared that, despite the
7 general incompatibility of nonconforming uses with the purposes of this Code, and with other
8 nearby uses, these limited commercial uses may be tolerated in residential areas, and tend to
9 provide convenience goods and services on a retail basis to meet the frequent and recurring
10 needs of neighborhood residents within a short distance of their homes or, within the South of
11 Market RED Districts, tend to provide jobs and continuation of small scale service and light
12 industrial activities. These uses tend to be small in scale, to serve primarily a walk-in trade,
13 and cause a minimum of interference with nearby streets and properties. Accordingly, this
14 Section recognizes the public advantages of these uses and establishes conditions for their
15 continued operation.

16 (a) **Exemption from Termination Provisions.** The following nonconforming uses in R
17 Districts shall be exempt from the termination provisions of Section 185, provided such uses
18 comply with all the conditions specified in subsection (b) below:

19 (1) Any nonconforming use at any Story in an RTO, RH₁ or RM District which is located
20 more than one-quarter of one mile~~300 feet one-fourth mile~~ from the nearest Named
21 Neighborhood Commercial District ~~or Restricted Use Subdistrict~~ described in Article 7 of this
22 Code **or any of the Restricted Use Subdistricts specified in subsection (3) below**, and
23 which complies with the use limitations specified for the First Story and below of an NC-1
24 District, as set forth in Section 710 of this Code.

1 (2) Any nonconforming use in an RTO, RH, or RM District which is located within one-
2 quarter of one mile~~300 feet one-fourth mile~~ from any Individual Area Neighborhood
3 Commercial District ~~or restricted use subdistrict~~ **or any of the Restricted Use Subdistricts**
4 **specified in subsection (3) below** and which complies with the most restrictive use
5 limitations specified for the First Story and below of:

6 (A) an NC-1 District, as set forth in Section 710 of this Code; or

7 (B) ~~any~~ the nearest Named Neighborhood Commercial District within one-quarter of
8 one mile~~300 feet one-fourth mile~~ of the use, as set forth in Sections 714 through 748 and 753
9 through 764 of this Code; ~~or~~ or

10 ~~— (C) Any Restricted Use Subdistrict within one-fourth mile of the use, as set forth in Sections 781~~
11 ~~through 781.7 of this Code.~~

12 **(C) Any of the specified Restricted Use Subdistricts specified in subsection (3)**
13 **below.**

14 **(3) Subsections (a)(1) and (a)(2) above apply to the following Restricted Use**
15 **Subdistricts: the Geary Boulevard Formula Retail Pet Supply Store and Formula Retail**
16 **Eating and Drinking Subdistrict set forth in Section 781.4 of this Code; the North Beach**
17 **Financial Service, Limited Financial Service, and Business or Professional Service**
18 **Subdistrict set forth in Section 781.6 of this Code; the Lower Polk Street Alcohol**
19 **Restricted Use District set forth in Section 788 of this Code; and the Third Street**
20 **Formula Retail Restricted Use District set forth in Section 786 of this Code; and the**
21 **Mission Street Formula Retail Restaurant Subdistrict as set forth in Section 781.5 of**
22 **this Code.**

23 **(34)** In the RE81.5 Districts, any nonconforming use which is a personal service use
24 falling within zoning category 816.31; home and business service use falling within zoning
25 categories 816.42 through 816.47; live/work unit falling within zoning category 816.55;

1 wholesale sales, storage, or light manufacturing uses falling within zoning categories 816.64
2 through 816.67.

3 (b) **Conditions on Limited Nonconforming Uses.** The limited nonconforming uses
4 described above shall meet the following conditions:

5 (1) The building shall be maintained in a sound and attractive condition, consistent with
6 the general appearance of the neighborhood;

7 (2) Any signs on the property shall be made to comply with the requirements of Section
8 606(c) of this Code for Limited Commercial uses;

9 (3) The hours during which the use is open to the public shall be limited to the period
10 between 6:00 a.m. and 10:00 p.m.;

11 (4) Public sidewalk space may be occupied in connection with the use provided that it is
12 ~~only~~-occupied only with tables and chairs as permitted by this Municipal Code;

13 (5) Truck loading shall be limited in such a way as to avoid undue interference with
14 sidewalks, or with crosswalks, bus stops, hydrants, and other public features;

15 (6) Noise, odors, and other nuisance factors shall be adequately controlled; and

16 (7) All other applicable provisions of this Code shall be complied with.

17 (c) **Formula Retail Uses.** All uses meeting the definition of "formula retail" use per Section
18 303.1 shall not be permitted except by conditional use authorization under the procedures of
19 Section 303 of this Code.

20 (d) **Street Frontage.** In addition to the requirements of Section 144 of this Code, the
21 requirements of Section 145.1(c)(6) and (7) shall apply.

22 (e) **Awnings.** Awnings are permitted, subject to the standards in Section 136.1(a) of this
23 Code. Canopies and marquees are not permitted.

24 (f) **Termination.** Any use affected by this Section 186 which does not comply with all of the
25 conditions herein specified shall be subject to termination in accordance with Section 185 at

1 the expiration of the period specified in that Section, but shall be qualified for consideration as
2 a conditional use under Section 185(e). Any such use which is in compliance with such
3 conditions at the expiration of such period but fails to comply therewith at any later date shall
4 be subject to termination when it ceases to comply with any of such conditions.

5 (g) **Reactivation.** Limited commercial uses in RH, RM, RTO, and RED Districts that have
6 been discontinued or abandoned, as defined in Section 183, may be reactivated with
7 conditional use authorization under Section 303. In approving such a use and in addition to
8 the findings required by Section 303, the Planning Commission shall find that:

9 (1) the subject space is located on or below the ground floor and was in commercial or
10 industrial use prior to January 1, 1960; and

11 (2) the proposed commercial use meets all the requirements of this ~~s~~Section 186 and
12 other applicable sections of this Code.

13 (h) **Other Applicable Provisions.** The provisions for nonconforming uses contained in
14 Sections 180 through 183 shall continue to apply to all uses affected by this Section 186,
15 except that the cost limit for structural alterations contained in Section 181(b)(4) shall not be
16 applicable thereto.

20 (c) **"Retail Sales or Service Activity or Retail Sales or Service Establishment."** For the

5 (d) **Accessory Uses.** Subject to the limitations set forth below and in Sections 204.1
6 (Accessory Uses for Dwellings in All Districts), 204.4 (Dwelling Units Accessory to Other
7 Uses), and 204.5 (Parking and Loading as Accessory Uses) of this Code, Accessory Uses as
8 defined in Section 102 shall be permitted when located on the same lot. Any Use that does
9 not qualify as an Accessory Use shall be classified as a Principal or Conditional Use unless it
10 qualifies as a temporary use under Sections 205 through 205.4 of this Code.
