4 **Ordinance authorizing the City and County of San Francisco’s Police Department to**
5 **retroactively accept and expend ARRA grant funds in the amount of \$16,562,750.00 from the**
6 **U.S. Department of Justice COPS Program for implementation of the COPS Hiring Recovery**
7 **Program (CHRP) to hire 50 new Q-2 San Francisco Police Officers, and amending the Annual**
8 **Salary Ordinance to provide for the creation of certain grant-funded positions.**

10 Be it ordained by the People of the City and County of San Francisco:

11 **Section 1. ARRA Grant-funded Positions; Amendment to FY 2009-2010 Annual Salary**

12 **Ordinance.** The hereinafter designated section and item of the Annual Salary Ordinance, FY 2009 -
13 2010 is hereby amended as follows:

21 **Section 2. Authorization to Accept and Expend Funds.**

22 This Ordinance authorizes the SF Police Department to accept and expend a grant in the amount of
23 \$16,562,750.00. The San Francisco Police Department having primary law enforcement duties to serve
24 and protect the City & County of San Francisco desires to expand their community policing capacity

1 and crime prevention efforts by accepting funds from the U.S. Department of Justice COPS Hiring
2 Recovery Program (CHRP) for the purpose of hiring 50 Q-2 sworn SF Police Officers; and,

3 Be it ordained, The Board of Supervisors hereby authorizes the SF Police Department to accept
4 and expend grant funds to expand their community policing capacity and crime prevention effort by
5 accepting funds from the U.S. Department of Justice COPS Hiring Recovery Program (CHRP) for the
6 purpose of hiring 50 sworn SF Police Officers; therefore, be it,

7 ORDAINED, That the Chief of Police for the City and County of San Francisco is authorized
8 on behalf of the City and County of San Francisco to accept and expend funding for DOJ’s COPS
9 Program in the amount of \$16,562,750.00 for 50 Q-2 Police Officer positions for 36 months with the
10 stipulation the SFPD will retain for one year all sworn officer positions after the 36 months are
11 completed. These retained CHRP-funded SF Police Officer positions will be added to the SF Police
12 Department’s budget and will be retained, over and above the number of locally-funded sworn officer
13 positions that would have existed in the absence of the grant. To the extent possible, all data should
14 come from a publicly verifiable source, and documentation will be provided to the COPS Office as
15 requested.
