3 **RESOLUTION AUTHORIZING THE MAYOR'S OFFICE OF EMERGENCY SERVICES TO**
4 **ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$251,674 FROM THE**
5 **CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FOR EMERGENCY**
6 **RESPONSE EQUIPMENT.**

8 WHEREAS, the City and County of San Francisco emergency response agencies
9 require specialized equipment to respond to potential terrorist attacks using weapons of mass
10 destruction; and,

11 WHEREAS, The United States Department of Justice, Office of Justice Programs, is
12 providing financial assistance for the purchase of such specialized equipment through the
13 State Domestic Preparedness Equipment Program; and,

14 WHEREAS, The California Governor's Office of Emergency Services has been
15 delegated responsibility for the administration of these funds within California and grant funds
16 are available from the Governor's Office of Emergency Services for emergency response
17 equipment; and,

18 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
19 therefore, be it

20 RESOLVED, That the Board of Supervisors hereby authorizes the Director of the
21 Mayor's Office of Emergency Services to accept and expend a State Domestic Preparedness
22 Equipment Program grant of up to \$251,674 from the California Governor's Office of
23 Emergency Services to fund the purchase of emergency response equipment for the City and
24 County of San Francisco; and be it

6 applicable grant application; and be it


7 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
