

1 [Accept and Expend Federal Grant for Sheriff's Department program providing a mentoring
2 component to augment the life skills program for violent offenders.]

3 **Resolution authorizing the Sheriff's Department: to accept and expend a grant in the**
4 **amount of \$110,000 from the U.S. Department of Education for providing a mentoring**
5 **program to violent offenders.**

7 WHEREAS, the U.S. Department of Education has made available funding through the
8 Life Skills for Prisoners Program; and,

9 WHEREAS, Due to the need for increased need to support prisoners in successfully
10 reentering the community upon release, the Sheriff's Department will provide a mentoring
11 component for violent offenders; and,

12 WHEREAS, An original grant of \$1,259,470 to the Sheriff's Department was approved
13 by the Board of Supervisors as Resolution No. 1035-00 on December 15, 2000;

14 WHEREAS, The original grant identifies non-federal funds of \$1,022,868; and,

15 WHEREAS, The original grant includes provision for indirect costs of \$70,842; and,

16 WHEREAS, the Sheriff's Department proposes to maximize use of additional available
17 grant funds on program expenditures by not including indirect costs in the grant budget; now,
18 therefore, be it


19 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
20 the additional grant budget; and be it

21 FURTHER RESOLVED, That a grant award notification has been received from the
22 U. S. Department of Education; and be it

1 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
2 Francisco authorizes the Sheriff's Department to accept and expend an additional \$110,000 in
3 grant funds from the U. S. Department of Education; and, be it

4 FURTHER RESOLVED, That the City and County of San Francisco will adhere to all
5 conditions specified in the grant agreement.
