1 AUTHORIZING THE DEPARTMENT OF HUMAN SERVICES TO ACCEPT AND EXPEND
2 A GRANT IN THE AMOUNT OF \$9,031,759 FROM THE U.S. DEPARTMENT OF
3 HOUSING AND URBAN DEVELOPMENT FOR STEWART B. MCKINNEY SUPPORTIVE
4 HOUSING PROGRAM.

5 WHEREAS, Under the Stewart B. McKinney Homeless Assistance
6 Act as amended, San Francisco is eligible to receive funds under
7 the Supportive Housing Program (SHP) from the U.S. Department of
8 Housing and Urban Development; and

9 WHEREAS, The U.S. Department of Housing and Urban Development
10 has announced the awarding of six SHP grants to the City & County
11 of San Francisco totaling \$9,031,759 to fund programs to reduce
12 homelessness in San Francisco; and

13 WHEREAS, The Department of Human Services is the authorized
14 administrator of the SHP grants and has prepared an Expenditure
15 Schedule for use of the SHP grants; and \$216,083 be allocated for
16 use as indicated on the Department of Human Services Expenditure
17 Schedule; and

18 WHEREAS, The grant terms prohibit including indirect costs in
19 the grant budget; now, therefore, be it


20 RESOLVED, That Department of Human Services is hereby


