2 RESOLUTION DETERMINING THAT THE ISSUANCE OF A TYPE 48 ON-SALE
3 GENERAL PUBLIC PREMISES LIQUOR LICENSE IN EXCHANGE FOR A TYPE 47
4 ON-SALE GENERAL EATING PLACE LIQUOR LICENSE TO CURTIS POST, FOR
5 THE OCCIDENTAL GRILL CIGAR CLUB, LLC LOCATED AT 471 PINE STREET, WILL
6 SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE
7 CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION

11 WHEREAS, Curtis Post is seeking issuance of a Type 48 on-sale general public
12 premises liquor license in exchange for a Type 47 on-sale general eating place liquor
13 license for The Occidental Grill Cigar Club, LLC, located at 471 Pine Street; and,

14 WHEREAS, The City Planning Department has verified that the area is properly
15 zoned; and

16 WHEREAS, The Police Department recommends that the liquor license
17 application be approved with conditions; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business
19 and Professions Code, the Board of Supervisors of the City and County of San
20 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48
21 on-sale general public premises liquor license in exchange for a Type 47 on-sale
22 general eating place liquor license, to Curtis Post for The Occidental Grill Cigar Club,
23 LLC, located at 471 Pine Street will serve the public convenience and necessity of the
24 people of the City and County of San Francisco.

1 Conditions: 1) Sales, service and consumption of alcoholic beverages shall be
2 permitted only between the hours of 11:30 a.m. and 12:00 midnight each day of the
3 week. 2) The petitioner shall be responsible for maintaining free of litter the area in
4 front of and adjacent to the premises over which they have control.




