

1 [Contract Approval - Brookville Equipment Corporation - Rehabilitation of 16 President's
2 Conference Committee Historic Streetcars - Not to Exceed \$34,482,428]

3 **Resolution approving a contract with Brookville Equipment Corporation for the**
4 **rehabilitation of 16 President's Conference Committee Historic Streetcars and related**
5 **tools, training, and spare parts in an amount not to exceed \$34,482,428 and for a term**
6 **not to exceed six years, to commence following Board approval.**

8 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) operates
9 the Municipal Railway (Muni), which has 32 President's Conference Committee (PCC)
10 streetcars in revenue service 21 hours per day, 365 days a year; and

11 WHEREAS, 16 of the 32 PCCs have reached the end of their useful life, as they have
12 been in revenue service since they were acquired from the Southeastern Pennsylvania
13 Transportation Authority (SEPTA) and rehabilitated by the SFMTA in 1993; and

14 WHEREAS, On April 5, 2013, the SFMTA issued a Request for Proposals ("RFP") for
15 Contract No. 660, Complete Rehabilitation of 16 PCC Historic Streetcars and received four
16 proposals in response to the RFP; and

17 WHEREAS, After reviewing the proposals and conducting oral interviews, the selection
18 committee ranked Brookville Equipment Corporation as the highest qualified proposer; and

19 WHEREAS, On May 20, 2014, the SFMTA Board of Directors adopted Resolution No.
20 14-077, which authorized the Director of Transportation of the SFMTA to execute Contract
21 No. CPT 660 with Brookville Equipment Corporation, for an amount not to exceed
22 \$34,482,428, and a term not to exceed six years; and

23 WHEREAS, A copy of the said contract is on file with the Clerk of the Board of
24 Supervisors in File No. 140655, which is hereby declared to be part of this motion as if set
25 forth fully herein; now, therefore, be it

1 RESOLVED, That the Board of Supervisors authorizes the SFMTA to enter into a
2 contract with Brookville Equipment Corporation to completely rehabilitate 16 PCC historic
3 streetcars for an amount not to exceed \$34,482,428, and for a term not to exceed six years;
4 and, be it

5 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
6 by all parties the SFMTA shall provide the final contract to the Clerk of the Board for inclusion
7 into the official file.
