4 **grant in the amount of \$125,000 from the Annie E. Casey Foundation to support**
5 **juvenile justice reform activities at the Juvenile Probation Department.**

7 WHEREAS, The Annie E. Casey Foundation has made available funding for activities
8 and technical assistance that will advance the principles of the Juvenile Detention Alternatives
9 Initiative (J.D.A.I.) benefiting the Juvenile Probation Department of the City and County of San
10 Francisco; and

11 WHEREAS, Due to the need for the development of strategies, practices and detention
12 alternative programming, the Juvenile Probation Department will seek and develop
13 commensurate in-service training curricula, sponsor meetings and retreats of the J.D.A.I.
14 collaborative, and facilitate parent, youth advisory group development; and,

15 WHEREAS, The Juvenile Probation Department will use a portion of the grant funds to
16 hire a project coordinator (1842) at 0.75 FTE for nine months to develop strategies and
17 practices that will support the implementation of a comprehensive plan designed to address
18 the disproportionate representation of minority youth in the juvenile justice system and
19 produce better outcomes for Juvenile Probation Department involved youth over time; and

20 WHEREAS, the Juvenile Probation Department has been selected to receive an
21 unconditional, unrestricted grant in the amount of \$125,000 from the Annie E. Casey
22 Foundation; now, therefore, be it

23 RESOLVED, That the Juvenile Probation Department of the City and County of San
24 Francisco is authorized to enter into the attached grant award agreement on behalf of the
25 City; and, be it




