

1 [Expansion of NextBus Notification Signs Pilot Program]

2 URGING THE BUDGET CONFERENCE COMMITTEE OF THE CALIFORNIA LEGISLATURE
3 TO ALLOCATE \$300,000 TO EXPAND THE NEXTBUS NOTIFICATION SIGNS PILOT
4 PROGRAM.

5 WHEREAS, The NextBus Notification Signs system utilizes global
6 positioning satellites and cellular transmitters to give riders an
7 accurate estimated time of arrival for Muni metro streetcars; and,

8 WHEREAS, A NextBus Notification Signs Pilot Program has been
9 implemented on the underground J,K,L,M & N lines; and,

10 WHEREAS, NextBus has improved streetcar service by reducing
11 bunching of cars and allowing Muni to identify problems with the
12 system and has improved rider satisfaction; and,

13 WHEREAS, An expansion of the Pilot Program to all routes of
14 above ground MUNI streetcars has been proposed; and,

15 WHEREAS, If the proposed expansion is approved, there will be
16 screens near all bus stops informing riders of streetcar schedules;
17 and,

18 WHEREAS, The proposed augmentation to the NextBus Pilot Program
19 will cost \$300,000; now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County
21 of San Francisco urges the Budget Conference Committee of the
22 California Legislature to allocate \$300,000 to expand the NextBus
23 Notification Signs Pilot Program; and be it

24 FURTHER RESOLVED, That a copy of this resolution be forwarded to
25 his Honor, the Mayor, with a request that he transmit copies to the

1 members of the Budget Conference Committee of the California
2 Legislature, with a request that they fund the expansion of the
3 NextBus Notification Signs Pilot Program.
