4 **public premises license to Mikhail Brodsky for Pectopah, LLC, located at 748**
5 **Innes Avenue (District 10), will serve the public convenience and necessity of the**
6 **City and County of San Francisco, in accordance with California Business and**
7 **Professions Code, Section 23958.4, and recommending that the California**
8 **Department of Alcoholic Beverage Control impose conditions on the issuance of**
9 **the license.**

11 WHEREAS, Mikhail Brodsky is seeking the issuance of a Type 42 on-sale beer
12 and wine public premises license for Pectopah, LLC, located at 748 Innes Avenue; and,

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval; and,

15 WHEREAS, The Police Department has filed no protests with the Department of
16 Alcoholic Beverage Control under California Business and Professions Code, Section
17 24013, and recommends that the Department of Alcoholic Beverage Control issue the
18 liquor license with conditions; and

19 WHEREAS, The conditions recommended by the Police Department are: 1)
20 Sales, service and consumption of alcoholic beverages shall be permitted between the
21 hours of 10:00 am to Midnight each day of the week; 2) The sale of alcoholic beverages
22 for off-sale consumption is strictly prohibited; 3) The petitioner(s) shall be responsible
23 for maintaining free of litter the area adjacent to the premises over which they have
24 control; 4) Loitering (loitering is defined as "to stand idly about; linger aimlessly without

1 lawful business") is prohibited on any sidewalks or property adjacent to the licensed
2 premises under the control of the licensee as depicted on the ABC-257; 5) Graffiti shall
3 be removed from the premises and all parking lots under the control of the licensee
4 within 72 hours of application. If the graffiti occurs on a Friday or weekend day, or on a
5 holiday, the licensee shall remove the graffiti within 72 hours following the beginning of
6 the next week day; 6) The exterior of the premises shall be equipped with lighting of
7 sufficient power to illuminate and make easily discernible the appearance and conduct
8 of all persons on or about the premises. Additionally, the position of such lighting shall
9 not disturb the normal privacy and use of any neighboring residences; 7) No noise shall
10 be audible beyond the area under the control of the licensee as defined on the ABC-
11 257; and 8) The interior lighting maintained therein shall be sufficient to make easily
12 discernible the appearance and conduct of all persons and patrons in that portion of the
13 premises where alcoholic beverages are sold, served, delivered or consumed; now,
14 therefore, be it

15 RESOLVED, That in accordance with California Business and Professions Code,
16 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
17 hereby determines for the foregoing reasons that the issuance of a Type 42 on-sale
18 beer and wine public premises license for Pectopah, LLC, located at 748 Innes Avenue,
19 will serve the public convenience or necessity of the City and County of San Francisco;

21 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
22 San Francisco hereby endorses and adopts the recommendations of the Police

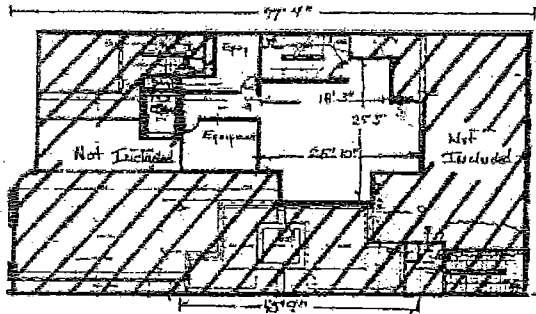

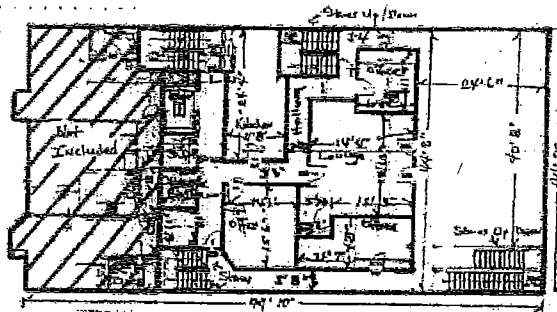

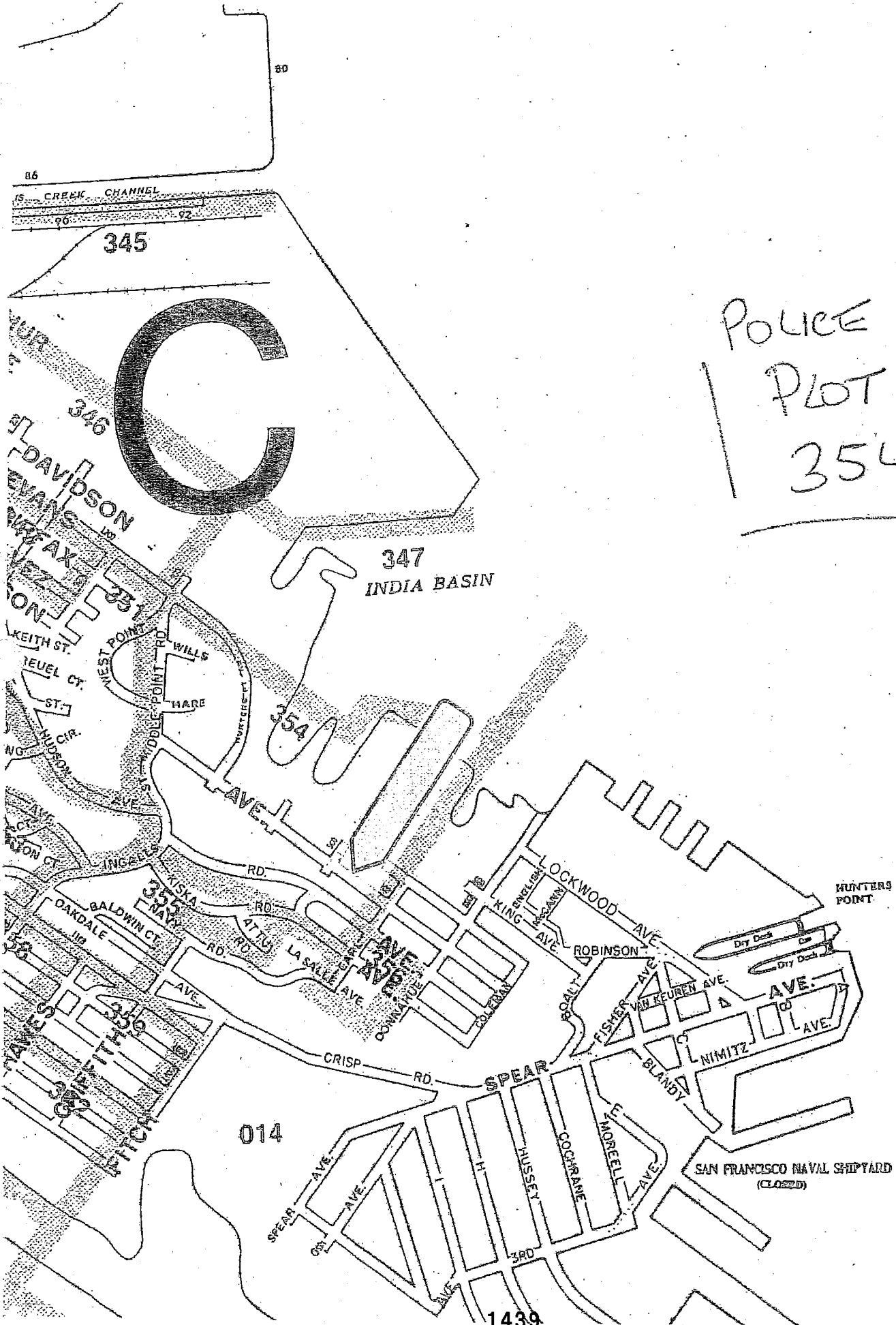

On behalf of PECTOPAH LLC I am asking for your support of our application for ABC License Type 42—On Sale Beer and Wine Public Premises. We plan to operate at 748 Innes Ave., #100, San Francisco, CA 94124 during Sundays through Saturdays from 10 am through midnight.


PECTOPAH LLC is a venue for spa and sauna lovers located in close associations with Archimedes Banya LLC and located in the same building. Archimedes Banya LLC is the first community bathing complex in San Francisco that follows Russian and German bathing traditions (banya - thermen). It provides different types of saunas and seam rooms, hot tubs, Jacuzzis, pools, massages, skin treatments and etc. About 150,000 of Russian speaking and 120,000 of German speaking people living in the Bay Area have been eagerly waiting for this sauna complex development for 13 years. It received more than eight thousand visits during the first 8 months of its operations. The thermal treatments require long (about 30 minutes) resting breaks between them. During these breaks people meet at PECTOPAH for social interaction and rest. Drinking beer is an integral part of the tradition and is the only thing that is still missing in our operations. Beer and wine will be sold to Archimedes visitors only, the venue is located past the banya entry.

Our premises are located in a separate detached building in an area near the entrance to former Hunters Point Shipyard. This is the first public business in the area which was considered dangerous and unsafe by many people of San Francisco and the Bay Area. We bring a lot of new people to the area and are re-establishing an improved reputation to the neighborhood. The popularity of the area is growing and this is important due to the future development of Hunters Point. The local population appreciates our effort to bring life to and security to the area (we have a guard outside our premises). During the 8 months of operation we have never had any incidents or conflicts with the neighbors or police.

Beer consumption is very important for the thermal bathing tradition. In addition to its relaxing qualities, it is an effective form of re-hydration following loss of liquid due to sweating. Russian and German populations of the Bay Area will be very thankful for your support. We believe that Archimedes Banya and PECTOPAH will become a signature destination among the attractions of San Francisco.
