11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. The Planning Department has determined that the actions contemplated in  
13 this ordinance comply with the California Environmental Quality Act (California Public  
14 Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the  
15 Board of Supervisors in File No. 130285 and is incorporated herein by reference.



**LEGISLATIVE DIGEST**

[Public Works Code - Waiver of Temporary Street Space Occupancy Fee for Small Business Week Sidewalk Sales]

**Ordinance waiving the fee required by Public Works Code, Section 724.1(b), for temporary street space occupancy within certain designated streets in the City and County of San Francisco on Saturday, May 11, 2013, and Saturday May 18, 2013, as part of Small Business Week Sidewalk Sales.**

Existing Law

Currently, Public Works Code Section 724.1(b) requires a fee for a temporary street occupancy permit.

Amendments to Current Law

This legislation shall waive the permit fee on Saturday, May 11, 2013 between 7 a.m. and 9 p.m. within certain designated streets within San Francisco and Saturday, May 18, 2013 between 7 a.m. and 9 p.m. within certain designated streets within San Francisco as part of Small Business Week Sidewalk Sales. All other provisions of the Public Works Code Section 724 et seq. shall remain in full effect.
