

1 [Zoning - Extension of Planning Commission Review Period]  
2 EXTENDING THE PRESCRIBED TIME WITHIN WHICH THE PLANNING COMMISSION  
3 MAY RENDER ITS DECISION ON A PROPOSED ORDINANCE TO AMEND THE  
4 PLANNING CODE WITH RESPECT TO THE UPPER MARKET STREET NEIGHBORHOOD  
5 COMMERCIAL DISTRICT.

6 WHEREAS, On December 20, 1999, the Board of Supervisors initiated the process to  
7 amend the Municipal Code, Part II, Chapter II (Planning Code), when the Honorable Mark  
8 Leno introduced and the Honorable Gavin Newsom co-sponsored a proposed ordinance  
9 concerning the Upper Market Street Neighborhood Commercial District, a copy of which is on  
10 file with the Clerk of the Board of Supervisors in File No. 992322; and,

11 WHEREAS, On December 27, 1999, the proposed ordinance was referred to  
12 the Planning Commission, which currently is reviewing the proposed ordinance; and,

13 WHEREAS, The Zoning Administrator has requested additional time to review  
14 the proposed ordinance; and,

15 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d)  
16 may, by resolution, extend the prescribed time within which the Planning Commission is to  
17 render its decision on proposed amendments to the Planning Code initiated by the Board of  
18 Supervisors; and,

19 WHEREAS, The Board deems it appropriate in this instance to grant to the  
20 Planning Commission an additional 90 days to review the proposed ordinance and render its  
21 decision; now, therefore, be it

22 RESOLVED, That by this resolution, the Board hereby extends the prescribed  
23 time within which the Planning Commission may render its decision on the proposed  
24 ordinance concerning the Upper Market Street Neighborhood Commercial District, a copy of  
25

1 which is on file with the Clerk of the Board of Supervisors in File No. 992322, for an additional  
2 90 days.


