13 WHEREAS, The Police Department recommends the modification of Condition  
14 Number One; now, therefore, be it

17 Francisco does hereby determines that the modification of Condition Number One  
18 for Joseph M. Gilmartin, Jr, for the Black Horse London Deli, located at 1514 Union




