4 **expend a grant in the amount of \$25,000 from the Environmental Protection Agency to**
5 **provide training to municipal staff involved in construction and renovation of municipal**
6 **buildings on Leadership in Energy and Environmental Design (LEED™) sustainable**
7 **building standards and to develop a database to track municipal green building**
8 **projects and their environmental benefits to the City and County of San Francisco.**

10 WHEREAS, Based upon evaluation of responses to an Environmental Protection
11 Agency request for proposals in the area of Resource Conservation, the Department of the
12 Environment's Green Building Program was selected to be the recipient of \$25,000 in funding
13 to provide training to municipal design staff on LEED™ sustainable building standards and
14 develop a database to track municipal green building projects and their environmental benefits
15 to the City and County of San Francisco; and,

17 WHEREAS, the Department of the Environment is responsible for implementation of
18 the City and County of San Francisco's Resource Efficient Building Ordinance; and,

20 WHEREAS, training municipal staff involved in construction and renovation of
21 municipal buildings in LEED™ standards will enable the Department to achieve the goals of
22 the Resource Efficient Building Ordinance; and,

24 WHEREAS, The LEED™ system, developed by the US Green Building Council,
25 provides a definitive standard for what constitutes a green building and is rapidly gaining
national and international acceptance as a common measurement of sustainable
achievement; and,

3 County of San Francisco; now, therefore, be it


4 RESOLVED, That the San Francisco Board of Supervisors authorizes the Director of
