

1 [Apply For State Re-Use Assistance Grant]

3 **Resolution authorizing the City and County of San Francisco to apply for annual grants**
4 **from the California Integrated Waste Management Board for the purpose of conducting**
5 **activities leading to an increase of the re-use of materials that might otherwise go into**
6 **the landfill.**

8 WHEREAS, Public Resources Code *Section 42000* authorizes the California Integrated
9 Waste Management Board to conduct market development activities to strengthen demand by
10 manufacturers and end-use consumers for recyclable materials collected by municipalities,
11 nonprofit organizations, and private entities; and,

12 WHEREAS, the concept of reuse is an integrated approach, which encompasses
13 integrated waste management objectives such as building materials efficiency, construction
14 and demolition waste reduction, maximization of reused- and recycled-content building and
15 landscaping materials; and maximization of reused electronics; and,

16 WHEREAS, on November 15, 2006 the California Integrated Waste Management
17 Board approved the Scoring Criteria and Evaluation Process for the Reuse Assistance Grants
18 for Fiscal Year 2007/2008; and,

19 WHEREAS, the California Integrated Waste Management Board will enter into an
20 agreement with the Grantee for development of the project; and,

21 WHEREAS, the California Integrated Waste Management Board has been delegated
22 the responsibility for the administration of the program within the state, setting up necessary
23 procedures governing application by cities and counties under the program; and,

24 WHEREAS, the grant is a competitive grant that is available to the City and County of
25 San Francisco from the California Integrated Waste Management Board; and,

1 WHEREAS, the City and County of San Francisco has set ambitious waste diversion
2 goals and being awarded grants from the California Integrated Waste Management Board will
3 assist the City in achieving these goals; now, therefore, be it

4 RESOLVED, that the Executive Director of the Department of Telecommunications and
5 Information Services, or a designee, is hereby authorized and empowered to execute in the
6 name of the City and County of San Francisco all necessary applications, contracts, payment
7 requests, agreements and amendments hereto for the purposes of securing grant funds and
8 to implement and carry out the purposes specified in the grant application; and, be it

9 FURTHER RESOLVED, that the City and County of San Francisco authorizes the
10 submittal of an annual grant application to the California Integrated Waste Management Board
11 for all available grants under the Public Resources Code *Section 42000* and this authorization
12 shall remain in effect for five (5) years.
