3 **Resolution declaring support of AB 1000 (Ma) that would provide California workers**  
4 **with earned paid sick days.**

WHEREAS, In 2006, San Francisco voters passed Proposition F, the first such  
8 legislation in the nation, that provides all workers in the city with the ability to earn and use  
9 paid sick days; and

WHEREAS, Assembly Bill 1000, on file with the Clerk of the Board of Supervisors in  
File No. 090375, which is hereby declared to be a part of this resolution as if set forth fully  
herein; the Healthy Workplaces, Healthy Families Act of 2009, by Assembly Member Fiona  
Ma allows all California workers to earn and use paid sick days for personal illness, to care for  
a sick family member and to recover from domestic violence or sexual assault; and

WHEREAS, 6 million working Californians- 40% of all workers in California- do not  
have any paid sick days through their employer; and

WHEREAS, the lack of paid sick days is a public health concern, and harms children  
and families and workers who have no paid sick days are forced to make an impossible  
choice when they or their children become ill; and

WHEREAS, many workers who show up to work sick handle our food at restaurants  
and take care of our children at daycare centers, thereby spreading germs to co-workers and  
to the public; and

1           WHEREAS, parents who have no paid sick days either have to lose a day's pay or  
2 send their children to school sick putting other children at risk; and

3           WHEREAS, AB 1000 allows workers to earn paid sick days, which they can use for  
4 personal illness, to care for a sick family member and to recover from domestic violence or  
5 assault; and now, therefore be it

6           RESOLVED, that by the adoption of this Resolution, the City of San Francisco hereby  
7 declares SUPPORT of AB 1000 (Ma) that would provide California workers with earned paid  
8 sick days.
