[AIRPORT GRANT Accept-Expend Federal Grant]

**Resolution authorizing the Airport Commission to retroactively accept and expend funding in a total amount of \$203,000 from the Transportation Security Administration ("TSA") for the Airport K-9 Explosives Detection Team Program.**

WHEREAS, The Airport utilizes canine (K-9) teams to detect explosives at the Airport; and,

WHEREAS, The Airport K-9 Explosives Detection Team Program incurs expenses for handler salaries, handler overtime, handler uniforms (laundry), K-9 food, K-9 veterinary care (medications), K-9 kenneling, vehicles, vehicle care and maintenance, handler training/travel, and explosives training/travel; and

WHEREAS, The Airport will be reimbursed by the TSA \$203,000 for the Airport K-9 Explosives Detection Team Program expenses incurred at Airport; and

WHEREAS, The grant does not require ASO amendment, and grant terms prohibit including indirect costs in the grant budget; and


WHEREAS, The Airport Commission approved the acceptance and expenditures of the TSA K-9 Explosives Detection Team Program funds pursuant to Resolution Nos. 08-0033 and 08-0068 dated February 5, 2008 and April 1, 2008, respectively, now, therefore, be it

**RESOLVED**, That this Board of Supervisors hereby authorizes the Airport to accept and expend the TSA funding for the Airport K-9 Explosives Detection Team Program; and be it

**FURTHER RESOLVED**, That the Board of Supervisors hereby waives the inclusion of indirect costs in the grant budget.




