

1 [Accept and Expend Grant - Atlanta HQ University of California San Francisco Technical  
2 Assistance - \$13,595]

4 **Resolution authorizing the Department of Public Health to retroactively accept and**  
5 **expend a grant from the University of California San Francisco in the amount of**  
6 **\$13,595 to participate in a program entitled “Atlanta HQ UCSF Technical Assistance to**  
7 **Support President’s Emergency Plan for AIDS,” for the period of October 1, 2011,**  
8 **through March 31, 2012.**

10 WHEREAS, UCSF is the recipient of a grant award from the Centers for Disease  
11 Control and Prevention supporting the Atlanta HQ UCSF Technical Assistance to Support  
12 President’s Emergency Plan for AIDS; and

13 WHEREAS, With a portion of these funds, UCSF has subcontracted with DPH in the  
14 amount of \$13,595 for the period of October 1, 2011 through March 31, 2012; and,

15 WHEREAS, The purpose of this project is to implement a Basic-Level Data Analysis  
16 and Data Use Workshop and provide hands-on training to strengthen participants’ skill sets  
17 and capabilities to better analyze HIV related data and generate high quality factsheets for  
18 surveillance and program monitoring; and

19 WHEREAS, As a condition of receiving the grant funds, UCSF requires the City to  
20 enter into an agreement (the “Agreement”), a copy of which is on file with the Clerk of the  
21 Board of Supervisors in File No.111041; which is hereby declared to be a part of this  
22 resolution as if set forth fully herein; and

23 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
24 for one existing position, one Senior Physician Specialist (Job Class 2232) at .10 FTE, for the  
25 period of October 1, 2011 through March 31, 2012; and

1 WHEREAS, The budget includes a provision for indirect costs in the amount of \$1,457;  
2 now, therefore, be it

3 RESOLVED, That DPH is hereby authorized to accept and expend a grant in the  
4 amount of \$13,595 from UCSF; and, be it

5 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
6 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,  
7 be it

8 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
9 agreement on behalf of the City.
