

1 [Appointments, Sugary Drinks Distributor Tax Advisory Committee - Vanessa Bohm, Maysha
2 Bell, Marna Armstead, Francis Abigail Cabrera, Diana Lau, Laura Derosier, and Maureen
3 Guerrero]

4 **Motion appointing Vanessa Bohm (residency requirement waived), Maysha Bell, Marna**
5 **Armstead, Francis Abigail Cabrera, Diana Lau, Laura Derosier, and Maureen Guerrero,**
6 **terms ending December 31, 2022, to the Sugary Drinks Distributor Tax Advisory**
7 **Committee.**

9 MOVED, That the Board of Supervisors of the City and County of San Francisco does
10 hereby appoint the hereinafter designated persons to serve as members of the Sugary Drinks
11 Distributor Tax Advisory Committee, pursuant to the provisions of Administrative Code,
12 Article IV, Sections 5.20 and 5.21, for the terms specified:

13 Vanessa Bohm (residency requirement waived), Seat 1, succeeding themselves, term
14 expired, must be held by a representative of a nonprofit organization that advocates for health
15 equity in communities that are disproportionately impacted by diseases related to the
16 consumption of sugar-sweetened beverages, for a two-year term ending
17 December 31, 2022;

18 Maysha Bell, Seat 2, succeeding John Maa, term expired, must be held by a
19 representative of a nonprofit organization that advocates for health equity in communities that
20 are disproportionately impacted by diseases related to the consumption of sugar-sweetened
21 beverages, for a two-year term ending December 31, 2022;

22 Marna Armstead, Seat 3, succeeding Joi Jackson-Morgan, term expired, must be held
23 by a representative of a nonprofit organization that advocates for health equity in communities
24 that are disproportionately impacted by diseases related to the consumption of sugar-
25 sweetened beverages, for a two-year term ending December 31, 2022;

1 Frances Abigail Cabrera, Seat 4, succeeding Roberto Ariel Vargas, term expired, must
2 be an individual who is employed at a medical institution in San Francisco and who has
3 experience in the diagnosis or treatment of, or in research or education about, chronic and
4 other diseases linked to the consumption of sugar-sweetened beverages, for a two-year term
5 ending December 31, 2022;

6 Diana Lau, Seat 5, succeeding Jonathan Butler, term expired, must be an individual
7 who is employed at a medical institution in San Francisco and who has experience in the
8 diagnosis or treatment of, or in research or education about, chronic and other diseases linked
9 to the consumption of sugar-sweetened beverages, for a two-year term ending
10 December 31, 2022;

11 Laura Derosier, Seat 15, succeeding Janna Cordeiro, term expired, must be a parent
12 or guardian of a student enrolled in the San Francisco Unified School District at the time of
13 appointment, nominated by the San Francisco Unified School District's Parent Advisory
14 Council, and appointed by the Board of Supervisors, for a two-year term ending
15 December 31, 2022;

16 Maureen Guerrero, Seat 16, succeeding Derik Aoki, term expired, must be a person
17 with experience or expertise in services and programs for children five years old and under,
18 for a two-year term ending December 31, 2022; and, be it

19 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 20 1. The membership of the Sugary Drinks Distributor Tax Advisory Committee has a goal
21 to be representative of the diversity of the City and County of San Francisco.
- 22 2. Applicant Vanessa Bohm, who is not a resident of San Francisco, is a person with
23 experience that uniquely qualifies them to serve on the Sugary Drinks Distributor Tax
24 Advisory Committee.

1 3. The Sugary Drinks Distributor Tax Advisory Committee has attempted to fill the
2 position, for which Vanessa Bohm was nominated, with an individual who is City a
3 resident and who has the specific experience, skills, and qualifications, but has been
4 unable to do so at this time. The Rules Committee has certified that Vanessa Bohm is
5 qualified to serve on the Sugary Drinks Distributor Tax Advisory Committee.

6 4. After exercising due diligence, the Board of Supervisors concludes that there is no
7 other possible representatives who is a resident of San Francisco, who has the specific
8 experience, skills, or qualifications possessed by this applicant, and who is willing to
9 serve on the Sugary Drinks Distributor Tax Advisory Committee at this time; and, be it

10 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
11 for Vanessa Bohm, as is allowed in cases where no qualified City resident who is willing to
12 serve can be found, pursuant to Charter, Section 4.101(a)(2), that otherwise requires
13 person(s) appointed to boards, commissions, and advisory bodies established by legislative
14 act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
