2 EXEMPTING THE CITY HALL CHILD CARE CENTER OUTDOOR PLAY SPACE FROM THE  
3 COMPETITIVE BIDDING REQUIREMENTS OF THE SAN FRANCISCO ADMINISTRATIVE  
4 CODE.

5 Note: This entire section is new.

6 Be it ordained by the People of the City and County of San Francisco:

7 Section 1. Findings. The Board of Supervisors of the City and County of San  
8 Francisco hereby finds and declares as follows:

9 1. There is a serious shortage of high quality child care for City employees and  
10 residents located in and around the Civic Center. In order to meet that need, the City has  
11 allocated space in the lower level of City Hall, along the northern side of the building, for a  
12 Child Care Center. The City Hall Child Care Center will serve approximately 30 children,  
13 infants through preschool age. It is in the public's best interest that the Child Care Center  
14 open as quickly as possible to address the demand for high-quality child care.

15 2. In order to award a license to a child care facility, the State of California requires a  
16 safe, appropriate, outdoor play space at the site of a child care facility. The City has allocated  
17 space on the lawn on the northern side of City Hall for an outdoor play space for the City Hall  
18 Child Care Center. The City Hall Child Care Center cannot open until the outdoor play space  
19 is completed.

20 3. Through a competitive selection process, the Department of Children, Youth and  
21 Their Families, has selected Marin Day Schools, a non-profit tax-exempt agency, to operate  
22 the City Hall Child Care Center. Marin Day Schools operates many child care centers in San  
23 Francisco and throughout the Bay Area. Marin Day Schools has particular expertise in the  
24 development, design and implementation of new child care center facilities and playgrounds.  
25 Marin Day Schools has assisted the Administrative Services Office and the Department of




