4 **Najwa Inc., dba Alimento, located at 507 Columbus Avenue (District 3), will serve**

10 WHEREAS, Najwa Inc. is seeking the transfer of a Type 21 off-sale general
11 license dba Alimento located at 507 Columbus Avenue (District 3); and

12 WHEREAS, The Planning Department has verified that the area is properly
13 zoned and recommends approval; and

14 WHEREAS, The Police Department has filed zero (0) protests with the
15 Department of Alcoholic Beverage Control under California Business and Professions
16 Code, Section 24013, and recommends that the Department of Alcoholic Beverage
17 Control issue the liquor license with conditions; and

18 WHEREAS, The conditions recommended by the Police Department are the
19 following: 1) Loitering (defined as "to stand idly about; linger aimlessly without lawful
20 business") is prohibited on any sidewalks or property adjacent to the licensed premises
21 under the control of the licensee as depicted on the ABC-257, dated 4/15/2016; 2) the
22 sale, service and consumption of powdered alcohol or like non-liquid beverage based
23 product is prohibited; 3) there shall be no plastic cups, glasses, or similar disposable
24 receptacles commonly used for the drinking of beverages, sold, furnished, or given
25 away at the petitioner's premises in quantities of less than twenty-four (24) in their

1 original multi-container package; 4) no person under the age of 21 shall sell or deliver
2 alcoholic beverages; 5) the sale of distilled spirits in sizes small than 600 ml is strictly
3 prohibited; 6) the sale of beer or malt beverages in quantities of 16 oz., 22 oz., or similar
4 size containers is prohibited; and 7) no beer or malt beverage shall be sold in quantities
5 of less than the manufacturer pre-packaged six packs per sale with the exception of
6 wine-coolers, beer coolers, which must be sold in manufacturer pre-packaged multi-unit
7 quantities of four (4) or more; now, therefore, be it

8 RESOLVED, That in accordance with California Business and Professions Code,
9 Section 23958.4, the Board of Supervisors of the City and County of San Francisco
10 hereby determines for the foregoing reasons that the transfer of a Type 21 off-sale
11 general license to Najwa Co. dba Alimento located at 507 Columbus Avenue (District 3),
12 will serve the public convenience or necessity of the City and County of San Francisco;
13 and, be it

14 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
15 San Francisco hereby endorses and adopts the recommendations of the Police
16 Department listed above and recommends that the Department of Alcoholic Beverage
17 Control issue the license with those conditions.



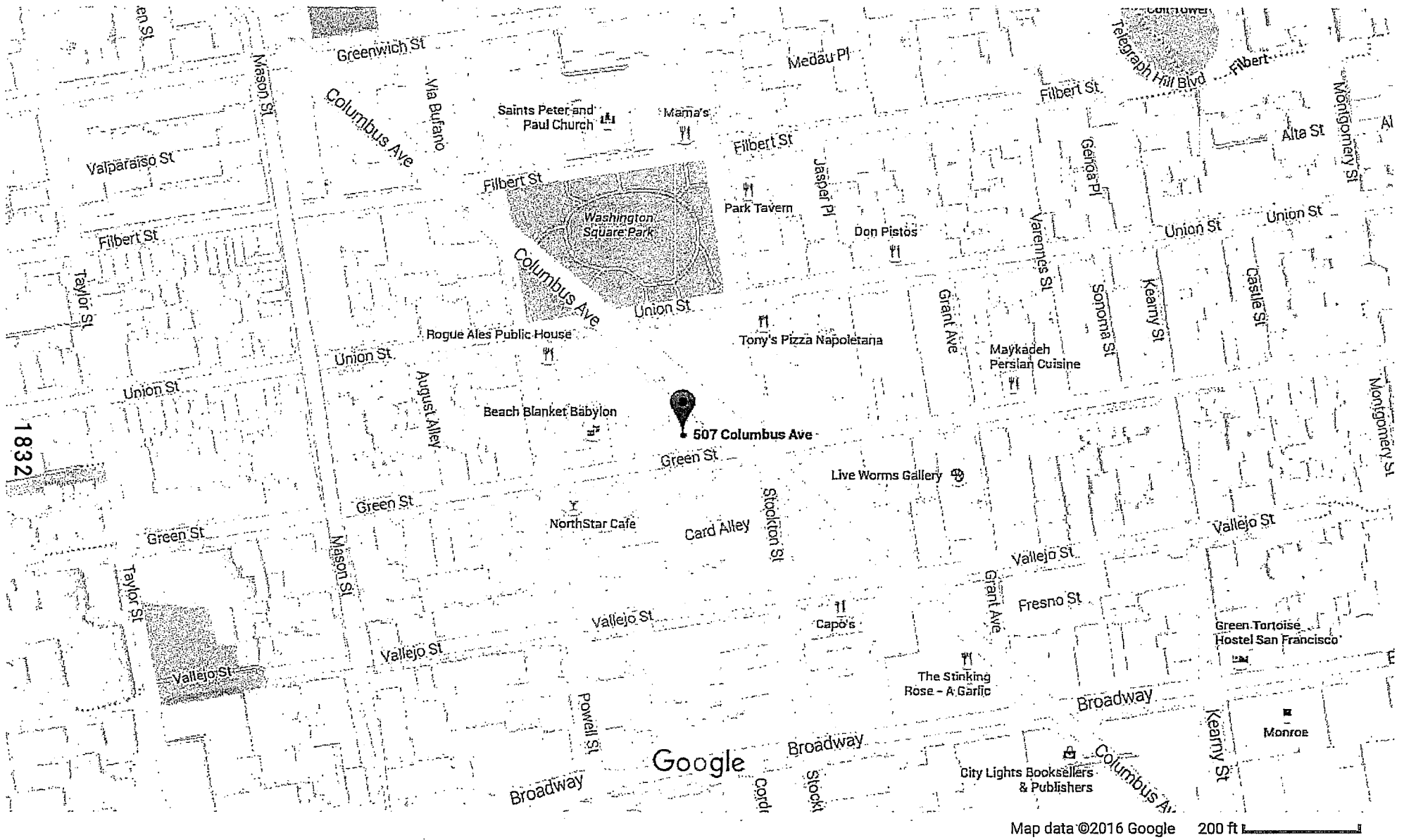

1. Loitering (loitering is defined as “to stand idly about; linger aimlessly without lawful business”) is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257, dated 4/15/2016.
2. The sale, service and consumption of powdered alcohol or like non-liquid beverage based product is prohibited
3. There shall be no plastic cups, glasses, or similar disposable receptacles commonly used for the drinking of beverages, sold, furnished, or given away at the petitioner’s premises in quantities of less than twenty-four (24) in their original multi-container package.
4. No person under the age of 21 shall sell or deliver alcohol beverages.
5. The sale of distilled spirits in sizes smaller than 600 ml is strictly prohibited.
6. The sale of beer or malt beverages in quantities of 16 oz., 22 oz., or similar size containers is prohibited.
7. No beer or malt beverage shall be sold in quantities of less than the manufacturer pre-packaged six packs per sale with the exception of wine-coolers, beer coolers

which must be sold in manufacturer pre-packaged multi-unit quantities of four (4) or more.

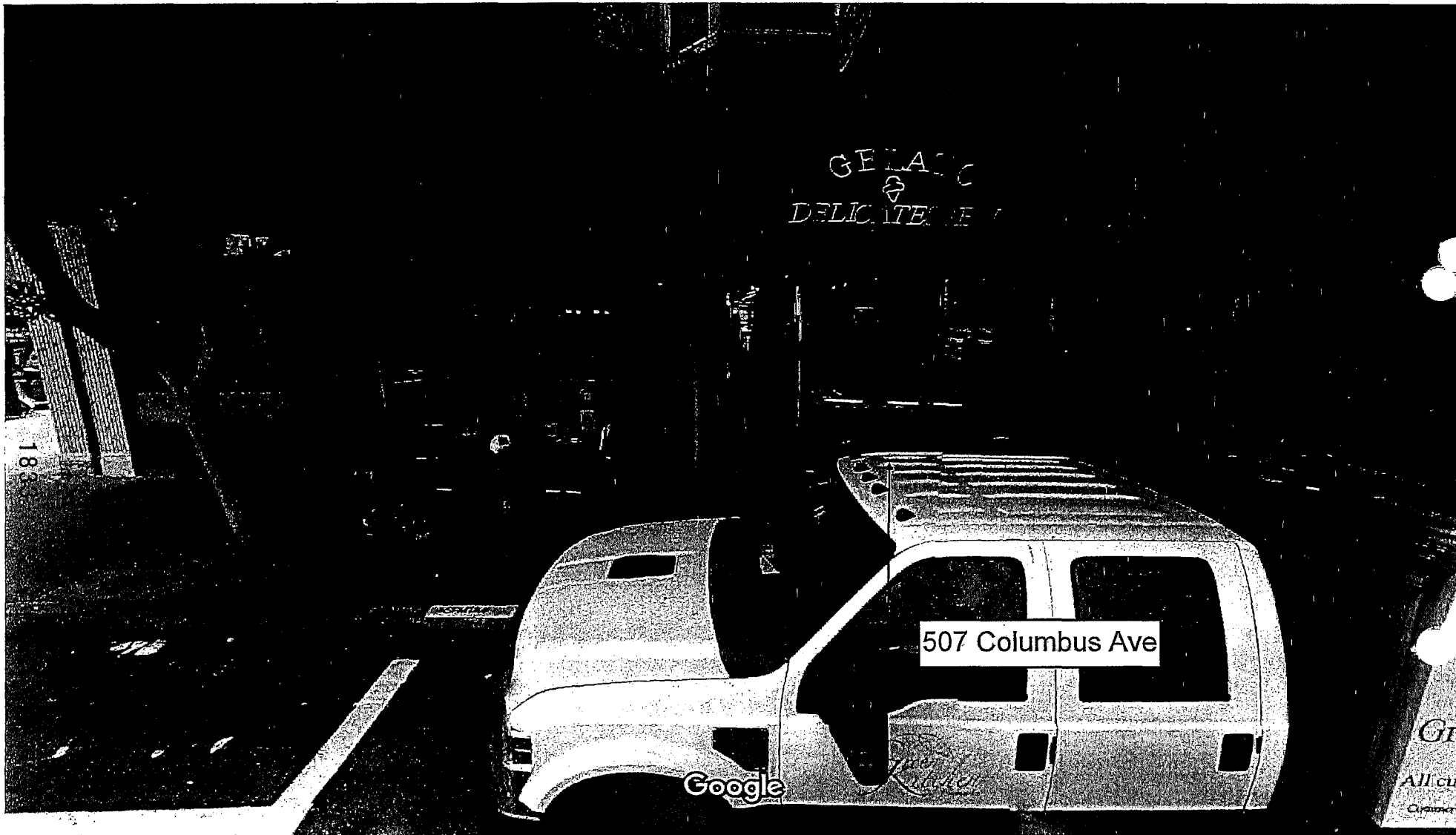


