3 **Resolution determining that the transfer of a Type 21 off-sale general alcoholic**  
4 **beverage control license from 2458 Polk Street to 2001 Polk Street to Ray Bair for**  
5 **Cheese Plus will serve the public convenience and necessity of the people of the**  
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**  
7 **California Business and Professions Code with conditions.**

9 WHEREAS, Ray Bair is seeking transfer of a Type 21 off-sale general alcoholic  
10 beverage control license for Cheese Plus located at 2001 Polk Street from 2458 Polk  
11 Street; and,

12 WHEREAS, The City Planning Department has verified that the area is properly  
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license  
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business  
17 and Professions Code, the Board of Supervisors of the City and County of San  
18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
19 off-sale general alcoholic beverage control license from 2458 Polk Street to 2001 Polk  
20 Street for Ray Bair for Cheese Plus, will serve the public convenience and necessity of  
21 the people of the City and County of San Francisco.

22 Conditions: (1) Petitioners shall not permit their patrons or the general public to  
23 loiter or congregate on the sidewalks adjacent to the licensed premises; (2) The  
24 petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the  
25 premises over which they have control; (3) Sales and service of alcoholic beverages

1 shall be permitted only between the hours of 9:00 a.m. and 9:00 p.m. each day of the  
2 week; (4) No wine shall be sold with an alcoholic content greater than 15% by volume  
3 except for "Dinner Wines" which have been aged two years or more; (5) Any beer sold  
4 with an alcoholic content greater than 3.2% by volume shall have a retail price no less  
5 than \$3.99; (6) No distilled spirits shall be sold in bottles or containers smaller than 250  
6 milliliters.




