11 WHEREAS, The San Francisco Department of Public Health (DPH) provides substance
12 use disorder services for Medi-Cal beneficiaries; and

13 WHEREAS, Oversight of these substance use disorder services is provided by the DPH
14 County Alcohol and Drug Program Administrator within DPH's Behavioral Health Services
15 branch (DPH-BHS); and

16 WHEREAS, The California Department of Health Care Services (DHCS) is responsible
17 for the administration of Medi-Cal services contracts; and

18 WHEREAS, On April 23, 2015, DCHS forwarded to the San Francisco Alcohol and Drug
19 Program Administrator a Multi-Year Contract for Substance Use Disorder Services for the term
20 of July 1, 2014, through June 30, 2017, in the amount of \$40,371,901 (Agreement); and

21 WHEREAS, DCHS requests the Agreement be signed by the Board of Supervisors or
22 their designee and submitted by the close of business on June 12, 2015; and

23 WHEREAS, DCHS requires a resolution, board minutes, order, motion, or ordinance
24 from the Board of Supervisors that specifically approves and authorizes the execution of the
25 Agreement; and



5 and losses resulting to any person, firm, or corporation who may be injured or damaged in
6 connection to the City's performance of this contract; now, therefore be it

7 RESOLVED, That DPH-BHS is hereby retroactively authorized to enter into a FYs
8 2012-2017 Substance Use Disorder Services Contract with DCHS for the term of July 1,
9 2012, through June 30, 2017, in the amount of \$40,371,901, and, be it

10 FURTHER RESOLVED, That said Agreement shall include an indemnification of the
11 State of California as set forth above; and, be it

12 FURTHER RESOLVED, That the DPH County Alcohol and Drug program
13 Administrator is hereby authorized and designated by the Board of Supervisors to sign said
14 Agreement and to approve Agreement amendments for less than ten percent (10%) of the
15 contracted amount.

MANDATE STATEMENT

City Charter Section 9.118(b) states that a contract entered into by a department, board, or commission having anticipated revenue to the City and County of San Francisco of \$1 million or more, or the modification, amendment, or termination of any contract which when entered into had anticipated revenue of \$1 million or more, shall be subject to approval of the Board of Supervisors by resolution.

BACKGROUND

Under California State law, the City and County of San Francisco (the County) is reimbursed by the California Department of Health Care Services (DHCS) for the costs associated with providing various substance abuse services. In order to receive this reimbursement, the County must enter into a Multi-Year Contract for Substance Use Disorder Services with DHCS. The contract includes pass-through funding from the State and federal governments for Drug Medi-Cal services and the Federal Substance Abuse Prevention and Treatment block grant.

The San Francisco Department of Public Health (DPH) Community Behavioral Health Services currently funds approximately 100 different substance abuse treatment and prevention programs provided by 45 community-based non-profit organizations. Counties negotiate with DHCS to determine rates for different types of substance abuse services, and these rates are then incorporated into the multi-year contract between DHCS and the County.

In February 2015, the Board of Supervisors approved the original contract between the County and DHCS to accept funding for substance abuse services. The term of the current contract is three years, commencing on July 1, 2014 and ending on June 30, 2017, for total compensation of \$33,250,026, or \$11,083,342 per year.

DETAILS OF PROPOSED LEGISLATION

The proposed resolution would retroactively authorize DPH to enter into an amended contract with DHCS to reimburse DPH for providing Substance Abuse Disorder Services to Medi-Cal beneficiaries. The amended contract increases the FY 2014-15 reimbursement amount by \$7,121,875 from \$11,083,342 to \$18,205,217, and the total contract amount from \$33,250,026 to \$40,371,901 for the three-year term from July 1, 2014 through June 30, 2017. Table 1 below shows the sources of funds for each year of the contract.

In April 2015, DHCS sent a contract amendment to DPH that reflects funding changes in FY 2014-15. The contract amendment would increase the Drug Medi-Cal Federal Share funding for FY 2014-15 from \$744,462 to \$7,866,337, an increase of \$7,121,875. The funding change is related to the expansion of eligibility for Medi-Cal, a public health insurance program for low-income Californians, which went into effect in 2014 under the Affordable Care Act. According to Mr. Jim Stillwell at DPH, there are approximately 1,000 new Medi-Cal beneficiaries in San Francisco as a result of Medi-Cal expansion. The federal government pays for 100 percent of the services provided to the new Medi-Cal beneficiaries, and the County is reimbursed for the services by DHCS. The funding change reflects Drug Medi-Cal services for the newly eligible Medi-Cal beneficiaries that were billed in FY 2014-15 and that is covered by appropriation by the federal government.

DPH would continue to subcontract with community-based non-profit organizations to deliver Substance Abuse Disorder Services through this amended contract. The following services would be delivered through this amended contract:

1. Outpatient drug-free treatment;
2. Narcotic replacement therapy;
3. Naltrexone treatment;
4. Intensive Outpatient Treatment; and
5. Perinatal Residential Substance Abuse Services.

The proposed resolution also allows DPH to approve future amendments to the subject contract for less than 10 percent of the contracted amount, or for approximately up to \$4,037,190, without further Board of Supervisors approval.

FISCAL IMPACT

DPH's total FY 2014-15 budget for Substance Abuse Disorder Services was \$69,420,583 as shown in Table 2 below, including the \$18,205,217 from DHCS under the subject contract. The additional \$7,121,875 in funding from DHCS offsets funds previously allocated to Substance Abuse Disorder Services in FY 2014-15, including (1) other Drug Medi-Cal Federal Share spending of \$3,854,761; and (2) City General Fund spending by \$3,267,114. Table 2 below shows total sources of funds for DPH FY 2014-15 Substance Abuse Disorder Services.

SUBJECT: Resolution retroactively authorizing the San Francisco Department of Public Health to Enter into an Amended Contract with the California Department of Health Care Services for Substance Use Disorder Services.

Purpose of this memorandum:

This memorandum provides an explanation of the Amendment to the Substance use Disorder Services (SUDS) Multi-year Contract between San Francisco and the California Department of Health Care Services (DHCS), a contract that is handled by the San Francisco Department of Public Health, Behavioral Health Services. The original contract was previously approved by the Board of Supervisors in February 2015 (File No. 141180).

Changes from previous (original) version of this contract:

The Department of Healthcare Services (DHCS) has issued an amendment to this contract consisting solely of an increase of \$7,121,875 Drug Medi-Cal Federal Share to FY 2014-15. This amendment increases the entire contract from \$33,250,026 to \$40,371,901. The DHCS has known since July, 2014, that an increase of this magnitude would be required, but waited until the end of the year to make the change, presumably to avoid having to make multiple changes as a better estimate of the final liability became available.

There were no other changes to the contract other than the \$7,121,875 increase in Drug Medi-Cal Federal Portion.

Mandatory nature, and type of contract:

- This is a mandatory contract between the State and each of the counties. It includes Federal pass-through dollars (Substance Abuse Prevention and Treatment grant, or SAPT grant). It is also the payment mechanism for Drug Medi-Cal Services.
- This is not a budget document, and does not interfere with the usual budget process. The contract has a variety of items, including budgeted, allocated and fee for service items.

Retroactivity:

Retroactivity of this contract only refers to the fact that the State is encumbering additional Federal Medicaid Funds to this contract after the original start date of the contract. This is done to assure the adequacy of the contract to reimburse all the services billed by The City and County. This contract covers services the County has been providing since July of 2014.

Exhibit A A1
Scope of Work

1. Service Overview

Contractor agrees to provide to the California Department of Health Care Services (DHCS) the services described herein.

State and the Contractor enter into this contract by authority of Chapter 3 of Part 1, Division 10.5 of the Health and Safety Code (HSC) and with approval of Contractor's County Board of Supervisors (or designee) for the purpose of providing alcohol and drug services. State and the Contractor identified in the Standard Agreement are the only parties to this Contract. This Contract is not intended, nor shall it be construed, to confer rights on any third party.

State and the Contractor enter into this contract for the purpose of identifying and providing for covered Drug Medi-Cal (DMC) services for substance use treatment in the Contractor's service area pursuant to Sections 11848.5(a) and (b) of the Health and Safety Code (hereinafter referred to as HSC), Sections 14124.20, 14021.51 – 14021.53, and 14124.20 – 14124.25 of the Welfare and Institutions Code (hereinafter referred to as W&I), and Title 22 of the California Code of Regulations (hereinafter referred to as Title 22), Sections 51341.1, 51490.1, and 51516.1.

State and the Contractor enter into this contract by authority of Title 45 of the Code of Federal Regulations Part 96 (45 CFR Part 96), Substance Abuse Prevention and Treatment Block Grants (SAPT Block Grant) for the purpose of planning, carrying out, and evaluating activities to prevent and treat substance abuse. Block Grant recipients must adhere to SAMHSA's National Outcome Measures (NOMs).

The objective is to make substance use treatment services available to Medi-Cal beneficiaries through utilization of federal and state funds available pursuant to Title XIX and Title XXI of the Social Security Act for reimbursable covered services rendered by certified DMC providers.

2. Service Location

The services shall be performed at applicable facilities in the County of San Francisco.

3. Service Hours

The services shall be provided during the working hours and days as defined by the Contractor.
