

1 (Lease of Real Property)

2 AUTHORIZING THE LEASE OF REAL PROPERTY AT 2450 SAN BRUNO AVENUE FOR  
3 THE SAN FRANCISCO PORTOLA BRANCH PUBLIC LIBRARY.

4       RESOLVED, In accordance with the recommendation of the City Librarian and the  
5 Director of Property, the Mayor and Clerk of the Board of Supervisors, on behalf of the City and  
6 County of San Francisco, as Tenant, be and they are hereby authorized and directed to execute  
7 the lease with Chun Pang Kir and Mei On Kir, as Landlord, for 2450 San Bruno Avenue, San  
8 Francisco, California.

10       The term of the lease shall be for five years commencing on July 1, 2000 upon approval  
11 by the Mayor and Board of Supervisors with one five-year option to extend the term which, if  
12 exercised, would adjust the rent to 95% of the prevailing market rent. If funds are not  
13 appropriated in any subsequent fiscal year, City may terminate the lease upon reasonable notice  
14 to Landlord.

16       The base monthly rental rate is \$6,533 with annual CPI adjustments or 4% whichever is  
17 greater. City will be responsible for separately metered electrical and janitorial service.

18 Landlord shall pay for water.

19       City shall hold Landlord harmless from any claims or liability for any injury or damage  
20 to any person or property occurring in or about the leased premises resulting from the negligence  
21 of City, its agents or employees.

23       Said lease shall be subject to certification by the Controller pursuant to Section 3.105 of  
24 the Charter.

25       The City Attorney shall approve the form of the Lease.
