

1 [John Muir Drive Emergency Authorization]
2 DECLARING A PUBLIC EMERGENCY AT JOHN MUIR DRIVE AS A RESULT OF THE
3 UNSTABLE CONDITIONS CAUSED BY HEAVY RAINS AND DIRECTING AND
4 AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF PUBLIC WORKS TO TAKE
5 NECESSARY MEASURES IN THE MOST EXPEDITIOUS MANNER TO PREVENT OR
6 MITIGATE LOSS OF OR DAMAGE TO THE SEWER TRANSPORT SYSTEM AT JOHN MUIR
7 DRIVE BETWEEN SKYLINE BOULEVARD AND LAKE MERCED BOULEVARD.

9 WHEREAS, the Board of Supervisors concurs with the Director of
10 Public Works ("Director") determination that an actual emergency
11 exists within the meaning of Administrative Code Section 6.60(C) due
12 to a dangerous condition caused by the heavy rains which have eroded
13 and undermined the ground along and adjacent to John Muir Drive
14 between Skyline Boulevard and Lake Merced Boulevard; and

15 WHEREAS, said dangerous condition involves a clear and imminent
16 danger, demanding immediate action to prevent or mitigate loss of or
17 damage to the City and County of San Francisco's sewer transport
18 system at John Muir Drive between Skyline Boulevard and Lake Merced
19 Boulevard; and

20 WHEREAS, The Director has determined that the cost of emergency
21 work to support and protect the sewer transport system at John Muir
22 Drive is \$350,000; now therefore be it

23 RESOLVED, that the Board of Supervisors hereby declares an
24 actual emergency exists within the meaning of Administrative Code

3 FURTHER RESOLVED, that the Board of Supervisors directs the

5 expeditious manner to prevent or mitigate loss of or damage to the
6 City and County of San Francisco's sewer transport system at John
7 Muir Drive between Skyline Boulevard and Lake Merced Boulevard, and
8 be it

9 FURTHER RESOLVED, that, pursuant to Administrative Code Section
10 6.60(D), the Board of Supervisors approves and authorizes the
11 Director to undertake the necessary work through the expenditure of
12 up to \$350,000 from the Department of Public Works Funds, and to seek
13 reimbursement from any parties responsible and liable for the
14 necessary corrective work, if such responsible parties can be
15 identified.






