Resolution authorizing the Department of the Environment to accept and expend a grant in the amount of \$430,500 from the Bay Area Air Quality Management District to retro-fit diesel engines in forty-one (41) Heavy Duty Vehicles (HDV) with diesel emission control equipment.

WHEREAS, the Bay Area Air Quality Management District has awarded funds to the Department of the Environment to assist Golden Gate Disposal and Recycling Company and Sunset Scavenger Company to retrofit forty-one (41) Heavy Duty Vehicles (HDV) with diesel emission control equipment to reduce oxide of nitrogen emissions (NOx) associated with operation of the vehicles; and,

WHEREAS, NOx emissions are a major component of ozone, a colorless, odorless gas that is injurious to human health when breathed; and,

WHEREAS, through the Transportation Fund for Clean Air, the Air District has made incentive funds available to encourage HDV fleets to install control technology to reduce emissions of NOx: and

WHEREAS, these incentive funds are available to encourage both public and private fleets to reduce NOx emissions; and,

WHEREAS the Department of the Environment was allowed to apply for funds on behalf of a private fleet that performs curbside solid waste collection under contract within its jurisdiction; and,

WHEREAS, Golden Gate Disposal and Recycling Company and Sunset Scavenger Company performs curbside solid waste collection under contract within the City and County of San Francisco; and,

**Supervisor Some Maxwell * BOARD OF SUPERVISORS WHEREAS, the Department of the Environment shall require that Golden Gate Disposal and Recycling Company and Sunset Scavenger Company operate the vehicles covered under this grant within the boundaries of the Air District for a minimum of five (5) years; and,

WHEREAS, The grant budget does not allow for indirect costs; now, therefore, be it RESOLVED, that the Board of Supervisors hereby authorizes the Director of the Department of the Environment to accept and expend \$430,500 from the Bay Area Air Quality Management District to assist Golden Gate Disposal and Recycling Company and Sunset Scavenger Company to retrofit forty-one (41) Heavy Duty Vehicles with diesel emission control equipment to reduce the emissions of NOx associated with the operation of the vehicles.
