12 hereby amends Rules 3.7 and 3.8, to read as follows:

13 **3.7 New Business.** This item includes legislation reported to the full Board by Board  
14 committees prior to 9:00 a.m. on the Thursday preceding the Tuesday Board meeting. ~~An~~  
15 ~~exception to Rule 3.7 is that legislation reported to the full Board by the Rules Committee at a~~  
16 ~~Wednesday committee meeting must be submitted to the Clerk of the Board by 12:00 noon that day to~~  
17 ~~be considered by the Board at the immediately following Tuesday (or Wednesday, if that Tuesday is a~~  
18 ~~holiday) Board meeting.~~

19 **3.8 Committee Reports on Urgent Legislation.** As an exception to the New  
20 Business rule, legislation deemed by a committee to be of an urgent nature, which is heard  
21 after the 9:00 a.m. Thursday deadline ~~(or after the Wednesday 12:00 noon deadline for the Rules~~  
22 ~~Committee, as provided in Rule 3.7);~~ may be considered by the Board as a committee report if  
23 the chair has anticipated such finding and requested the Clerk of the Board to include the item  
24 on the printed agenda under Committee Reports at the end of New Business.
