3	Resolution declaring March 27, 2025, as Heritage on the Marina Day in the City and
4	County of San Francisco in recognition of its historical significance and continuous
5	dedication to serving the community with integrity and care.

7	WHEREAS, Heritage on the Marina has long served as a beacon of community
8	commitment within San Francisco, originally founded by the San Francisco Ladies' Protection
9	and Relief Society to aid women and children, and evolving into a care home for San
10	Francisco's elderly; and
11	WHEREAS, The San Francisco Ladies' Protection and Relief Society was established
12	in 1853 by a group of women who recognized the urgent need to provide shelter and support
13	to vulnerable women and children, laying the foundation for what would become one of the
14	city's most enduring charitable organizations; and
15	WHEREAS, In 1922, the Society commissioned Julia Morgan, California's first licensed
16	female architect, whose groundbreaking work helped shape the state's architectural legacy, to
17	design the current facility;
18	WHEREAS, The construction of the facility was made possible through the generosity
19	of sisters Edith and Lucy Allyne, descendants of early San Francisco pioneers, whose
20	contributions ensured the expansion and long-term sustainability of the institution; and
21	WHEREAS, Since its opening in 1925, Heritage on the Marina has continued to uphold
22	its mission of service, offering care and community to elderly residents while preserving the
23	rich legacy of the women who built and sustained it; and

1	WHEREAS, March 2025 marks the 100th anniversary of Heritage on the Marina,
2	celebrating a century of impactful service to the community and honoring its role as a
3	longstanding pillar of support and care for its residents; and
4	WHEREAS, The institution has consistently demonstrated leadership in preserving
5	architectural integrity while fostering an inclusive environment that respects and honors its
6	residents' contributions to the community; and
7	WHEREAS, In celebration of Women's History Month, the commendation recognizes
8	the generations of women who have played a critical role in the history and development of
9	Heritage on the Marina, from its founders and benefactors to the caregivers and residents
10	who have shaped its legacy; now, therefore, be it
11	RESOLVED, That the City and County of San Francisco hereby commend Heritage on
12	the Marina for its outstanding service to the community, preserving both the social and
13	architectural history of the Marina District; and, be it
14	FURTHER RESOLVED, That the Board of Supervisors declares March 27, 2025 as
15	Heritage on the Marina Day in the City and County of San Francisco, in recognition of its
16	historical significance and continuous dedication to serving the community with integrity and
17	care.
