[Selling Naming Rights of Transit Stations]

Resolution urging the Board of Directors of BART and the Municipal Transportation Authority to prohibit the selling of the naming rights of any public transit stations, especially the Embarcadero, Montgomery, Powell and Civic Center stations, to any private entity, corporation or individual.

WHEREAS, There have been efforts on the part of some local municipalities to sell the naming of transit stations to private businesses and corporations; and

WHEREAS, The ubiquitous, prolific and intrusive presence of commercial advertisement has already inundated all forms of media including television, radio, the internet, all forms of printed media, billboards, as well as the interior and exterior of buses, taxis and even private cars; and,

WHEREAS; This further intensification and commercializing of public space represents a disturbing and noxious trend which most citizens find annoying, invasive and repugnant; and,

WHEREAS, The prolific amount of advertisement found within transit stations, within the interiors of BART trains and MUNI buses, on the exterior of MUNI buses as well as billboards installed at bus stops already generates a steady and significant income source for both BART and MUNI; and

WHEREAS, It is in the interest of the citizens of San Francisco that naming of public space be reserved for individuals and organization that made valuable contributions to society; now, be it




