3 **Ordinance approving Health Service System plans and contribution rates for calendar**  
4 **year 2017, and amending the Administrative Code to remove those rates from the**  
5 **Code.**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. Background and Findings.

15 (a) Under Charter Section A8.423, the Health Service Board (HSB) is required to  
16 conduct a survey of the ten counties in the State of California, other than the City and County  
17 of San Francisco, having the largest populations to determine the “average contribution” made  
18 by each such county toward the providing of health care plans, exclusive of dental or optical  
19 care, for each employee of such county. The HSB is then required to certify to the Board of  
20 Supervisors “the average contribution” as determined by the survey.

21 (b) According to the California Department of Finance, the ten most populous counties  
22 in the State of California other than San Francisco (in descending order of population) are:  
23 Los Angeles, San Diego, Orange, Riverside, San Bernardino, Santa Clara, Alameda,  
24 Sacramento, Contra Costa, and Fresno (collectively, the “Survey Counties”).

25 (c) On March 10, 2016, based on the Health Service System’s survey of each of the  
Survey Counties, a copy of which is on file with the Clerk of the Board of Supervisors in Board

1 File No. 160747, the HSB determined that “the average contribution” made by the counties  
2 surveyed for the 2017 calendar plan year is \$604.84.

3 (d) At its meetings of May 12, June 9 and June 21, 2016, the HSB adopted health  
4 insurance plans and contribution rates for Health Service System plans to become effective  
5 on January 1, 2017, for the calendar plan year January 1, 2017 through December 31, 2017.  
6 Said plans and contribution rates are on file with Clerk of the Board of Supervisors in Board  
7 File No. 160747, and are incorporated herein by reference.

8 Section 2. The Board of Supervisors hereby approves the health insurance plans and  
9 contribution rates adopted by the HSB on May 12, June 9 and June 21, 2016, as referenced  
10 in subsection (d) of Section 1 of this ordinance. The Health Insurance Plans are expected to  
11 exceed 10 million dollars in expenditures, and Charter Section 9.118(b) requires Board of  
12 Supervisors Approval, which is hereby granted.

13 Section 3. As referenced in subsection (c) of Section 1 of this ordinance, “the average  
14 contribution” under Charter Section A8.423, which shall constitute the monthly amount  
15 contributed by participating employers to the Health Service Trust Fund for the calendar plan  
16 year January 1, 2017 through December 31, 2017, as required under Charter Section  
17 A8.428(b)(2), is \$604.84.

18 Section 4. The Administrative Code is hereby amended by deleting Section 16.703 in  
19 its entirety, as follows:

20 **~~SEC. 16.703. HEALTH SERVICE SYSTEM; PLAN AND CONTRIBUTION RATES.~~**

21 ~~*Changes in contribution rates adopted by the Health Service Board for the plans of the Health*~~  
22 ~~*Service System, to become effective on January 1, 2016 for the calendar plan year January 1, 2016*~~  
23 ~~*through December 31, 2016, approved by the Health Service Board in actions taken by it on June 11,*~~  
24 ~~*2015, which plans and contribution rates are on file with the Clerk of the Board of Supervisors, are*~~  
25 ~~*hereby approved.*~~

1 Section 5. Effective Date. This ordinance shall become effective 30 days after  
2 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
3 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
4 of Supervisors overrides the Mayor's veto of the ordinance


