

1 [Accept-Expend Federal Grant]

3 **Resolution authorizing the Executive Director of the Department of Parking and Traffic**
4 **and the Director of the Department of Public Works to accept and expend up to**
5 **\$555,000 in federal and state grant funds to implement the West Approach Overhead**
6 **Signage Project in the City and County of San Francisco.**

8 WHEREAS, The concrete section of the Western Approach of Interstate 80 to the Bay
9 Bridge, from the West Anchorage to Fifth Street in San Francisco, was weakened during the
10 1989 Loma Prieta earthquake; and,

11 WHEREAS, The State has begun to implement its plan to retrofit and rebuild that
12 portion of freeway; and,

13 WHEREAS, The Departments of Parking and Traffic and Public Works staff have
14 worked closely with the California Department of Transportation (Caltrans), the Municipal
15 Railway (MUNI), local businesses and residents on a daily basis to coordinate all plans and
16 designs for all temporary detours on City streets as part of the demolition and reconstruction
17 of that portion of the Freeway; and,

18 WHEREAS, Caltrans has requested that aforementioned Departments work together to
19 obtain all necessary clearances for and to design, prepare Plans, Specifications and Estimate
20 (PS&E), advertise, open bids, award, administer and complete a construction contract to
21 furnish and install nine (9) overhead sign structures and fifty-five (55) sign panels for traffic
22 control of its West Approach Seismic Retrofit Project; and,


23 WHEREAS, Indirect costs are ineligible according to federal and state rules and
24 regulations; now, therefore, be it

1 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco
2 authorizes the Executive Director of the Department of Parking and Traffic and the Director of
3 the Department of Public Works to accept and expend up to \$555,000 in federal and state
4 grant funds to implement the West Approach Overhead Signage Project within the City and
5 County of San Francisco; and, be it

6 **FURTHER RESOLVED**, That the Executive Director of the Department of Parking and
7 Traffic and the Director of the Department of Public Works are hereby authorized and
8 empowered to execute, deliver, and perform, in the name of the City and County of San
9 Francisco, all applications, contracts, agreements, amendments, and payment requests
10 necessary to carry out the West Approach Overhead Signage Project.
